WHEAT MARKETING ACT 1971, No. 8213. DATE OF COMING INTO OPERATION.

PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia,

Whereas, by an Act of Parliament of the State of Victoria passed in the twentieth year of the reign of Her Majesty Queen Elizabeth II entitled the Wheat Marketing Act 1971, No. 8213, it is amongst other things enacted that the several provisions of the said Act shall come into operation on a day or the respective days to be fixed by Proclamation or successive Proclamations of the Governor in Council published in the Government Gazette:

Now therefore I, the Governor of the State of Victoria, in Now therefore I, the Governor of the State of Victoria, in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State do by this my Proclamation FIX Friday the twenty-eighth day of April, One thousand nine hundred and seventy-two as the day on which the several provisions of the Wheat Marketing Act 1971, No. 8213, shall come into operation, except that provision contained in paragraph (c) of sub-section (1) of section 17 of the said Act which inserts paragraph (h) in sub-section (1) of section 41 of the Wheat Marketing Act 1969.
