PORT RULE NO. 132.

PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

Whereas by Part II. of the *Marine Act 1958* it is amongst other things enacted that the Governor in Council by Proclamation published in the *Government Gazette*, may from time to time define the limits and boundaries of ports in Victoria and frame rules and regulations for the governance and preservation of the said ports respectively and for the regulation of shipping in the same (including the imposition of charges for the use of mooring sites and other facilities):

And that any such regulation may from time to time be in like manner altered, amended or repealed and other substituted in their stead:

Now therefore, I, the Governor of the State of Victoria in the Commonwealth of Australia by and with the advice of the Executive Council thereof and in the exercise of the powers conferred by the said Act, by this Proclamation do hereby amend the Proclamation dated the 13th day of February, 1973, as follows:—

Delete the proviso added at the end of Paragraph (A) of the schedule to Clause 2 by amendment dated 29th May, 1973, and substitute therefor the following:—

“Provided that during the period between the 8th November, 1973 and 31st May, 1974, both dates inclusive, the charges set forth in Paragraph (A) of this schedule shall be reduced by 30 per cent., unless the Governor in Council by proclamation determines otherwise.”

Delete the proviso added at the end of Paragraph (C) of the schedule to Clause 2 by amendment dated 29th May, 1973, and substitute therefor the following:—

“Provided that during the period between the 8th November, 1973, and the 31st May, 1974, both dates inclusive, the charges set forth in Paragraph (C) of this schedule shall be reduced by 50 per cent., unless the Governor in Council by proclamation determines otherwise.”

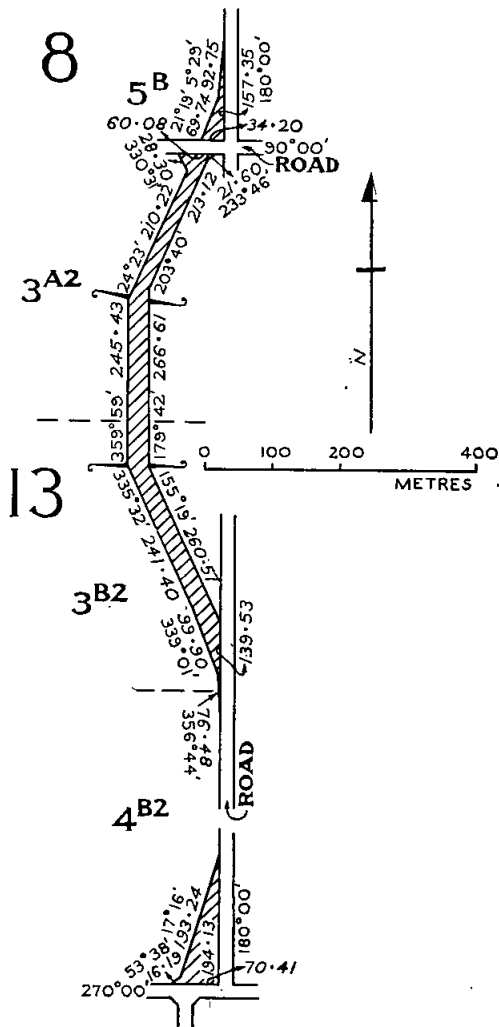

Melbourne Cricket Ground Act 1933 (No. 4149).  
MELBOURNE CRICKET GROUND.

AMENDMENT OF REGULATION.

Whereas by Section 9 of the Melbourne Cricket Ground Act 1933 (No. 4149), the trustees appointed thereunder have power from time to time, with the approval of the Governor in Council, to make Regulations as therein provided, and with like approval to repeal or amend such Regulations: And whereas the said Act provides that the Regulations relating to the Metropolitan Cricket Ground in force immediately before the commencement of the said Act shall be deemed to have been made pursuant to the said Act and shall remain in force until repealed under the said Act: And whereas Regulations relating to the Melbourne Cricket Ground (hereinafter called the Ground) have been made from time to time both before and after the commencement of the said Act: And whereas it is in the opinion of a statutory majority of the said trustees necessary and expedient to amend one of such Regulations: Now therefore, we the undersigned, a statutory majority of the said trustees for the time being of the land described in the Fifth Schedule to the said Act, as enlarged pursuant to the provisions of the Melbourne Cricket Ground Acts (Nos. 5614 and 6854), together with all improvements thereon, do by virtue of all the powers thereunto us enabling hereby amend Regulation No. 20 (as notified in the Government Gazette of 11th July, 1973) by substituting therefor the following:—

REGULATION 20.

1. The maximum scale of fees which shall be charged and collected by the trustees for admission to the Second and Fourth Divisions of the Ground on such days as it may be set apart for cricket matches or football matches, shall (in addition to any tax payable under any law other than the said Act on or in respect of such fees or admissions) be as follows:—

- (a) For admission of every person on any such day such a sum as the trustees may from time to time determine not exceeding Three dollars (\$3.00).
- (b) For a reserved seat or reserved accommodation and the booking thereof on any such day such additional sum as the trustees may from time to time determine not exceeding Fifty cents (\$0.50).

2. The fees which shall be charged and collected by the trustees for admission to the Ground on such occasions as it may be set apart for outdoor games, sports, amusements or functions other than cricket matches or football matches shall (in addition to any tax payable under any law other than the said Act on or in respect of such fees or admissions) be such sums as the trustees may from time to time determine.

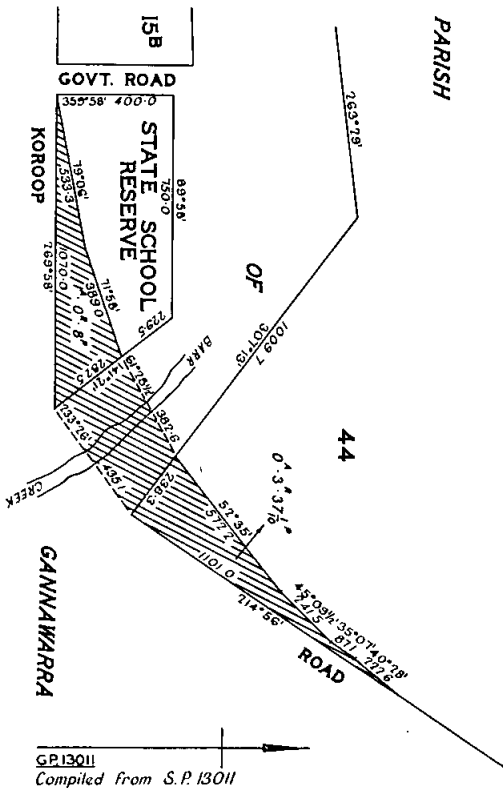

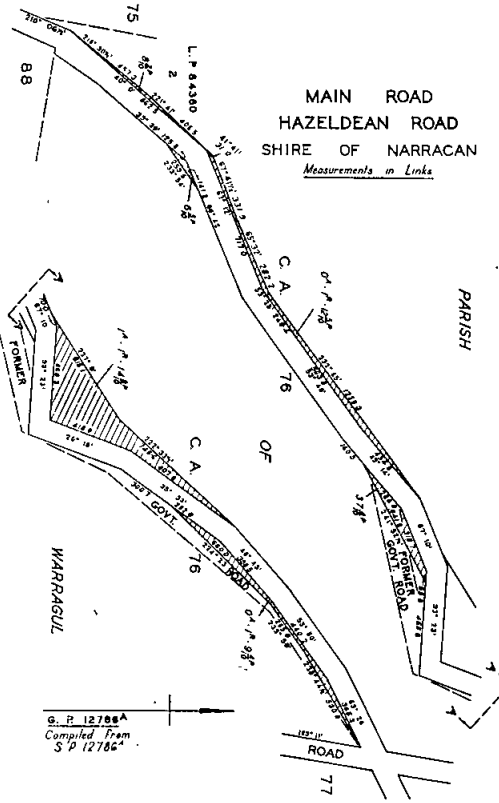

SHIRE OF KERANG

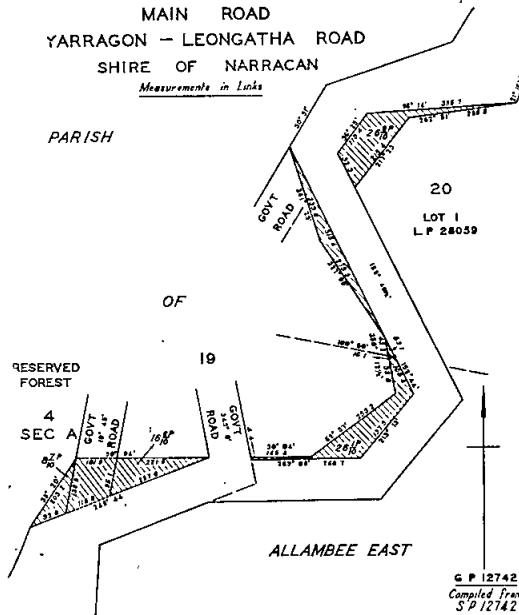

- (b) state the place of which such vehicle or vehicles is or are to be used;
- (c) The times during which such vehicle or vehicles will be used;
- (d) the names, addresses and age or ages of any person or persons who will be using such vehicle or vehicles at such time;
- (e) describe such vehicle or vehicles stating its make engine size and whether or not it is registered;
- (f) whether or not the consent of the owner of the land has been obtained;
- (g) supply such other information that the Council may require.

4. The Council in giving its consent under Clause 2 hereof can impose any condition which it considers appropriate to the use of such vehicles.

5. This Bylaw shall apply to and have operation throughout the whole of the Municipal district.

6. Any person guilty of a wilful act or default contrary to the provisions of this Bylaw shall be liable to a penalty of not less than \$10.00 nor more than \$100.00 and any person guilty of a continuing offence shall be liable to a penalty of not more than \$10.00 for each day on which an offence against this Bylaw is continued after a conviction or order by any Court.

(b) In addition to complying with the requirements of paragraph (a) of this clause the owners or occupiers of buildings in which there are two or more separate dwellings shall on the front door of each such separate dwelling or in such other conspicuous place as the Authorised Officer determines mark such separate dwelling with such numbers for the purpose of distinguishing the same as the Authorised Officer may from time to time direct or approve.

(c) Such owners or occupiers shall renew the numbers of such houses buildings or separate dwellings as often as they are obliterated or defaced.

(d) If any owner or occupier of any such house building or separate dwelling neglects for one week after notice to him from the Authorised Officer to mark such house building or separate dwelling with such number as the Authorised Officer may direct or approve or to renew the number thereof as aforesaid he shall forfeit a sum not exceeding \$4.00 and the Council may cause such number to be so marked or renewed and recover the expense thereof from the owner or occupier of such house building or separate dwelling before any Justice and where such expense is paid by or recovered from the occupier he may deduct the same from any rent payable by him to the owner.

- (i) amending By-Law No. 15;

- (ii) prescribing fees on licences under By-Law No. 15; and
- (iii) prescribing minimum insurance to be taken out by licences under By-Law No. 15.

1. Clauses (4) and (11) of By-law No. 15 shall be and the same are hereby repealed.

2. By-law No. 15 shall be amended as follows:—

I. After Clause (3) the following Clause shall be inserted—

“(4) (a) Every licence shall expire on the 30th day of September next following the date of issue of such licence, and shall thereafter be of no force or effect.

(b) There shall be paid to the Council in respect of every licence for a petrol pump whether portable or otherwise in or on any footway a fee of \$21.00.

(c) Provided that where a licence is granted for a period less than 12 months a proportionate reduction of the fee based on the number of months unexpired shall be made by the Council.”

II. After Clause (10) of By-law No. 15 the following Clause shall be inserted—

“(11) Every licensee under the provisions of this By-law shall, before the petrol pump in respect of which a licence was granted is erected, or if such petrol pump is erected prior to the application for a licence in respect thereof then before such petrol pump is used for the sale or supply of motor spirit, insure himself and thereafter keep himself insured at all times during the currency of such licence and any renewal thereof in an insurance company of good repute against liabilities which may be incurred by him in respect of such petrol pump and its use, control or possession by him for a minimum sum of \$200,000.00. Every licensee shall on demand produce to the Council or any duly authorised officer of the Council the said policy of insurance and the receipt for the premium for the then unexpired period of his licence PROVIDED that any licensee operating a petrol pump under a currently valid licence, and holding an insurance policy for less than the sum of \$200,000.00 may continue so to operate until the expiration of such permit, and shall show to Council's satisfaction that he has insured himself as aforesaid for the minimum sum of \$200,000.00 before any renewal of his permit is granted.

III. To the form in the Third Schedule by By-Law No. 15 there shall be added after the words “hereby apply for renewal of such licence for the year ending 30th September, 19 ” the following words:—

“and I/WE produce herewith a copy of my/our insurance policy with respect to such Petrol Pump for the sum of at least \$200,000.00 and the receipt for the premium for the period in respect of which this application is made”.

IV. This By-Law shall apply to and have operation throughout the whole of the municipal district.

3. This By-Law shall apply to and have operation throughout the whole of the municipal district of the Shire of Mansfield.

4. The minimum area, depth and width of frontage etc., as specified in Column 4 of Table 804 of the Uniform Building Regulations, Victoria, 1969 (hereafter called the Regulations) are hereby adopted as the minimum area, width and depth of frontage etc., of land on which a building of Classes I and II occupancy shall be constructed throughout that portion (or those portions) of the municipal district of the Shire of Mansfield as defined in Clause 3 of this By-Law.

5. The maximum number of storeys, including the ground storey of a building of Classes II and III occupancy shall be three storeys except where the ground storey is devoted exclusively to the parking of wheeled vehicles, the building may contain four storeys.

6. In the case of a building on any land forming part of a subdivision approved by the Council and lodged with the Office of Titles prior to the date of commencement of the Regulations, the requirements of Clause 813 of the Regulations may be dispensed with, by resolution of the Council.

7. Any person or persons or members of bodies corporate or incorporate failing to comply with the provisions of the By-Law shall be deemed to have committed an offence against the By-Law and be subject to the following penalties:—

- (i) For a wilful act or default contrary to this By-Law be subject to a minimum penalty of \$10.00 and a maximum penalty of \$100.00.
- (ii) For a second offence a minimum penalty of \$40.00 and a maximum penalty of \$100.00.
- (iii) For any subsequent offence a minimum penalty of \$60.00 and a maximum penalty of \$100.00.
- (iv) In the case of a continuing offence be subject to a penalty of \$10.00 for each day on which any offence against the By-Law is continued after a conviction or order by any Court, provided that the maximum penalty for a continuing offence shall not exceed \$500.00.
- (v) In addition to penalties herein before prescribed any expense incurred by the Council in consequence of a breach of the By-Law or in the execution of work directed by the By-Law to be executed by any person and not executed by him shall be paid by the person committing such breach or failing to execute such work.
