MELBOURNE METROPOLITAN PLANNING SCHEME.

AMENDMENT NO. 19c.

Notice of Amendment.

In pursuance of the powers conferred by sub-section 6 of section 32 of the Town and Country Planning Act 1961, the Governor in Council, by and with the advice of the Executive Council on the 18th April, 1973, amended the Melbourne Metropolitan Planning Scheme to make "apartment house", "flat" and "residential building" Column 4 uses in the Residential "A" and "B" Zones throughout the metropolitan area.

TEACHING SERVICE ACT 1958.

At the Executive Council Chamber, Melbourne, the nineteenth day of April, 1973.

PRESENT:

His Excellency the Governor of Victoria.

Mr. Meagher | Mr. Hunt.

In exercise of the powers conferred by section 5c of the Teaching Service Act 1958 as substituted by the Teaching Service Act 1973, I, the Governor of the State of Victoria, with the advice of the Executive Council of the said State, do by this Order determine that of the two members of the Teachers Tribunal representing the Government of Victoria, namely Douglas Campbell Duncan and Jack Gillies Baker:

- (1) when the Tribunal is determining or otherwise dealing with—
 - (a) any matter in relation to which the Tribunal is required by sub-section (1) of section 5A of the Teaching Service Act 1958 to include the member representing the primary school teachers; or
 - (b) any matter in relation to which by sub-section (2) of the said section 5A the Tribunal is required to include the member elected to represent the teaching service generally

the said Douglas Campbell Duncan shall be the member to sit on the Tribunal; and

- (2) when the Tribunal is determining or otherwise dealing with—
 - (a) any matter in relation to which the Tribunal is required by sub-section (1) of section 5A of the Teaching Service Act 1958 to include the member representing the secondary school teachers; or
 - (b) any matter in relation to which the Tribunal is required by sub-section (1) of the said section 5A to include the member representing the technical school teachers

the said Jack Gillies Baker shall be the member to sit on the Tribunal.

And the Honorable Lindsay Hamilton Simpson Thompson, Her Majesty's Minister of Education for the State of Victoria, shall give the necessary directions herein accordingly.
