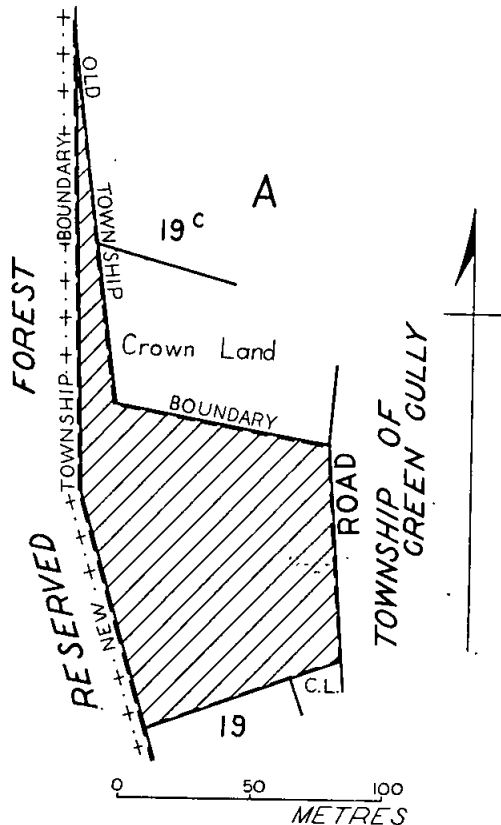

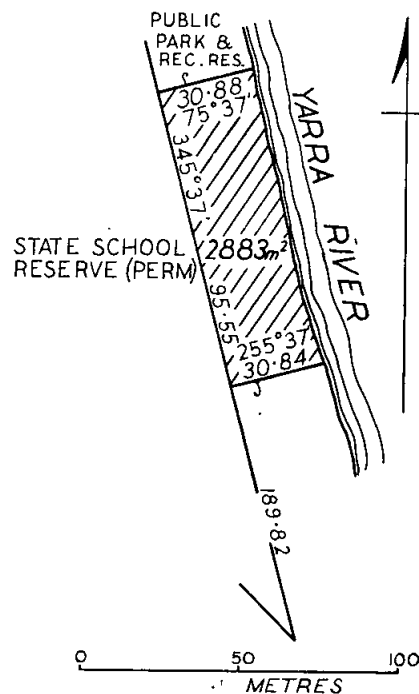

In pursuance of Section 5 (2) of the Richmond and Hawthorn Lands Act 1970, I, the Governor of the State of Victoria in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State

do by this Proclamation revoke and make null and void so far as it relates to the land indicated by hatching on plan hereunder; the Order in Council of the 13th day of October, 1873, permanently reserving 63.23 hectares (156 acres 1 rood), more or less, of land in the Parish of Jika Jika (Town of Richmond in Order) as a site for Public Park and Recreation. (Designated Richmond Park).—(Rs.9052).

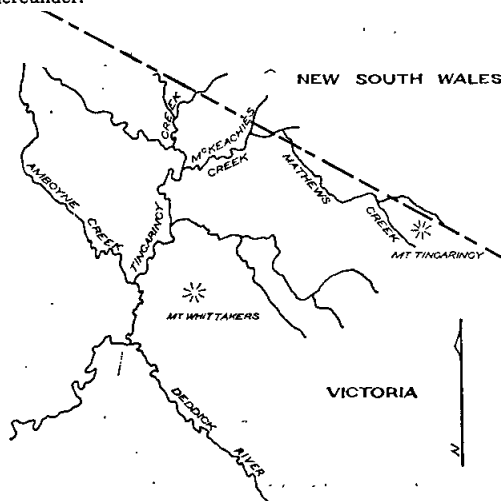

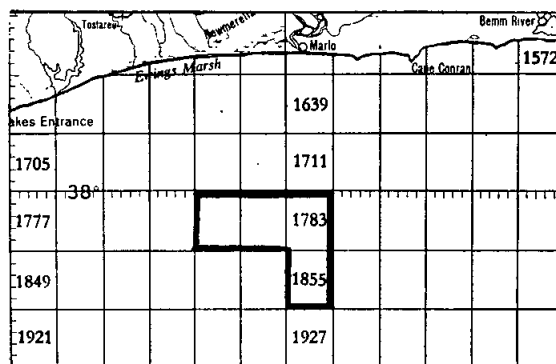

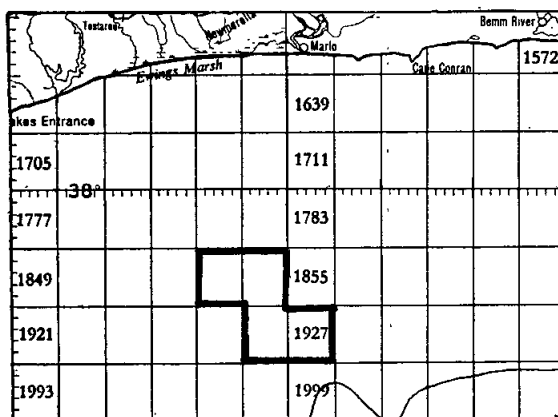

STATE RIVERS AND WATER SUPPLY COMMISSION.
BY-LAW NO. 5719 AMENDING BY-LAW NO. 5694 AND FIXING CHARGES FOR WATER SUPPLIED BY MEASURE IN OTWAY URBAN DISTRICT.

The State Rivers and Water Supply Commission in pursuance and exercise of the powers conferred by the Water Act, does hereby make the By-law following:—

1. From the Schedule contained in By-law No. 5694 delete the section headed "Supplied from Otway System".

2. This By-law shall apply within the Otway Urban District and shall take effect as hereinafter provided notwithstanding the provisions of any previous By-law.

3. The meter or meters measuring the supply of water to any property within the said urban district shall be read once in every financial year as near as practicable to the same date and the quantity so measured as having been supplied during the period (hereinafter called the "meter year") between any two successive such readings shall be the basis of charges payable under this By-law.

4. In respect of any property rated or supplied with water by the Commission—

(a) the maximum quantity of water to be supplied in any meter year without additional charge, except where a special agreement with the Commission applies, shall be the quantity which if charged at—

(i) 5.5 cents per kilolitre for any meter year in course at the commencement of this By-law, and

(ii) 8.0 cents per kilolitre for any meter year beginning after the commencement of this By-law—

would give an amount equal to—

(i) the amount of the rate or minimum annual charge payable, if any, in the previous financial year if the meter year ends at anytime from 1st July to 30th September, both dates inclusive, or

(ii) the amount of the rate or minimum annual charge payable, if any, in the current financial year if the meter year ends at anytime from 1st October to 30th June both dates inclusive.

(b) for all water supplied in any meter year in excess of the maximum quantity referred to in paragraph (a) of this Clause the charge shall be—

(i) 5.5 cents per kilolitre for any meter year in course at the commencement of this By-law.

(ii) 8.0 cents per kilolitre for any meter year beginning after the commencement of this By-law.

5. The charges as set out in Clause 4 of this By-law shall be payable on demand at the Office of the State Rivers and Water Supply Commission at Camperdown.

6. Interest will be chargeable on all charges for water remaining unpaid for a period of three months from the date they become payable.

7. Such person or persons as the State Rivers and Water Supply Commission may from time to time appoint for that purpose shall be and is or are hereby authorized to demand receive collect and recover the said charges for water.

- (b) For all water supplied in any meter year in excess of the maximum quantity referred to in paragraph (a) of this clause, the charge is hereby fixed at thirty five cents (35c) per 1,000 gallons (7.7 cents per Kilolitre) for any meter year.

3. Subject as is hereinafter provided, the charge for water supplied by measure to any property not rated by the Trust is hereby fixed at thirty cents (30c) per 1,000 gallons, (6.6 cents per Kilolitre) up to maximum quantity allowed, and in excess of such maximum quantity, thirty five cents (35c) per 1,000 gallons (7.7 cents per kilolitre).

4. The minimum charge for water supplied by measure to any property not rated by the Trust is fixed by individual Agreements with the Trust.

5. The aforesaid charges shall be payable within seven days of demand upon the owner or occupier at the office of the Trust during normal business hours.

REGULATIONS FOR THE CARE, PROTECTION AND MANAGEMENT OF THE BRIAGOLONG ROAD AND QUARRY RESERVE.

I, William Archibald Borthwick, Her Majesty's Minister of Lands in and for the State of Victoria, in pursuance of the powers conferred on me by Section 218 of the Land Act 1958, do hereby make the following Regulations for or with respect to the land in the Parish of Briagolong temporarily reserved pursuant to Order in Council dated the 19th February, 1903, as a site for Road and Quarry purposes, hereinafter referred to as the "Reserve".

The Reserve has been placed under the control of the Corporation of the Shire of Maffra as a Committee of Management (hereinafter referred to as the "Committee") with power and authority to enforce the foregoing Regulations.

REGULATIONS.

1. No person shall remove from the Reserve any soil, sand, loam, gravel or other material except with the written permission of the Committee or Engineer to the Shire of Maffra or other persons authorized by the Committee, and then only subject to the observance of such terms and conditions and the payment of such fees as may be prescribed by the Committee from time to time.

2. No person shall enter or remain in the Reserve who may offend against decency as regards dress, language or conduct.

3. No person shall, without the consent in writing of the Committee:—

- (a) bring into the Reserve any intoxicating liquor;
- (b) discharge firearms within the Reserve;
- (c) camp within the Reserve;
- (d) light or maintain a fire within the Reserve except in such place or places as may be provided by the Committee;
- (e) deposit any rubbish, debris, litter or other unwanted material or thing, within the Reserve;
- (f) interfere with or remove or damage or destroy any fences, tracks, signs, earthen banks or any other improvements or structures in the Reserve;
- (g) cut, damage or remove any trees or plants growing in the Reserve;
- (h) allow any cattle, horses, sheep, goats, pigs or other animals to enter or remain in the Reserve.

4. No person shall drive, ride, place, leave or park any motor vehicle, motor cycle or bicycle in the Reserve except in an area set apart for the purpose by the Committee.

5. No person shall drive any motor vehicle or ride any motor cycle or bicycle in the Reserve at a speed in excess of 10 m.p.h. or in such a manner as to create undue dust or to cause damage to the roadways, parking area or property in the Reserve.

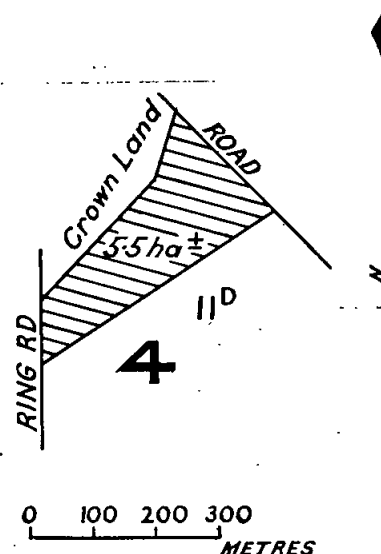
