Fertilizers Act 1974.

EXEMPTION OF CERTAIN PRODUCTS OR CLASSES THEREOF FROM THE PROVISIONS OF THE FERTILIZERS ACT 1974 IN RESPECT OF LABELLING DELIVERY DOCUMENTS OR REGISTRATION.

PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

Whereas by subsection (1) of Section 4 of the *Fertilizers Act 1974*, it is enacted that subject to the Act the Governor in Council by Proclamation published in the *Government Gazette*, may exempt any agricultural lime, fertilizer or soil conditioner or any class of such product from any of the provisions of that Act in respect of labelling, delivery documents or registration:

Now therefore I, the Governor of the State of Victoria, by and with the advice of the Executive Council of the said State do by this my Proclamation—

- (1) exempt from all of the provisions of Sections 8, 9, 10 and 11 of the said Act in respect of labelling, delivery documents or registration the following fertilizers or classes of fertilizers:—
 - Unprocessed sewage sludge
 - Unprocessed sea weed
 - Unprocessed manufacturer's waste
 - Seeds of a kind or mixture of kinds mixed with or attached to or enclosed in or coated with any fertilizer;
- (2) exempt from all of the provisions of Sections 8, 9, 10 and 11 of the said Act in respect of labelling, delivery documents or registration the following class of agricultural limes:—
 - Seeds of a kind or mixture of kinds mixed with or attached to or enclosed in or coated with any agricultural lime;
- (3) exempt from all of the provisions of Sections 8, 9, 10 and 11 of the said Act in respect of labelling, delivery documents or registration the following soil conditioners:—
 - Peat
 - Peat Moss

JUSTICES ACT 1958.

PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

Whereas by subsections (2A) and (2B) of section 115 of the *Justices Act 1958* it is provided, amongst other things, that—

- I. A Warrant of distress in a civil matter shall not be executed by a member of the police force in any municipal district or subdivision of a municipal district for the time being specified by proclamation for the purposes of the said section 115 where the warrant is issued after the proclamation is made.
- II. The Governor in Council may by proclamation published in the *Government Gazette* specify municipal districts for the purposes of the said section 115.

Now therefore I, the Governor of the State of Victoria, acting by and with the advice of the Executive Council thereof, do by this my Proclamation specify the municipal districts of the municipalities set out in the Schedule hereto for the purposes of the said section 115.

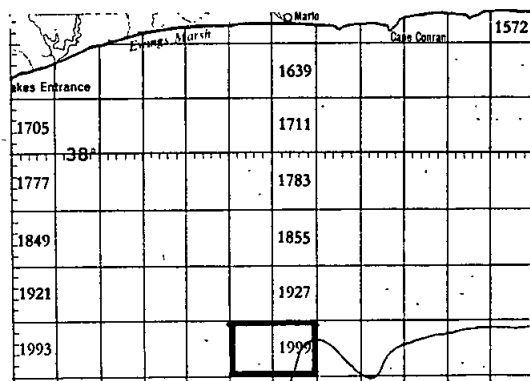

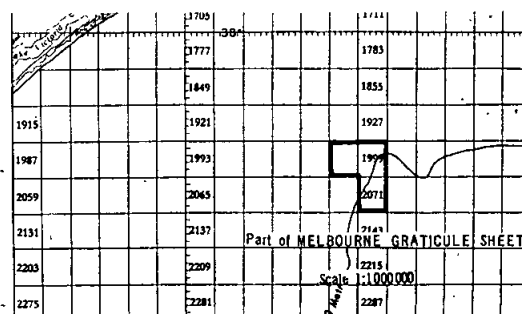

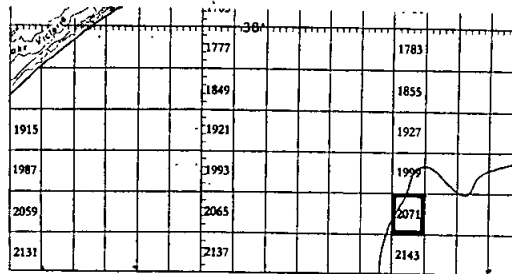
