ACTS OF PARLIAMENT.

PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

I, the Governor of the State of Victoria, in the Commonwealth of Australia, do hereby declare that I have this day assented, in Her Majesty's name, to the Bills passed by the Parliament of the said State, the titles whereof are hereunder set forth, together with the short titles, that is to say:—

- No. 8951. "An Act to consolidate and amend the Law relating to Officers of the Supreme Court and for other purposes." (*Supreme Court Act 1976*.)
- No. 8952. "An Act to constitute a Metropolitan Fire Brigades Superannuation Board, to make Provision for the Administration by the said Board of a Metropolitan Fire Brigades Superannuation Fund, to provide for the Transfer to the said Board of certain assets and the Responsibility for the Administration thereof, and for other purposes." (*Metropolitan Fire Brigades Superannuation Act 1976*.)
- No. 8953. "An Act to make Provision for and with respect to the Creation of a Department of Minerals and Energy, to amend the *Coal Mines Act 1958*, the *Gas and Fuel Corporation Act 1958*, the *Health Act 1958*, the *Mines Act 1958*, the *Mining Development Act 1958*, the *Petroleum Act 1958*, the *Extractive Industries Act 1966*, the *Pipelines Act 1967*, the *Petroleum (Submerged Lands) Act 1967*, the *Groundwater Act 1969* and the *Public Service Act 1974*, and for other purposes." (*Minerals and Energy Act 1976*.)
- No. 8954. "An Act to amend Parts IV. and V. of the *Legal Profession Practice Act 1958* and for other purposes." (*Legal Profession Practice (Guarantee Fund) Act 1976*.)
- No. 8955. "An Act to amend the *Magistrates (Summary Proceedings) Act 1975*." (*Magistrates (Summary Proceedings) (Amendment) Act 1976*.)
- No. 8956. "An Act to amend Sub-section (1) of Section 3 of the *Money Lenders Act 1958*." (*Money Lenders (Credit Societies) Act 1976*.)
- No. 8957. "An Act to amend the *Patriotic Funds Act 1958*, and for other purposes." (*Patriotic Funds (Amendment) Act 1976*.)

PROCLAMATION

I, the Governor of the State of Victoria, in the Commonwealth of Australia, do hereby declare that I have this day assented, in Her Majesty's name, to the Bills passed by the Parliament of the said State, the titles whereof are hereunder set forth, together with the short titles, that is to say:—

- No. 8958. "An Act to amend Division 1A of Part XLIX. of the *Local Government Act 1958*, and for other purposes." (*Local Government (House Builders' Liability) Act 1976*.)
- No. 8959. "An Act to amend the Provisions of the *Police Regulation Act 1958* with respect to Long Service Leave." (*Police Regulation (Long Service Leave) Act 1976*.)
- No. 8960. "An Act to amend the *Private Agents Act 1966*." (*Private Agents (Amendment) Act 1976*.)
- No. 8961. "An Act to make further Provision with respect to Drugs of Addiction and Specified Drugs, to amend the *Poisons Act 1962* and for other purposes." (*Poisons (Drugs of Addiction) Act 1976*.)

- No. 8962. "An Act to make Provision with respect to the Validation of Certain Persons to be Members of the Legislative Council and of the Legislative Assembly and to indemnify Them from any Penal Consequences which They may have incurred by Sitting and Voting as Members thereof." (*Constitution (Validation of Elections) Act 1976.*)
- No. 8963. "An Act to establish a Ministry of Immigration and Ethnic Affairs, to assist Migrants and Members of Ethnic Groups to settle in Victoria, and for other purposes." (*Ministry of Immigration and Ethnic Affairs Act 1976.*)
- No. 8964. "An Act to increase the Amount of certain Fees payable under the *Motor Car Act 1958.*" (*Motor Car (Fees) Act 1976.*)
- No. 8965. "An Act to amend the *Marketing of Primary Products Act 1958* with respect to the Constitution and Powers of Marketing Boards and for other purposes." (*Marketing of Primary Products (Marketing Boards) Act 1976.*)

NOTE.—Acts No. 8959 and 8962 shall come into operation on the day of Royal Assent, i.e. 16th December, 1976. Acts No. 8961, 8963 and 8965 shall come into operation on days to be fixed by proclamation. Act No. 8958, Sections 2 (2), 4, 9 and 11 shall be deemed to have come into operation on 15th October, 1974, the remaining sections on a day to be fixed by proclamation. Act No. 8960, Section 3 (2) shall come into operation on 1st January, 1978, the remaining provisions on a day or days to be fixed by proclamation. Act No. 8964 shall come into operation on 1st January, 1977.
