PROCLAMATION

I, the Governor of the State of Victoria, in the Commonwealth of Australia, do hereby declare that I have this day assented, in Her Majesty's name, to the Bills passed by the Parliament of the said State, the titles whereof are hereunder set forth, together with the short titles, that is to say:—

- No. 9012. "An Act to amend Part V. of the *Police Offences Act 1958* and for other purposes." (*Police Offences (Child Pornography) Act 1977.*)
- No. 9013. "An Act to make Provision with respect to the Licensing of Milk Vendors, to amend the *Milk Board Act 1958* and the *Milk and Dairy Supervision Act 1958* and for other purposes." (*Milk Board (Milk Vendors) Act 1977.*)
- No. 9014. "An Act to amend the *Dandenong Valley Authority Act 1963* to include certain Lands within the Catchment of the Cardinia Creek in the District of the Dandenong Valley Authority, and for other purposes." (*Dandenong Valley Authority (Cardinia Creek) Act 1977.*)
- No. 9015. "An Act to amend the *Motor Car Act 1958*, the *Stamps Act 1958*, the *Country Roads Act 1958* the *Motor Car (Compulsory Third Party Insurance) Act 1967*, the *Motor Car (Learner Drivers' Permits) Act 1972*, the *Road Traffic Act 1958*, and for other purposes." (*Motor Car (Amendment) Act 1977.*)
- No. 9016. "An Act to provide for the Appointment of a State Library and National Museum Buildings Committee for the Establishment of a State Library and National Museum Trust Fund, to make Provision for the Site for those Buildings, to amend the *Ministry for the Arts Act 1972*, and for other purposes." (*State Library and National Museum Buildings Committee Act 1977.*)
