ACTS OF PARLIAMENT

PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

I, the Governor of the State of Victoria, in the Commonwealth of Australia, do hereby declare that I have this day assented, in Her Majesty's name, to the Bills passed by the Parliament of the said State, the titles whereof are hereunder set forth, together with the short titles, that is

- No. 9032. "An Act to amend the Parliamentary Committees Act 1968, to amend the Public Works Committee Act 1958, to alter the Method of determining Attendance Fees and for other purposes."

 (Committees (Attendance Fees) Act 1977.)
- No. 9033. "An Act to amend section 16 of the Public Account Act 1958, and for other purposes." (Public Account (Amendment) Act 1977.)
- No. 9034. "An Act to amend the Epworth Hospital (Guarantee) Act 1977 and for other purposes." (Epworth Hospital (Guarantee) (Amendment) Act 1977.)

Forests Act 1958, No. 6254

DECLARATION OF PROHIBITED PERIOD

In pursuance of the powers conferred by section 3 of the Forests Act 1958, I, Frederick James Granter, Her Majesty's Minister of Forests in the State of Victoria, hereby declare a Prohibited Period in respect of any fire protected area (other than a State forest, National Park or Protected Public Land) at the times, dates, and in the municipalities specified in the Schedule hereunder:

SCHEDULE


The Prohibited Period shall commence at midnight between the second and third days of November, 1977, and end between the thirtieth day of April, and the first day of May, 1978, in the municipalities shown hereunder:

The Shires of Arapiles; Ararat, all that portion west and north-west of the Avoca-Ararat-Hamilton railway line; Bairnsdale; Dundas; Glenelg; Kowree; Minhamite; Mt. Rouse; Omeo; Orbost; Portland; Seymour; Stawell; Tambo; Wannon; Wimmera.
