PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

I, the Governor of the State of Victoria, in the Commonwealth of Australia, do hereby declare that I have this day assented, in Her Majesty's name, to the Bills passed by the Parliament of the said State, the titles whereof are hereunder set forth, together with the short titles, that is to say:—

- No. 9159. "An Act to amend the Water Act 1958, the Local Government Act 1958, and the Drainage of Land Act 1975 and for other purposes." (Water Drainage Act 1978.)

(Melbourne and Metropolitan Board of Works (Reconstitution) Act 1978)
