PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia &c., &c., &c.

Whereas the Parliament of Victoria stands adjourned until such day and hour as may be fixed by the President of the Legislative Council and the Speaker of the Legislative Assembly respectively: Now I, the Governor of the State of Victoria, in the Commonwealth of Australia, do by this my Proclamation prorogue the said Parliament of Victoria until Wednesday, 21st March, 1979.

Given under my Hand and the Seal of the State of Victoria aforesaid, at Melbourne, this thirteenth day of February in the year of Our Lord One thousand nine hundred and seventy-nine, and in the twenty-eighth year of the reign of Her Majesty Queen Elizabeth II.

DISCHARGING MEMBERS OF THE LEGISLATIVE COUNCIL FROM ATTENDANCE AND DISSOLVING THE LEGISLATIVE ASSEMBLY

PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia &c., &c., &c.

Whereas by the Constitution Act it was amongst other things enacted that it should be lawful for the Governor to fix such places within Victoria and, subject to the limitation therein contained, such times for holding the first and every other Session of the Council and Assembly, and to vary and alter the same respectively in such manner as he might think fit; and also from time to prorogue the said Council and Assembly, and to dissolve the said Assembly, by Proclamation or otherwise, whenever he should deem it expedient; And whereas the said Council and Assembly, called "The Parliament of Victoria", stand prorogued until Wednesday, 21st March, 1979. And whereas it is expedient to dissolve the Legislative Assembly: Now therefore 1, the Governor of the State of Victoria, in the Commonwealth of Australia, in exercise of the power in me vested in this behalf, do by this my Proclamation discharge the Honorable the Members of the Legislative Council from their meeting and attendance on Wednesday, 21st March, 1979. And I do dissolve the Legislative Assembly, such dissolution to take effect on Thursday, 15th March, 1979. And I do hereby declare that I have this day given Order that Writs be issued in due form, and according to law, for the election of Members to be duly returned to serve in the Legislative Assembly: and (with the consent of the President of the Legislative Council) for the Periodical Election of Members to be duly returned to serve in the Legislative Assembly:

Community Welfare Services Act 1978, No. 9248 DATE OF COMING INTO OPERATION

PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia,

Whereas by an Act of Parliament of the State of Victoria passed in the twenty-seventh year of the reign of Her Majesty, Queen Elizabeth the Second, Queen of Australia, entitled the Community Welfare Services Act 1978—No. 9248—it is amongst other things enacted that the several provisions of the said Act shall come into operation on the day or respective days to be fixed by proclamation or successive proclamations of the Governor in Council published in the Government Gazette.

Now therefore, I, the Government Gazette.

Now therefore, I, the Governor of the State of Victoria in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State, do by this proclamation fix Tuesday, the thirteenth day of February 1979 as the date on which sections I and 2; paragraphs (a); (b); (c); (d); (e) and (g) of section 4; sections 5 and 6; sub-sections (1) and (2) of section 7; sections 8, 9 and 10; sections 13–17 inclusive; sub-section (1) of section 18; paragraphs (b) and (c) of sub-section (1) and sub-section (2) of section 20; sections 26; sections 31 and 32; section 35; paragraphs (a) and (b) of section 54; sections 55 and 56 and section 58 of the Community Welfare Services Act 1978—No. 9248—shall come into operation.
