Notice of Intention to Borrow the Sum of \$300 000 for Permanent Works and Undertakings

Notice is hereby given that the Council of the City of Brunswick proposes to borrow the principal sum of \$300 000 secured by a charge over the general rates of the municipality, such sum to be raised by the grant of a mortgage in accordance with the provisions of the Local Government Act 1958.

- 1. The maximum rate of interest that may be paid is  $17 \cdot 3$  per cent. per annum.
- 2. The purposes for which the loan is to be applied

Albert Street Works and Stores Depot Re-development (part cost)
Road reconstruction, drainage and relocation of services Melville Road-Victoria Street to Albion Street (part cost) 250 000

- 3. The period of the loan shall be 10 years.
- 4. The moneys borrowed shall be repayable by providing out of the municipal fund 19 half-yearly instalments of approximately \$28 298.98 each including principal and interest on 15 June and 15 December with the final instalment of \$212 743.71 on 15 December 1992. The first instalment shall be payable on 15 June 1983.
- 5. Such moneys shall be repayable to Commonwealth Savings Bank of Australia, Melbourne.

The plans and specifications and the estimate of the cost of the proposed works and a statement showing the proposed expenditure of the moneys to be borrowed are open for inspection at the office of the Council of the City of Brunswick, at 233 Sydney Road, Brunswick.
