

PUBLIC MEETING OF PUBLIC SERVICE BOARD

The next Public Meeting to discuss policy issues will be held at 2.00 p.m. on Monday, 17 October 1983 in the State Film Theatre, 1 MacArthur Street, Melbourne. The Agenda items for the meeting are:

For the information of persons who may be interested in attending the meeting, an outline of the matters to be considered at the meeting are set out below. Full discussion papers will be sent to persons who notify their intention to attend.

1. Study Leave

The discussion paper prepared for this item seeks to describe the Public Service Board's Study Assistance Policy in the context of human resources development and to obtain advice on the policy as it stands.

2. Recruitment Policy and Practice

In 1982/83 2812 men and women were appointed as officers of the public service and at base and above-base levels. The process by which recruitment takes place and the quality of recruitment decisions have a considerable impact on the future effectiveness and vitality of the Victorian Public Service. This discussion paper proposes a recruitment model within which Victorian Public Service recruitment can be examined. The merit principle is clarified and several initiatives are put forward to upgrade the quality of recruitment activities in the Service.

3. Review of the Third Division

As part of the program of occupational category reviews, the Board has initiated an investigation of the Third Division categories.

The Third Division is currently comprised of about 26 000 positions which are classified into some 1200 different position titles. This project aims to rationalise the classification of those positions into the minimum number of occupational categories possible and to construct classification structures to reflect the organisation of work in each of those categories. The first specific group to be addressed was the Clerical Officer category and the second will be Technical Officer category.

At the meeting the Board Officer will address the policy issues involved; other parties with a major interest will be invited to comment and the Board will invite those attending to comment on the policy proposals and to raise relevant matters for discussion.

Subsequent to the Meeting the Board will finalize its consideration of the policy issues involved and will publish a statement summarizing its decisions or conclusions.

Public Servants wishing to attend the Meeting should obtain approval for appropriate time off from their Permanent Head.



A By-law of the City of Keilor made under the provisions of the *Health Act* 1958 (as amended) and numbered 75 for —

- (a) the provision, use and control of receptacles for the deposit and collection of refuse and rubbish (whether temporary or otherwise) and prescribing the size and shape of and the materials to be used in the construction of such receptacles; and
- (b) preventing or regulating the deposit of refuse and rubbish upon streets and other lands and places under the control of the Council; and
- (c) the removal, replacement, cleansing and disinfecting of receptacles for refuse and rubbish; and
- (d) repealing By-laws numbered 19 and 57 of the City of Keilor.

In pursuance of the powers conferred by the *Local Government Act* 1958 and the *Health Act* 1958 and any and every other power it thereunto enabling the Mayor, Councillors and Citizens of the City of Keilor order as follows:

- 1. By-laws numbered 19 and 57 of the City of Keilor are hereby repealed.
- 2. This By-law may be known as the Household Refuse Disposal By-law.
- 3. In this By-law, unless inconsistent with the context or subject matter —
- "City Engineer" means the City Engineer for the time being of the City of Keilor.
- "Council" means the Council of the City of Keilor.
- "Household refuse" includes all refuse, rubbish, garbage and wastes produced in or about any premises but excludes sewage, manure, materials of a mineral nature and trade waste.
- "Occupier" includes the owner, occupier, registered proprietor and/or any other person having the management or control of any premises.
- "Premises" includes messuages, buildings, lands and hereditaments of every tenure.
- "Trade Waste" means all refuse, rubbish, garbage and waste produced or accumulated in or about any premises and arising from the use of such premises for any trade or business.
- 4. The occupier of every premises shall provide, keep and maintain at all times upon such premises a properly constructed receptacle in which he shall from time to time cause to be deposited all household refuse produced or accumulated in or about such premises.
 - 5. Every receptacle for the purposes of this By-law shall:
 - (a) have a capacity of not more than 0.084 cubic metres and when containing household refuse shall not exceed twenty kilograms in weight; and
 - (b) be constructed of galvanised iron of not less than 24 gauge or impervious plastic material in such a manner as to prevent the escape by leakage or otherwise of any of the contents of such receptacle and any absorption by any part of the receptacle of any household refuse deposited therein; and
 - (c) be watertight, flyproof, vermin-proof; and
 - (d) be provided with stout side-handles to make it capable of being easily and conveniently carried by one person; and
 - (e) be provided with a flyproof and vermin proof close fitting lid with a handle thereon and having a flange overlapping the top of such receptacle and such lid

- shall be incapable of being dislodged by animals or when the receptacle is overturned: and
- (f) be kept covered at all times by the occupier (except when household refuse is being deposited therein); and
- (g) be kept at all times in a clean inoffensive and sanitary condition.
- 6. A person shall not deposit any household refuse in any bag made of plastic or any other material unless such bag is wholly contained within a receptacle as defined under the preceding clause.
- 7. A person shall not place or cause or permit to be placed in any such receptacle:
 - (a) any slops or liquid waste; and
 - (b) any moist refuse unless the same has been previously strained and securely wrapped in paper in such a manner as to prevent its escape from such paper; and
 - (c) any dust from any vacuum cleaner; ashes; hair or other like substance unless the same has been securely wrapped in paper in such a manner as to prevent its escape from such paper; and
 - (d) any ashes or other like substance unless the same is non-combustible and free from any heat-generating particles; and
 - (e) any trade waste.
- 8. The occupier of every premises shall on the days appointed by the City Engineer as the days on which household refuse will be collected from such premises place or cause to be placed the receptacle or receptacles provided by him as aforesaid on the footway adjoining such premises near to the street channel or in such other location as may from time to time be approved by the City Engineer and shall remove or cause to be removed such receptacle from such footway or other location within a period of twelve hours from the time at which household refuse has been discharged from such receptacle.
- 9. A person shall not place, throw, sweep, hose, leave or deposit or cause to be placed, thrown, swept, hosed, left or deposited on any street, footpath, nature strip, right-of-ways or land, household refuse of any kind, save for the household refuse placed in a receptacle as aforesaid, or in a street container provided by the council for that purpose.
- 10. Any person guilty of any wilful act or default contrary to any of the provisions of this By-law shall be liable to a penalty of not less than \$10.00 nor more than \$100.00 for each offence and in the case of a continuing offense shall be liable to a penalty of not more than \$10.00 for each day on which such offence is continued after a conviction or order by any court.
- 11. This By-law shall apply to and have operation throughout the whole of the municipal district of the City of Keilor.
- 12. This By-law shall come into force and effect on the day following the date of its publication in the Victorian Government Gazette.


