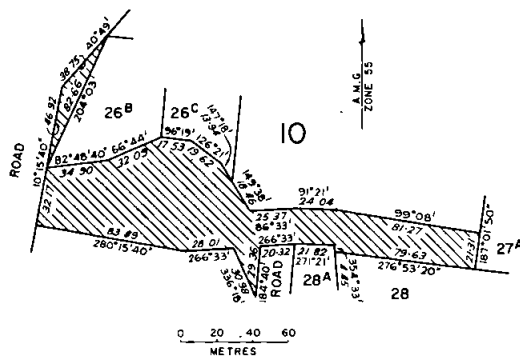

MACALISTER RIVER IMPROVEMENT TRUST

By-Law No. 27

The Macalister River Improvement Trust, in pursuance and exercise of the powers conferred by the *River Improvement Act 1958*, doth hereby make the following By-Law.

1. The following rate, to be called the "Macalister River Improvement District River Improvement Rate" is hereby made and shall be levied upon occupiers and owners of all properties within the Macalister River Improvement District which are rateable to any Municipality a Rate of .085 cents in the Dollar on the Annual Municipal Value of such properties provided that the sum of Two Dollars shall be the minimum amount of rate in respect of any property liable to be rated in the said district.

2. Such rate is made and shall be levied for the year beginning with 1 January 1983 and ending with 31 December 1983 and shall be payable on 1 January 1983 at the office of the Macalister River Improvement Trust at Maffra.

3. Such person or persons as the Macalister River Improvement Trust may from time to time appoint for that purpose shall be and is or are, hereby authorized to demand, collect and recover the said rate.

YARRA RIVER IMPROVEMENT TRUST

RATING BY-LAW 1983

The Yarra River Improvement Trust in pursuance and exercise of the powers conferred by the *River Improvement Act 1958*, doth hereby make the By-Law following:

1. The following rate to be called "Yarra River Improvement District River Improvement Rate" is hereby made and shall be levied upon the occupiers or owners of all properties within the Yarra River Improvement District which are rateable to any municipality—

First Division—A rate of 2.714 cents in the dollar on the net annual municipal value of such properties. Provided that the sum of four dollars shall be the minimum amount of rate in respect of any property liable to be rated in the said district.

Second Division—A rate of 2.2526 cents in the dollar on the net annual municipal value of such properties. Provided that the sum of four dollars shall be the minimum amount of rate in respect of any property liable to be rated in the said district.

Third Division—A rate of 0.9499 cents in the dollar on the net annual municipal value of such properties. Provided that the sum of four dollars shall be the minimum amount of rate in respect of any property liable to be rated in the said district.

Fourth Division—No rate.

Fifth Division—No rate.

2. Such rate is made and shall be levied for the year beginning with 1 January 1983, and ending with 31 December 1983, and shall be payable on 1 June 1983, at the office of the Yarra River Improvement Trust at Healesville.

3. Such person or persons as the Yarra River Improvement Trust may from time to time appoint for that purpose shall be and is or are hereby authorized to demand, receive, collect, and recover the said rate.

MEDICAL BOARD OF VICTORIA

RECORD OF TEMPORARY MEDICAL REGISTRATION AS AT 31 DECEMBER 1982

Printed and published under the direction of the Medical Board of Victoria pursuant to the provisions of Section 27 of the *Medical Practitioners Act 1970*.

Section 27 of the *Medical Practitioners Act 1970* states, *inter alia*:

Section 27 (2) enables the Board to apply conditions and limitations when issuing a certificate of temporary registration.

Temporary registrants will, in general, be required to work *either*—

- (a) under the *general supervision* of and within the applicant institution or an officially-related institution or, with the approval of the applicant registration, within separate institutions of the same standard as the applicant institution.

When these conditions are to apply, Class I temporary registration may be granted;
or

- (b) under the direct supervision of *qualified members of the staff* of the applicant institution and only within the applicant institution or an officially-related institution. If specifically sought by the applicant institution the Board may grant permission for the registrant to work outside the applicant institution or an officially-related institution provided that such work is solely within the practice of the designated qualified member of the staff of the sponsoring institution and under his constant direct supervision. Under these conditions the temporary registrant may *not*

- (i) act as the principal treating doctor in the clinical management of patients;

- (ii) render accounts except as an assistant to the designated qualified member of the staff of the applicant institution.

When these conditions are to apply, Class II. temporary registration may be granted.

Section 27 (3) states—

"Every such certificate shall in the first place be issued for a period of not more than two years, but upon application in writing by the governing body of a teaching or research institution during the currency of the certificate the Board may from time to time renew the certificate for a further period or periods of not more than one year in respect of each such application, but so that the maximum period for which a certificate may be in force under this section in respect of any person shall not in the aggregate exceed four years."

Section 27 (4) states—

"The Board may at any time cancel any certificate issued or renewed under this section and thereupon the certificate shall cease to have any force or effect."

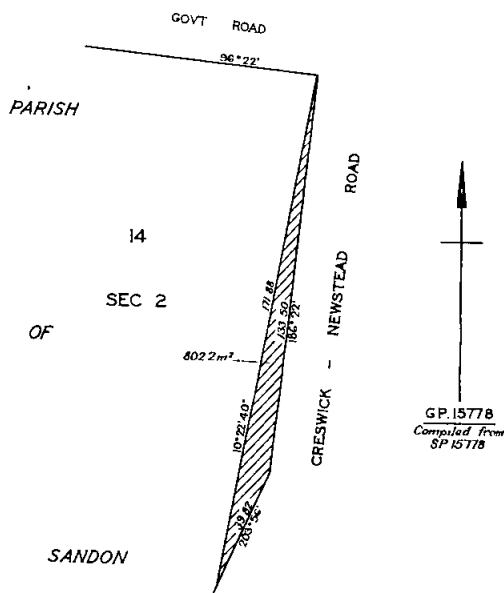

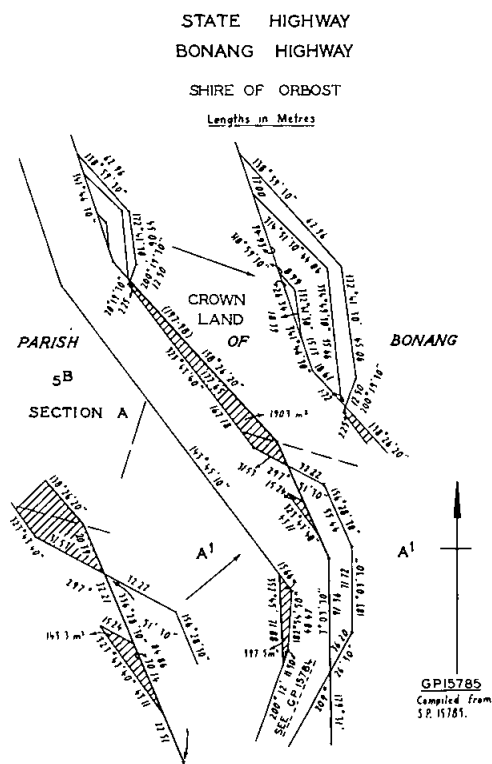

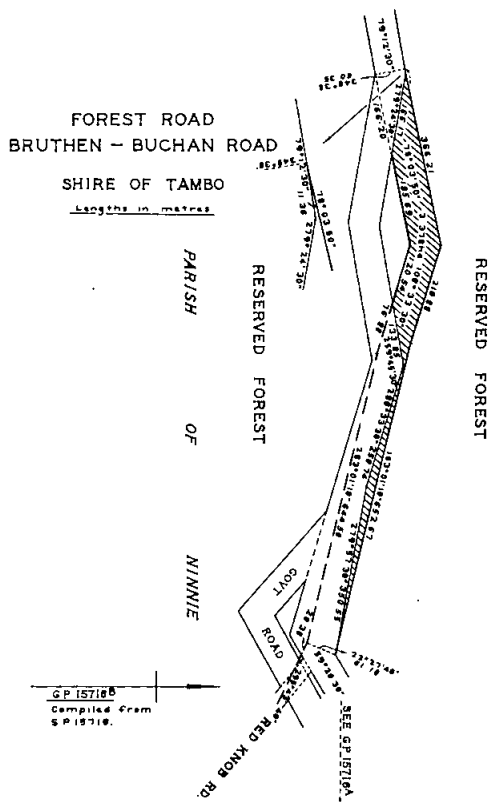

 - (b) habitually makes on any highway within the municipal district an amount of noise which is unreasonable and excessive having regard to the locality and the time;
 - (c) causes a nuisance by the emission of sounds.
2. (i) The Municipal Clerk upon receipt of at least two independent and separate complaints submitted to him in writing and signed by the persons making the same alleging—
- (a) that they are householders within the said municipal district;
 - (b) that they reside within hearing of the sound of any animal kept on any premises within the municipal district; and
 - (c) that such animal is the source of noise which falls within one or more of the sub-paragraphs of Clause 1 of this By-Law;

shall refer the matter to the Council.

(ii) The Council may direct that such investigations as it may deem necessary or desirable should be made in respect of such complaints.

(iii) Upon receiving evidence to its satisfaction that such complaints are justified the Council shall serve upon the owner or occupier of the premises on which such animal is normally kept a notice requiring that such noise or nuisance be abated within seven days of the date of service of the notice and that thereafter no animal shall be kept or allowed to be kept on the premises in contravention of Clause 1 hereof.

3. Any owner or occupier who having been served with such a notice is, after the expiration of the said period of seven days, in breach of Clause 1 hereof shall be guilty of an offence and shall be liable—

- (a) to a penalty of not more than \$100.00; and
- (b) in the case of a continuing offence, to a penalty of not more than \$10.00 for each day on which such offence continues after a conviction or Order in respect thereof by any Court.

4. In this By-Law—

- (a) "animal" includes any bird; and
- (b) "premises" includes any building and any land.

5. This By-Law shall apply to and have operation throughout the whole of the municipal district.
