Country Fire Authority Act 1958

VARIATION OF FIRE DANGER PERIOD

In pursuance of the powers conferred by section 4 of the *Country Fire Authority Act 1958*, I, Charles Race Thorson Mathews, Minister for Police and Emergency Services, after consultation with the Minister of Forests hereby vary the declaration of fire danger periods previously published in the *Government Gazette* by declaring that such fire danger periods shall end from and inclusive of Monday, 28 March 1983, in respect of the under-mentioned municipalities or parts of municipalities:
