DRUGS, POISONS AND CONTROLLED SUBSTANCES ACTS 1981

PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

Whereas by section 9 of the *Drugs, Poisons and Controlled Substances Act* 1981 it is amongst other things enacted that the Governor in Council may, by proclamation published in the *Government Gazette* amend any of Schedule One, Two, Three, Four, Five, Six, Seven or Eight or any column in Schedule Eleven to the said Act by adding to any of the said Schedules or removing therefrom any item.

Now therefore, I, the Governor of the State of Victoria in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State do by this my Proclamation:

Amend the Principal Act as follows:

(a) In Schedule Two:

Before the item relating to ACETIC ACID there shall be inserted the following:

"In this Schedule 'NON-OPIATE ANTITUSSIVE' means any antitussive that is not a Poison or Controlled Substance and any antitussive that is included in this Schedule, except the following:

ACETYLDIHYDROCODEINE CODEINE DIHYDROCODEINE NICOCODINE NICODICODINE NORCODINE PHOLCODINE"

(b) In Schedule Three:

Before the item relating to ADRENALINE there shall be inserted the following:

"In this Schedule, 'OPIATE ANTITUSSIVE' means any of the following:

ACETYLDIHYDROCODEINE

CODEINE

DIHYDROCODEINE

NICOCODINE

NICODICODINE

NORCODEINE

PHOLCODINE"

- (c) In Schedule Four:
 - (i) The following items are removed:

"VACCINES, sera, toxoids, anti-toxins and antigens for human parenteral use."

"VACCINES, Veterinary Live Virus, except poultry vaccines."

(ii) After the item relating to MICONAZOLE there shall be inserted the following item:

"MINOXIDIL."

(iii) After the item relating to PIPERACILLIN there shall be inserted the following item:

"PIROXOCAM."

(iv) After the item relating to URETHANES there shall be inserted the following items:

"VACCINES, sera, toxoids, anti-toxoins, antigens and venoms for human parenteral use"

"VACCINES, veterinary live virus, except-

- (a) poultry vaccines; and
- (b) scabby mouth vaccines in Schedule Six."
- (d) In Schedule Five:

Before the item relating to ACETIC ACID and after the item relating to Pottery there shall be inserted the following item:

"Sealed metal tubing in vapour pressure thermometers."

- (e) In Schedule Six:
 - (i) in the preamble after the item relating to Pottery there shall be inserted the following item:

"Sealed metal tubing in vapour pressure thermometers."

(ii) The following item is removed:

"ARSENIC, the following-

- (a) substances containing 0-5 per centum or less or Arsenic; and
- (b) substances containing more than 0.5 per centum of Arsenic when specifically prepared, packed and labelled for use as sheep or cattle dips or as sheep or cattle drenches or as solutions for the treatment of foot-rot."
- (iii) Before the item relating AZAMETHIPHOS there shall be inserted the following item:
 - "ARSENIC, the following-
 - (a) substances containing 0-5 per cent or less of arsenic;
 - (b) substances containing more than 0-5 per cent of arsenic when specifically prepared, packed and labelled for use as sheep or cattle dips or as sheep or cattle drenches or as solutions for the treatment of foot-rot; and
 - (c) in animal feedstuff pre-mixes containing 4 per cent or less of arsenic."
- (iv) After the item relating to TRIETHYL PHOSPHATE there shall be inserted the following item:

"VACCINES, veterinary live virus, scabby mouth."



Whereas by an Act of Parliament of the State of Victoria passed in the thirtieth year of the reign of Her Majesty Elizabeth the Second, Queen of Australia, entitled the Building Control Act 1981, No. 9720 it is amongst other things enacted that—

- 1. The several provisions of the said Act (except the several items in the Schedule) shall come into operation on the day or on the respective days to be fixed by proclamation or successive proclamations of the Governor in Council published in the Government Gazette; and
- 2. The several items in the said Schedule shall come into operation on the day or on the respective days to be fixed by proclamation or successive proclamations of the Governor in Council published in the Government Gazette.

And whereas by a proclamation dated 20 April 1982, Monday, 2 August 1982 was the day fixed on which—

- 1. Sections 1 to 16 inclusive, 18 to 30 inclusive, 45 to 64 inclusive, 131 to 179 inclusive of the said *Building Control Act* 1981, No. 9720 came into operation; and
- 2. Items 59 to 62 inclusive, 64 to 69, 71, 90 and 97 to 100 inclusive of the said Schedule came into operation.

And whereas by a proclamation dated 27 March 1984, Monday, 2 April 1984 was the day fixed on which sections 65 to 84 inclusive of the *Building Control Act* 1981, No. 9720 came into operation.

Police Regulation Act 1958 VICTORIA POLICE FORCE

Determination No. 411 of the Police Service Board.

The Police Service Board, in pursuance of the powers in that behalf conferred by the *Police Regulation Act* 1958, hereby makes the following Determination (that is to say):

- 1. The Determination No. 179 of the Police Service Board of 14 December 1971, and published in the *Government Gazette* of 25 January 1972, as amended, is hereby further amended as follows:
- 1.1 By deleting paragraphs 85-117 inclusive and substituting therefor the following new paragraphs:

SUB-DIVISION II SICK LEAVE

- 85. Subject to this sub-division, the Chief Commissioner may, in case of illness of a member, grant leave of absence to him.
- 86. In cases of illness of a member, the conditions under which the Chief Commissioner may grant leave of absence shall be as set out hereunder.
- 87. (1) In the case of members joining the Police Force on or subsequent to 17 February 1975, the basis for determining the amount which may be granted, when sick leave with pay is approved, shall be ascertained by crediting the member with the following periods, such sick leave to be cumulative:

On admission to the Police Force—30 days leave on full pay.

On completion of 2 years of service, and each year's service thereafter—

15 days leave on full pay.

- 87. (2) In the case of members who were in the Police Force prior to 17 February 1975, the basis for determining the amount which may be granted, when sick leave with pay is approved, shall be ascertained by crediting the member with any sick leave standing to his credit which was accumulated under the provisions of any regulation in force prior to such date and by the addition of 15 days per annum on the subsequent anniversary dates of the member's appointment.
- 88. (1) Where the Chief Commissioner is satisfied that the illness of a member is directly attributable to or is aggravated by his service in the war which commenced in the year 1939, apart from any sick leave which may be standing to his credit, he may be granted up to and inclusive of 30 June 1954, special sick leave with full pay, up to but not exceeding 8 days in the aggregate during any year of service, and from and inclusive of 1 July 1954, up to but not exceeding 15 days in the aggregate during any year of service. Such special sick leave shall be cumulative provided that the total of accumulated leave under this provision standing to the credit of the member shall not at any time exceed 100 days.
- 88. (2) Where the Chief Commissioner is satisfied that the illness of a member is directly attributable to or is aggravated by his service in connection with the warlike operations in Korea after 26 June 1950, or in Malaya after 28 June 1950 or in Vietnam after 31 July 1968, part from any sick leave which may be standing to his credit, from and inclusive of 17 February 1975, he may be granted special sick leave with full pay up to but not exceeding 15 days in the aggregate during any year of service. Such special sick leave shall be cumulative provided that the total of accumulated leave under this provision standing to the credit of the member shall not at any time exceed 100 days.
- 89. To determine the sick leave for which a member is eligible at any time, all sick leave granted with full pay during his service after 1 June 1948, shall be deducted from the appropriate period ascertained under the provisions of the preceding paragraphs.
- 90. After deduction has been made as provided in the preceding paragraphs, the period remaining shall be the amount of sick leave for which a member is eligible.
- 91. Notwithstanding the amount of sick leave standing to the credit of any member, continuous sick leave with pay shall not be granted for any period longer than 52 weeks. Where a member has had 52 weeks continuous sick leave with full pay, no further leave with full pay shall be granted until such member has completed a period of duty of not less than 4 weeks.
- 92. Notwithstanding the provisions of paragraph 91 if a member sustains injury in the discharge of his duty or whilst on a journey necessary to enable him to report for duty or return home after duty, or contracts illness directly attributable to his duty, of such a nature as to incapacitate him from duty, and the Chief Commissioner is satisfied that such injury or illness was not contributed to by such member's culpable negligence or wilful misconduct, he may approve of such injury or illness as "on duty", whereupon such member shall be granted sick leave on full pay during such incapacity until he has recovered or been dealt with under the provisions of Part III, Division 2 of the *Police Regulation Act* 1958, and such leave granted under this clause shall not be regarded as debit against the amount of sick leave standing to his credit.
- 93. Any member claiming to have sustained injury or contracted illness directly attributable to his duty must furnish a report for the information of the Chief Commissioner, setting out in detail the circumstances of such injury or illness, together with the names of any witnesses of the occurrence or any other evidence. Such report must be furnished as soon as practicable by the member concerned or by some other member to whom the circumstances are known or reported.

When such claim is approved by the Chief Commissioner, the member concerned shall, in addition to full pay, receive without charge any medical, surgical, x-ray, pathological, nursing or other incidental treatment made necessary by such injury or illness, at any time during his period of service, at the Police Hospital or elsewhere, if recommended by the Police Medical Officer and approved by the Chief Commissioner.

- 94. For each week a member is absent on sick leave with pay, the amount of sick leave standing to his credit shall be reduced by 5 days.
- 95. When the period of sick leave granted to a member with pay does not extend to a week, his appropriate credit shall be reduced by the number of days he would have been required to be on duty if he had not been absent on sick leave.
- 96. For the purposes of sick leave under this Sub-Division, a week shall be deemed to be any period of 7 consecutive days, inclusive of a Sunday.
- 97. For a period exceeding 3 days' absence, a member must forward a satisfactory certificate, by a legally qualified medical practitioner, that he will be incapacitated for a period not exceeding 28 days and setting out the cause of such absence. Any extension of such leave may be granted subject to the receipt of a further satisfactory medical certificate to be forwarded with respect to any period of absence.
- 98. Where the number of days during which a member is absent through illness in any year without a medical certificate exceeds 5 days in the aggregate, the number of days in excess of 5 shall not be granted as sick leave but shall be deducted from his annual recreation leave, or be granted without pay.
- 99. If any member is certified by the Police Medical Officer or by some other legally qualified medical practitioner, approved by the Chief Commissioner, to be suffering from pulmonary tuberculosis and to be probably curable, 12 months sick leave of absence may be granted on full pay. Such sick leave may be made conditional on the member undergoing treatment in a specified sanatorium when so recommended by the Police Medical Officer or other approved practitioner. Any leave so granted in excess of the amount standing to his credit shall not be regarded as a debit against the member. Where any member who has received sick leave of absence as aforesaid is not so far recovered as in the opinion of the Police Medical Officer or other approved practitioner to be able to resume his duties, and the Police Medical Officer or other approved practitioner is of the opinion that the member should receive further treatment and is probably curable, such member may be granted such further leave on such terms and conditions as the Chief Commissioner may determine.
- 100. If any member is certified by the Police Medical Officer to be suffering from poliomyelitis, or the after effects thereof, and to be unfit for duty, leave of absence may be granted for 6 months, on full pay and 3 months on half pay. Any leave so granted in excess of the amount standing to his credit shall not be regarded as a debit against such member, and on his resumption of duty he shall be entitled to a total initial credit of not less than 15 days.
- 101. Where the Chief Commissioner has reason to believe that a member is in such a state of health as to render him a danger to his fellow members, he may require such member to furnish a report as to his condition from an approved legally qualified medical practitioner, or may require him to submit himself for examination to the Police Medical Officer.
- 102. Upon receipt of a medical report, the Chief Commissioner may direct the member to absent himself from his duties for a specified period, or if already on leave of absence, to continue on leave for a specified period, and any such absence shall be regarded as sick leave.

- 103. Any member who contracts an infectious or contagious disease shall report the matter to the Chief Commissioner without delay, whereupon he shall be granted the usual terms of sick leave provided that if so instructed by the Chief Commissioner, he present himself when directed for medical treatment. Where a member contracts an infectious or contagious disease and fails to report the fact as provided, he shall not be entitled to sick leave with pay under the provisions of this sub-division.
- 104. Any member who is ill may on application attend the Police Hospital for medical examination, and subject to the provisions of paragraphs 94 and 95 members may receive treatment subject to payment of the fees as fixed by the Governor in Council.
- 105. The Chief Commissioner may order any member to attend at the Police Hospital for medical examination, and where such member so attends under the order of the Chief Commissioner, such medical examination shall be free of charge.
- 106. Any member who is ill and unfit for duty shall notify the Officer in Charge of the station to which he is attached of his inability to attend for duty and the nature of his ailment. Such notification shall, where practicable, be made half an hour before the time fixed for the commencement of such member's duty.
- 107. Any member who is Officer in Charge of a station and who is ill and unfit for duty shall report the fact as soon as practicable to the officer in Charge of the District or Division to which he is attached.
- 108. Where a member is continuously absent from duty on account of illness beyond a period of 13 weeks, he shall not be permitted to resume duty until the Police Medical Officer or some other approved legally qualified medical practitioner has certified that he is fit to resume duty.
- 109. In cases of serious illness or where other justifiable cause exists the Chief Commissioner may approve of sick leave for a period not exceeding 3 months being granted on the recommendation of the Police Medical Officer or other approved legally qualified medical practitioner.
- 110. Where a member is absent on account of sickness, injury or disability which is proved to be simulated, or such absence arises from improper or vicious conduct or excessive indulgence in alcohol or improper or illegal practice, he shall not be entitled to sick leave with pay under the provisions of this Sub-Division.
- 111. Where the Chief Commissioner has doubts as to cause of illness or the reason for absence he may, before accepting a medical certificate refer such certificate to the Police Medical Officer for report, or order the member concerned to attend the Police Medical Officer for examination.
- 112. Any member who is able and fails to attend the Police Medical Officer when so instructed by the Chief Commissioner shall not be entitled to sick leave with pay under the provisions of this sub-division.
- 113. The Chief Commissioner notwithstanding anything in this sub-division, where he is of the opinion that any member is unfit through his mental or physical condition to continue in the Police Force, may direct that such member be examined by the Police Medical Board if he is a contributor to the Police Pension Fund or the Government Medical Officer if he is a contributor to the State Superannuation Fund.
- 114. For the purposes of sick leave under this Sub-Division "service" means "continuous service", inclusive of any period of absence on leave. In determining at any time the amount of sick leave standing to the credit of a member who has been absent on leave without pay (other than for the purpose of service with any Naval, Military or Air Expeditionary Force, or the Commonwealth Defence

Force) continuously for a period extending beyond 6 months, the portion of such period in excess of 6 months shall not be counted as service.

- ilil 5. Any member who is required to render service with the Citizen Forces, and who, while so serving sustains injury or contracts illness necessitating his absence from duty beyond the period of leave granted by the Chief Commissioner under the provisions of the Police Regulations, may be granted leave on the following terms:
 - (a) If compensation is not paid to the member by the appropriate Commonwealth Department in respect of such absence the leave may be granted as sick leave.
 - (b) If compensation is paid and is equal to or exceeds the amount of pay which the member would have received and had he been granted sick leave, the leave shall be granted without pay.
 - (c) If compensation is paid, and is less than the amount of pay which the member would have received had he been granted sick leave, he may be paid an amount equal to the difference and his sick leave credit reduced as if he had been granted sick leave for such number of days as is appropriate to the amount of the difference.
- il 16. The provisions of the Sub-Division shall be read and construed so as not to deprive any member of any pension or benefit to which he is entitled under the provisions of the *Police Regulation Act* 1958.
- 11:17. If a member recovers or receives at law or by settlement or under the Workers Compensation Act 1958, compensation or benefit which, in the opinion of the Police Service Board, is substantially the same as is provided for him in this Determination he shall not be entitled to substantially the same benefit under this Determination in addition to such compensation or benefit.
- 2. This Determination shall come into operation on and from 11 (October 1984.

52. Members attending courses or conferences in the metropolitan area or elsewhere in Victoria may be re-imbursed the equivalent of a first class rail fare, to enable them to travel to and from their homes every weekend for the duration of the courses or conferences.

Miscellaneous Expenses

- 53. (1) A member when required to travel by rail in the performance of his duty shall be entitled to travel first class, except when the duty being performed is the escorting of a prisoner.
- (2) A member when authorized or required to travel by air in the performance of his duty shall travel economy class.
- 54. (1) Where a member is supplied, free of cost, with sleeping accommodation in respect of a journey made by rail, there shall be deducted from any expenses payable to him the sum of \$30.45 in respect of each night when such accommodation is provided.
- (2) Where a member travels by air, boat, rail or other facility and food and sleeping accommodation or either of them is provided and charged for in the fare, he shall not be entitled to any of the expenses herein before prescribed, but shall be entitled during such travel to receive the allowance for incidentals specified in paragraph 45 (5).
- 55. A member performing full time duty at a mobile police station during the period he is engaged on such duty for each day or part of day shall receive:
 - (a) where the mobile police station is fully equipped with bedding, cutlery, crockery and cooking utensils, an allowance of \$15.81;
 - (b) where the mobile police station is not so equipped, an allowance of \$20.90.

The Police Service Board in pursuance of the powers in that behalf conferred by the *Police Regulation Act* 1958, hereby makes the following Determination (that is to say):

- 1. The Determination Nos. 408 and 411 of the Police Service Board of 11 October 1984, are hereby amended as follows:
- 1.1 In Determination No. 408 by deleting paragraph 50 and substituting therefore the following new paragraph:

"Course or Conference Expenses

50. A member whilst attending a training course at the Police College 'Airlie' shall be granted the following relevant allowances:

(a) whilst residing at the College—

- (b) whilst not in residence at the College, but partaking of one or more meals, the appropriate meal allowance specified in sub-paragraph (a)."
- 1.2 In Determination No. 411 by deleting paragraph 92 and substituting therefore the following new paragraph:

"Notwithstanding the provisions of paragraph 91 if a member sustains injury in the discharge of his duty or whilst on a journey necessary to enable him to report for duty or return home after duty, or contracts illness directly attributable to his duty, of such a nature as to incapacitate him from duty, and the Chief Commissioner is satisfied that such injury or illness was not contributed to by such member's culpable negligence or wilful misconduct, he may approve of such injury or illness as 'on duty', whereupon such member shall be granted sick leave on full pay during such incapacity until he has recovered or been dealt with under the provisions of Part III., Division 2 of the *Police Regulation Act* 1958, and such leave granted under this clause shall not be regarded as a debit against the amount of sick leave standing to his credit."

2. This Determination shall come into operation on and from 11 October 1984.

Legal Profession Practice Act 1958 SOLICITORS (PROFESSIONAL CONDUCT AND PRACTICE) RULES 1984

Whereas by section 88 of the Legal Profession Practice Act 1958 the Council of the Law Institute of Victoria is empowered to make rules regulating in respect of any matter the professional duties practice conduct and discipline of practitioners whether engaged in practice as principals on their own account or employed by other practitioners or by persons not practitioners.

Now therefore the Council of the Law Institute of Victoria in pursuance of section 88 of the Legal Profession Practice Act 1958 and all other powers thereto enabling hereby makes the following rules:

1. These rules may be cited as the "Solicitors (Professional Conduct and Practice) Rules 1984" and shall come into operation on the date of their publication in the Victoria

Government Gazette.

- 2. (1) A solicitor may advertise in connection with his practice if the advertising—
 - (a) is not false;
 - (b) is not misleading or deceptive or likely to mislead or deceive;
 - (c) is not vulgar or sensational;
 - (d) does not claim or imply the superiority of the solicitor over any or all other solicitors;
 - (e) does not contain any testimonials or endorsements concerning the solicitor;
 - (f) does not contain any claim (either directly or indirectly) that the solicitor is a specialist, expert, leader or an established or experienced solicitor in any field of practice or generally, except that the advertisement may contain a statement of the fields of practice in which he will or will not accept instructions.
- (2) Notwithstanding sub-rule (1), if in the opinion of the Council the advertisement is undesirable, unprofessional or likely to bring the profession into disrepute, the Council may order such solicitor to cease or amend such advertising.
- 3. A solicitor shall at all times use his best endeavours to complete any work on behalf of his client as soon as is reasonably possible.
- 4. (1) A solicitor shall not carry on practice in any place, whether the same be his main practice or a branch thereof, unless he or some other solicitor entitled to practice in Victoria is in charge at that place and gives substantial attendance thereat during the normal business hours of his practice at that place: Provided that a solicitor may send a clerk who is not a solicitor to a branch office for the purpose only of receiving instructions for the preparation of income tax returns.
- (2) For the purposes of the preceding sub-rule substantial attendance shall mean attendance for a substantial period of each day of which the office of the solicitor is open to members of the public. The office of a solicitor at any place shall be deemed to be open to the public on every week day (other than public holidays) during the year unless the solicitor sets out in legible characters on a sign erected at or near the entrance to that office and on all letters or documents written or prepared by him or any of his clerks in the course of or in connection with his practice thereat the day or days and the hours thereof during which his office is so open at that place.
- (3) Except with the express consent of the Council a solicitor shall not carry on practice in any place unless his office is open to the public at that place during the normal

business hours for a period of not less than two consecutive hours in each week during the year save for those weeks in which the office is closed for annual holidays.

.

- (4) Every solicitor who does not carry on practice as a sole practitioner under his own name shall have mentioned in legible characters on all letters written by him or any of his clerks or by his firm or any of the clerks of the firm in the course of or in connection with his practice or the practice of the firm.
 - (a) the business name and the name or names of all persons registered or required to be registered under the Business Names Act 1962; or
 - (b) the name of the firm and in addition the names of all the partners practising under that firm name.
- 5. (1) (a) Subject to sub-rule (3), a solicitor shall, within a period of one month after being so requested in writing by a client or such further period as the client in writing allows or as may in the circumstances be reasonable, render to the client a bill of costs in such detail as to be capable of being taxed and covering all work performed for that client to which such request relates and for which he has not already rendered such a bill of costs or been paid.
- (b) For the purpose of this rule, a solicitor shall not be deemed to have been paid if, without the written authority of his client, he has appropriated moneys held by him on behalf of the client in or towards satisfaction of the amount alleged to be owing by the client to him.
- (2) Without prejudice to any other liability of the solicitor, if the solicitor fails or neglects to render such a bill of cost within such period as aforesaid he shall, subject to sub-rule (3), forthwith pay to the client all moneys and deliver to the client all documents which he is holding on behalf of that client notwithstanding that he may otherwise be entitled to a lien upon those moneys or documents for payment of his costs.
- (3) The foregoing provisions of this rule shall not apply to a solicitor who has a sufficent and satisfactory reason for not complying with the said request of his client.
- (4) For the purposes of this rule, the expression "bill of costs" includes an account within the meaning of the Regulations made pursuant to the Family Law Act 1975.
- 6. Where any complaint is made to the Council or the Secretary concerning the conduct of a solicitor in his professional capacity, such solicitor shall, within 14 days after being called upon by the Council, the Ethics Committee of the Council or the Secretary so to do, furnish to the Council in writing a full and accurate account of his conduct in relation to the subject matter of the complaint, unless he has a sufficient and satisfactory reason for not furnishing an account thereof
- 7. (1) A solicitor shall not, in the course of or in connection with his practice, accept a commission or other remuneration for negotiating for, or procuring an agreement for, or acting as an agent for the receipt of, a loan of money except—
 - (a) where the repayment of the loan is to be secured by a mortgage, charge, lien or assignment of any real or personal property or by a guarantee which is to be so secured and the solicitor receives no more than the appropriate fees and costs prescribed by the Solicitors' Remuneration Order or payable under an agreement made pursuant to section 87 of the Supreme Court Act 1958; or
 - (b) where he has been retained by a borrower to procure a loan of a specified amount in an isolated transaction (not being one of a series of similar transactions for the same client) and, if he is also acting for the lender, the amount of commission or remuneration which he

- is to be paid by the borrower is disclosed in writing to the lender prior to the loan being made; or
- (c) where the solicitor is acting as the agent of a member of any one of the Australian Associated Stock Exchanges and the commission or other remuneration is paid to him by his principal.
- (2) In this rule "loan of money" shall, in additional to the normal meaning of the term, include any agreement whereby for valuable consideration any property is transferred subject to a condition that the transferee will transfer the property back to the transferor upon the occurrence of some specified event and, in particular, any sale by a society under the Building Societies Act 1958 of borrowing shares of the society upon terms requiring or entitling the society or some other person to re-purchase such shares at some future date.
- (3) Receipt of a procuration fee by a partner or a member of the family of the solicitor or his partner or by a company (other than a company the shares in which are listed on any Stock Exchange in Australia) in which any shares are beneficially held by the solicitor or his partner or a member of the family of the solicitor or his partner shall be deemed a breach of this rule.
 - 8. (1) A solicitor shall not-
 - (a) directly or indirectly borrow money from his client;
 or
 - (b) knowingly arrange for or permit his client to lend money to—
 - (i) any member of the immediate family of that solicitor:
 - (ii) any partner, employer or employee of that solicitor;
 - (iii) any member of the immediate family of a partner, employer, or employee of that solicitor; or
 - (iv) any corporation, partnership or trust in which that solicitor, or a partner, employer or employee of that solicitor, or a member of the immediate family of any of them, has, directly or indirectly, a material interest—

unless—

- (c) the client is a corporation or natural person whose business is or includes the lending of money to members of the public; or
- (d) that solicitor is able to discharge the onus of proving that full written disclosure was made to the client and that the client's interests were fully protected in the circumstances of the case whether by independent legal representation or otherwise.
- (2) In this rule, unless inconsistent with the context or subject matter—

"Client", in relation to a solicitor, includes-

- (a) a person between whom and that solicitor or his partner, employer or employee the relationship of solicitor and client exists;
- (b) a person seeking to lend or invest money who for that purpose consults that solicitor or his partner, employer or employee; and
- (c) a person who in the circumstances is entitled to look to that solicitor for guidance and advice in respect of a proposed loan or investment.

"Member of the immediate family" includes a spouse, child, grandchild, sibling, parent, grandparent, spouse of a child, spouse of a grandchild, spouse of a sibling, spouse of a parent, and spouse of a grandparent, and for the purposes of this definition a person who lives with another person as a spouse, although not legally married to that other person,

shall be deemed to be related to that other person in the same manner as he would be if he were married to that other person.

- (3) Nothing in this rule shall be deemed to limit or restrict any duty or obligation of a solicitor which otherwise exists.
- 9. (1) A solicitor shall comply with any personal undertaking which he has given—
 - (a) in the course of or in connection with his practice;
 - (b) to the Council; or
 - (c) to the Secretary.
- (2) For the purpose of paragraph (a) of sub-rule (1) an undertaking given by an employee of a solicitor on behalf of the solicitor shall be deemed to be a personal undertaking by that solicitor.

Whereas by section 77 of the Legal Profession Practice Act 1958 it is provided that no accountant or other person employed or appointed to make an audit or examination of any accounts of a solicitor or firm of solicitors for the purposes of Part V of that Act shall (otherwise than as is prescribed or pursuant to the provisions of that Act) communicate any matter of which he is informed or which comes to his knowledge in the course of such audit or examination to any person except in the course of his report:

Now therefore, the Council of the Law Institute of Victoria, pursuant to section 88 of the Legal Profession Practice Act 1958 and of all other powers thereunto enabling, hereby makes the following rules:

- 1. These Rules may be cited as the "Auditors (Disclosure of Information) Rules 1984" and shall come into operation on the date of their publication in the Victoria Government Gazette.
- 2. An accountant or other person employed or appointed to make an audit or examination of any accounts of a solicitor or firm of solicitors for the purposes of the Legal Profession Practice Act 1958, may communicate any matter of which he is informed or which comes to his knowledge in the course of such audit or examination to—
 - (a) any Court or person acting judically within the meaning of the Evidence Act 1958;
 - (b) the Solicitors' Disciplinary Tribunal;
 - (c) the Secretary or any solicitor or counsel instructed by the Law Institute of Victoria or the Crown Solicitor of the State of Victoria or any counsel appearing on behalf of the Crown in right of the said State in relation to any proceedings, inquiry, or other matter pending or contemplated before any of the bodies or persons herein mentioned arising out of the audit or examination or otherwise in relation to the trust accounts of the said solicitor;
 - (d) any accountancy institute or organization or any duly appointed tribunal investigating the conduct of an auditor arising out of a report referred to such institute or organization by the Council or any counsel or solicitor appearing or instructed to appear before or advising such institute, organization or tribunal in relation to any such investigation;
 - (e) the solicitor or any member of the firm of solicitors whose accounts such accountant or other person has been employed or appointed to audit or examine or to any solicitor acting for such solicitor or firm of solicitors;

Legal Profession Practice Act 1958 SOLICITORS (SHARING OF REMUNERATION) RULES 1984

Whereas it is provided by section 94 of the Legal Profession Practice Act 1958 that, except in the cases and subject to the conditions prescribed by rules made under that Act, no solicitor shall share with an unqualified person receipts from his practice or from any business usually carried on by a solicitor in conjunction with his practice:

Now, therefore, the Council of the Law Institute of Victoria, pursuant to section 88 of the Legal Profession Practice Act 1958 and all other provisions in that behalf enabling, hereby makes the following rules:

- 1. These Rules may be cited as the "Solicitors (Sharing of Remuneration) Rules 1984" and shall come into operation on the date of their publication in the Victoria Government Gazette.
- 2. In these Rules unless inconsistent with the context or subject matter--
 - "Child" includes a person adopted by a solicitor and legally dependent on him, and a person to whom the solicitor stands in loco parentis.
 - "legal work" includes any work performed by a solicitor in the course of or in connection with any business usually carried on by the solicitor in conjunction with his practice.
 - "retired practitioner" includes a practitioner who on account of illness or for any other reason which the Council of the Institute deems sufficient is no longer engaged in practice as a solicitor.
 - "spouse" includes a person who lives with the solicitor as a spouse on a permanent and bona fide domestic basis, although not legally married to him.
- 3. A solicitor may share with any unqualified person receipts from his practice or from any business usually carried on by that solicitor in conjunction with his practice in the following cases:
 - (a) He may pay an annuity or other sum whether by way of a proportionate share or otherwise out of profits to a retired practitioner or to the dependents or legal personal representatives of a deceased practitioner;
 - (b) He may pay to a practitioner who is a member of the Defence Force of the Commonwealth of Australia and is thereby prevented from personally attending to his practice the whole or any part of any costs or other moneys received by him for legal work performed by him for former clients of that practitioner;
 - (c) Where he carries on practice in the State of Victoria and an adjoining State in partnership with a solicitor of such adjoining State he may share with that solicitor any costs received by him in respect of any legal work performed in the State of Victoria in the course of or in connection with the partnership practice;

- (d) He may share those receipts with the spouse, child or grandchild of the solicitor, or one or more of them, in accordance with an agreement or agreement whereby any one or more of them being the spouse, a child or a grandchild of the solicitor, but not any other person, acquires a beneficial interest in or benefits from a share or a part of those receipts;
- (e) He may share those receipts with a corporation for the time being approved by the Council as being a corporation formed to supervise the conduct of a community-based legal service.








The deviations from an existing road in the Shire of Orbost as shown hatched on plans numbered GP 15363G and GP 15365A hereunder.



INQUIRY INTO PUBLIC SECTOR **SUPERANNUATION**

Whereas section 4F (1) (a) (ii) of the Parliamentary Committees Act 1968 provides (inter alia) that the Governor in Council by Order published in the Government Gazette may refer any proposal, matter or thing relevant to the functions of the Joint Investigatory Economic and Budget Review Committee under the said Act for inquiry consideration and report to the Parliament.

To inquire into, consider and report to Parliament, by 31 October 1984, the question relating to Parliamentarians', Judges', Governors' and other Special Superannuation Schemes ("public sector superannuation") with reference to the following:

- (a) The adequacy of present provisions for the management of all Victorian public sector superannuation schemes, including
 - structure and management of schemes representation of contributors
 - actuarial assessment and valuation
 - reporting to Government and contributors, and contributors' access to information
 - auditing requirements-

in terms of the efficient operations of these funds and the protection of the interests of contributors and the Government.

- (b) Whether uniform provisions for the management of schemes are feasible and desirable, and if so what these might be.
- Whether the existing administration of schemes is efficient and administrative costs are reasonable.
- Whether the current organizational structure of superannuation schemes in the Victorian public sector is the most suitable having regard to
 - differences in the financial independence of various agencies and authorities involved
 - possible benefits from reduction of duplication and economies of scale-
 - any disadvantages from competition between schemes and whether a reduction in the number of separate schemes if feasible and desirable.
- Whether the terms and conditions governing eligibility for membership of various schemes are reasonable in comparison with other schemes in Australia and whether these terms and conditions are equitable between different employees.
- (f) The appropriateness of the current benefits, having regard to:
 - (i) the needs of contributors, superannuants and beneficiaries:
 - (ii) comparable benefits for public sector employees in other States and in the Commonwealth Government and those prevailing in the private sector, also having regard to any differences in salary packages and to the role of superannuation in the recruitment and retention of Victorian Government employees;
 - (iii) vesting and including the reasonableness of provisions governing breaks in service, resignation, early retirement, ill-health retirement, retrenchment and redundancy.
- (g) The adequacy of portability and preservation arrangements between schemes, and between them and other Australian superannuation schemes.
- (h) The suitability of the present basis of Government funding of the various schemes including the funding of administrative costs, and the future financial implications for Government of existing basis of funding.
- Whether the existing investment powers and pattern of investments of these schemes is optimal from the point of view of contributors and of the Government; and whether existing arrangements provide the most efficient mechanism for maximizing the investment income of the schemes.
- (j) Future options for public sector superannuation, including new relationships between public sector and private sector superannuation schemes.
- (k) The adequacy of the existing legislative and regulatory framework for the operation of schemes and the appropriate legislative framework for any recommended changes in the structure and operation of schemes


