Fire Authorities Act 1984 DATE OF COMING INTO OPERATION

PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

Whereas by an Act of Parliament of the State of Victoria passed in the thirty-third year of the reign of Her Majesty Elizabeth the Second, Queen of Australia, entitled the Fire Authorities Act 1984 it is amongst other things enacted that the several provisions of the said Act shall come into operation on the day or respective days to be fixed by proclamation or successive proclamations of the Governor in Council published in the Government Gazette.

Now therefore I, the Governor of the State of Victoria, in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State, do by this my Proclamation fix, Tuesday, 13 November 1984 as the day on which sections 1-3, 5, 7-9, 11, 12 and 22-25 of the Fire Authorities Act 1984 shall come into operation.
