PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

WHEREAS BY PROCLAMATION published in the *Government Gazette* on 16 October 1984, the Governor in Council divided the 22 Electoral Provinces for the Legislative Council and the 88 Electoral Districts for the Legislative Assembly into the subdivisions named in conjunction with each Electoral Province and Electoral District as set forth in Part I. of the Schedule thereto and specified the boundaries of those subdivisions as set forth in Part II. of that Schedule.

AND WHEREAS an error was made in specifying the boundaries of the subdivision of Gong Gong (Ballarat Province) (Electoral District of Ballarat South) and of the subdivision of Woorndoo (Western Province) (Electoral District of Warrnambool).

NOW THEREFORE I, the Governor of the State of Victoria, by and with the advice of the Executive Council and in pursuance of the powers conferred by Section 27 of the *Constitution Act 1975* do by this my proclamation specify the boundaries of the subdivision of Gong Gong (Ballarat Province) (Electoral District of Ballarat South) and the boundaries of the subdivision of Woorndoo (Western Province) (Electoral District of Warrnambool) as the boundaries set forth in the Schedule hereto.

SCHEDULE

SUBDIVISION OF GONG GONG (BALLARAT PROVINCE)

(ELECTORAL DISTRICT OF BALLARAT SOUTH)

Commencing at the south-western angle of allotment 10, section 24, Parish of Warrenheip, being a point on the southern boundary of the Shire of Bungaree; thence generally north-easterly, north-westerly and south-westerly by the southern, eastern and northern boundaries of that shire to the north-eastern angle of allotment 4, section 5, Parish of Dean; thence further south-westerly by a road to the south-eastern angle of allotment 2L; thence northerly by the eastern boundaries of that allotment and allotments 2K and 2J to the northern boundary of the Shire of Bungaree; thence generally westerly by that boundary to the road forming the western boundary of allotment 1B, section 23, Parish of Bungaree; thence southerly by that road to the southern boundary of allotment 3A, section 4, Parish of Creswick; thence westerly by that boundary and the southern boundary of allotment 3B and northerly by the western boundary of the latter allotments to Slaty Creek; thence south-westerly by that creek to a point in line with the western boundaries of allotment 9; thence generally southerly by a line and the western boundaries of allotments 9 and 11 to the road forming

the southern boundary of the parish; thence westerly by that road to Sawpit Creek; thence south-westerly by that creek to Shuttleworth Road; thence southerly by that road to James Hill Road; thence south-westerly by that road to Codes Forest Road; thence southerly by that road to White Swan Road; thence south-easterly by that road to the western boundary of allotment 1, section 5, Parish of Ballarat; thence southerly by the western boundaries of allotments 1 and 2 and easterly by the southern boundaries of the latter allotment and allotment 3 and generally south-westerly by a 30.18 metre road to the northern boundary of allotment 9A; thence westerly and southerly by the northern and western boundaries of that allotment and further southerly by a road to the southern boundary of allotment 9C; thence easterly by the southern boundaries of allotments 9C, 8B and 8C to Gong Gong Creek; thence south-westerly by that creek and the Yarrowee River to the northern boundary of the City of Ballarat; and thence easterly and southerly by the northern and eastern boundaries of the City of Ballarat to the point of commencement.

SUBDIVISION OF WOORNDOO (WESTERN PROVINCE)

(ELECTORAL DISTRICT OF WARRNAMBOOL)

Commencing at the south-eastern angle of the Parish of Darlington; thence generally westerly by the southern boundaries of the Parishes of Darlington, Darlington West, Toorak and Hexham East to the Hopkins River; thence generally northerly by that river to the northern boundary of the Shire of Mortlake; thence easterly and southerly by the northern and eastern boundaries of that shire to the road forming the northern boundary of allotment 6AA, section 11, Parish of Jellalabad; thence easterly by that road, and the road forming the northern boundary of allotment 6AB, to the eastern angle of that allotment; thence south-westerly by a road to the road forming the eastern boundary of allotment 5AA; thence southerly by that road, a line, a road and a line to a point in line with the southern boundary of allotment 2, section 17, Parish of Darlington; thence westerly by a line to the south-eastern angle of that allotment; and thence south-easterly by a road to the point of commencement.

Given under my Hand and the Seal of the State of Victoria aforesaid, at Melbourne, this twentieth day of November in the year of our Lord One thousand nine hundred and eighty-four and in the thirty-third year of the reign of Her Majesty Queen Elizabeth the Second, Queen of Australia.
