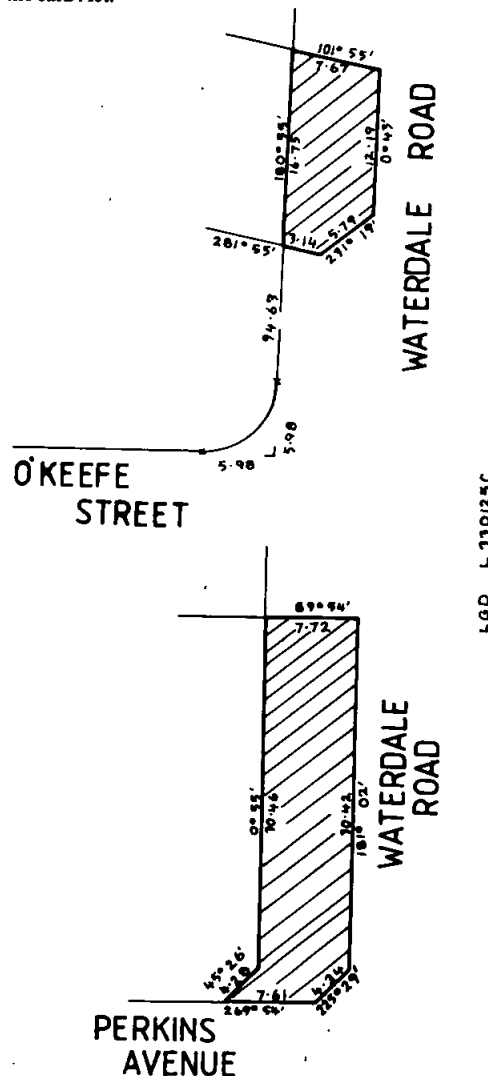
# PROCLAMATION

By His Excellency the Governor of the State of Victoria and  
its Dependencies in the Commonwealth of Australia, &c.,  
&c., &c.

Whereas by the *Local Government Act* 1958, section 519 it is amongst other things enacted that it shall be lawful for the Governor in Council at any time and from time to time upon the request of the council of any municipality by notice in the *Government Gazette* to proclaim any land reserved used or by purchase or exchange acquired for a street road highway thoroughfare bridge square court alley or right-of-way or any street road lane or passage made or laid out or proposed to be made or laid out on any land of which a plan of subdivision delineating that street road lane or passage has been sealed with the seal of the municipality under subdivision (3) of Division 9 of Part XIX of the *Local Government Act* 1958 or a corresponding previous enactment to be a public highway and that such land shall thereupon and thenceforth from the date of such proclamation become and be absolutely dedicated to the public as a public highway within the meaning of any law then or thereafter in force.

And whereas the Council of the City of Heidelberg has requested that the land hereinafter mentioned, acquired for a road, be so declared to be a public highway.

Now therefore I, the Governor of the State of Victoria in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State, do by this proclamation declare that the land shown by hatching on the plan hereunder shall be a public highway within the meaning of the said Act.

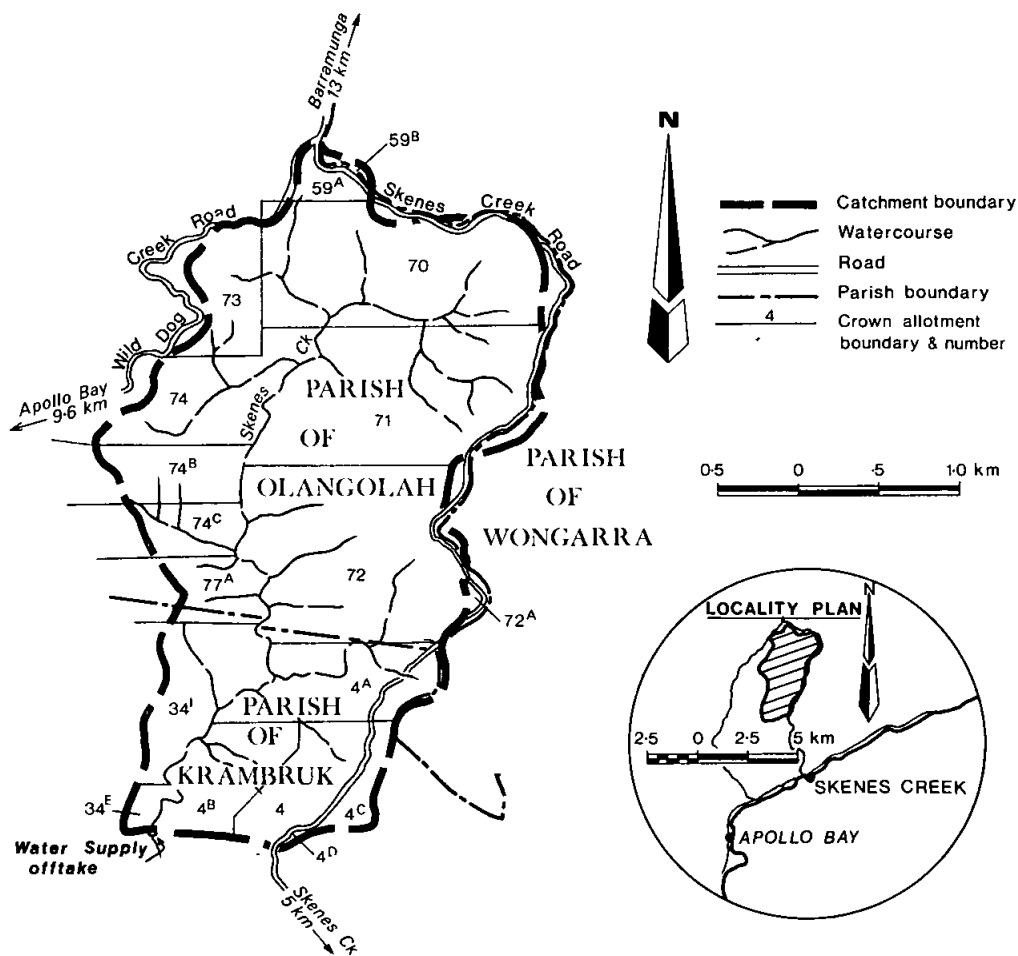
Proclaimed 23 December 1981, *Victoria Government Gazette* No. 3 dated 7 January 1981 pursuant to section 22 (1) of the *Soil Conservation and Land Utilization Act 1958*.

In pursuance of the provisions of section 23, sub-section (1) of the *Soil Conservation and Land Utilization Act 1958*, the Soil Conservation Authority, after consultation with the Land Conservation Council, has determined the land use for all that land in the Parishes of Olangolah, Krambruk and Wongarra within the boundaries of the Skenes Creek Water Supply Catchment delineated and marked on Plan No. S-927.

The area concerned is shown on the plan below. All land within this area shall be used in accordance with the particular category of land use to which it has been assigned in the Land Use Determination.

The boundaries of the land use categories are shown on Plan No. S-1311 and are intended as a guide to persons and public authorities involved in land use and management in the area, who should consult the Soil Conservation Authority before making any changes in land use.

The text and plan of the Land Use Determination (Plan No. S-1311) may be viewed at or obtained from the offices of the Soil Conservation Authority at Kew and Colac. Landowners and relevant public authorities will be advised by letter.



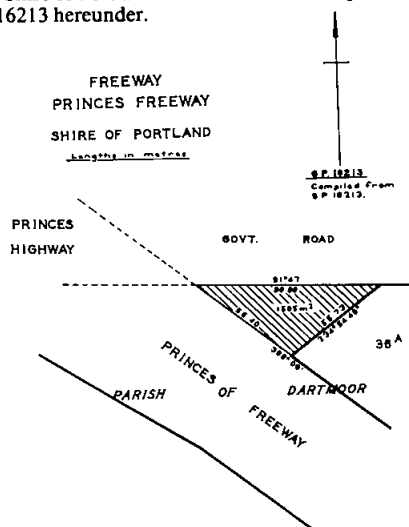
