Town and Country Planning Act 1961 GEELONG REGIONAL PLANNING SCHEME

Amendment No. 111
Notice of Amendment

In pursuance of the powers conferred by the *Town and Country Planning Act* 1961, the Governor in Council on 12 December 1984, amended the abovementioned scheme in respect of the municipal district of the City of Geelong and for which the Geelong Regional Commission is the Responsible Authority.

The amendment comes into operation on the date this Notice is published in the Government Gazette.

The amendment designates a Service Business Zone located on the north bank of the Barwon River and bounded by Hopkins and Little Fyans Streets, Geelong South as 'land liable to flooding' which was inadvertently omitted when Amendment No. 41 was approved.

Town and Country Planning Act 1961 MELBOURNE METROPOLITAN PLANNING SCHEME Amendment No. 327

Notice of Amendment

In pursuance of the powers conferred by the *Town and Country Planning Act* 1961, the Governor in Council on 12 December 1984, amended the abovementioned scheme in respect of the municipal district of the Cities of Berwick and Footscray and for which the Melbourne and Metropolitan Board of Works is the Responsible Authority.

Town and Country Planning Act 1961 MELBOURNE METROPOLITAN PLANNING SCHEME Amendment No. 280, Part 1 Notice of Approval
