WORKERS COMPENSATION (PARTICULARS OF CLAIM)
REGULATIONS 1984

At Government House, Melbourne, the twenty-first day of December 1984 PRESENT:

His Excellency the Governor of Victoria
Mr Simpson Mr Cathie

IN PURSUANCE of the powers conferred by section 73 of the Workers Compensation Act 1958, and all other powers him thereunto enabling, His Excellency the Governor of the State of Victoria, by and with the advice of the Executive Council thereof, hereby makes the following Regulations, that is to say:

1. These Regulations may be cited as the Workers Compensation (Particulars of Claim) Regulations 1984 and shall come into operation on 1 January 1985.

- 2. In these Regulations the Workers Compensation Regulations 1975* are called the Principal Regulations.
- 3. In Regulation 103 of the Principal Regulations after the expression 'Part III. Accident Insurance Business. Regulations 301-313.' there shall be inserted the expression 'Part IV. Particulars of claim. Regulation 401.'.
- 4. After Regulation 313 of the Principal Regulations there shall be inserted the following heading and Regulation:

'PART IV'

Particulars of Claim: Clause 5A (1) (b) of The Clauses Referred To in section 9 of the Act

- '401. The particulars of claim to be provided with a claim for compensation by a worker pursuant to Clause 5A (1) (b) of *The Clauses Referred To* in section 9 of the Act are—
 - (a) the name, residential address and date of birth of the worker:
 - (b) the nature and alleged cause of the injury in respect of which the claim is made and the place where and the date on which that injury happened;
 - (c) the date of commencment of the incapacity for work which resulted from or was materially contributed to by that injury where this date is different from the date of the injury; and
 - (d) the name and residential address of all persons who are in relation to the worker a wife, husband, relative or child who is wholly or mainly dependent on the earnings of the worker within the meaning of Clause 1 (b) (i) of The Clauses Referred To in section 9 of the Act specifying the nature of the relationship to the worker of each person so named and the date of birth of each child so named.'

And the Honourable Robert Allen Jolly, Her Majesty's Treasurer for the State of Victoria, shall give the necessary directions herein accordingly.
