MAGISTRATES (SUMMARY PROCEEDINGS) ACT 1975,  
No. 8731

## PROCLAMATION

By His Excellency the Governor of the State of Victoria  
and its Dependencies in the Commonwealth of Australia,  
&c., &c., &c.

Whereas:

I. By the *Magistrates (Summary Proceedings) Act 1975* (the said Act), section 88, it is provided, *inter alia*, that the Governor in Council may by Proclamation published in the *Government Gazette* declare as many Magistrates' Courts as he thinks necessary within the "metropolitan area" within the meaning of the *Town and Country Planning Act 1961* to be and to be known as "traffic courts" for the hearing or determination of matters brought by the alternative procedure under Part VII. of the said Act by members of the Police Force in respect of offences referred to in Schedule Two of the said Act.

II. A Proclamation made under the said section 88 may, *inter alia*, proclaim any Magistrates' Court to be a traffic court exclusively for the hearing or determination of such matters and revoke or vary any Proclamation made under any of the provisions of that section in force before the commencement of the *Magistrates (Summary Proceedings) (Amendment) Act 1981*.

III. It is provided in section 89 of the said Act that a Proclamation made under section 88 may proclaim a traffic court within the meaning of that section to be the appropriate court for the hearing of matters arising within the municipal districts of the municipalities specified in the Proclamation in relation to that court.

Now therefore I, the Lieutenant-Governor as Deputy for the Governor of the State of Victoria, by and with the advice of the Executive Council thereof, do by this my Proclamation—

(1) vary the Proclamation made by the Governor in Council on 9 December 1980 and published in the *Government Gazette* on 10 December 1980 by revoking those parts thereof which did—

(a) set aside absolutely the Magistrates' Court at Elsternwick for the hearing or determination from 1 January 1981 of matters brought by the alternative procedure by members of the Mobile Traffic Branch of the Victoria Police Force in respect of offences referred to in Schedule Two to the said Act; and

(b) proclaim the Magistrates' Court at Elsternwick for the hearing or determination of matters which may be dealt with by the alternative procedure to be the appropriate court for the hearing of matters arising within the respective municipal districts of the municipalities of Berwick, Brighton, Caulfield, Chelsea, Dandenong, Frankston, Malvern, Moorabbin, Mordialloc, Oakleigh, Prahran, Sandringham, Springvale, St. Kilda and Waverley; and

(2) proclaim the Magistrates' Court at Elsternwick to be a traffic court exclusively for the hearing or determination of matters brought by the alternative procedure under Part VII of the said Act by members of the Police Force in respect of offences referred to in Schedule Two to the said Act; and

(3) proclaim the said traffic court at Elsternwick to be the appropriate court for the hearing of matters arising within the respective municipal districts of the municipalities specified in the schedule hereto.
