Electoral Commission Act 1982

NAMES AND BOUNDARIES OF ELECTORAL PROVINCES FOR THE LEGISLATIVE COUNCIL AND NAMES AND BOUNDARIES OF ELECTORAL DISTRICTS FOR THE LEGISLATIVE ASSEMBLY.

Notice having been given pursuant to Section 13 of the *Electoral Commission Act 1982*, that a copy of the statement, particulars, and maps, prepared by the Electoral Commissioners showing their electoral division and forwarded to the Honourable the Minister for Property and Services has been deposited in the Central Plan Office, now therefore I, the Chief Electoral Officer, publish hereunder, pursuant to Sections 14 and 15 of the *Electoral Commission Act 1982*, the names and boundaries of the electoral provinces for the Legislative Council and the names and boundaries of the electoral districts for the Legislative Assembly as set forth in the said statement of the Electoral Commissioners.

TECHNICAL DESCRIPTIONS

In the following descriptions, wherever the boundary described runs along a river, creek, road, or street, the centre of such river, creek, road or street shall be taken to be the boundary line; and wherever the boundary is described as by a mountain range or watershed, the line following the highest part of such range or watershed shall be taken to be the boundary.

Where any boundary of a municipal district or portion of a municipal district is specified in these descriptions, it shall be taken to be the boundary existing on the 1st February, 1984.

LEGISLATIVE COUNCIL

NAMES AND BOUNDARIES OF THE TWENTY-TWO ELECTORAL PROVINCES

BALLARAT PROVINCE

Commencing on the Serra Range where the southern boundary of the Parish of Nekeeya abuts thereon; thence easterly by the southern boundary of the Parish of Nekeeya and northerly by the road forming the western boundary of the Parish of Kalymna to the north-western angle of allotment 11A of the last-named parish; thence easterly by a road to the north-eastern angle of allotment 3, Section A (Burru-beep Estate); thence south-easterly and northerly by roads to the north-western angle of allotment 8, Section A Parish of Merrybuela; thence easterly by a road to the Hopkins River and generally south-westerly by that river to the northern boundary of the Parish of Wickliffe South; thence generally westerly and southerly by that boundary to Back Creek; thence generally southerly by Back Creek to the northern boundary of the Shire of Mortlake; thence generally easterly by that boundary and Mount Emu Creek to the northern boundary of the Parish of Argyle; thence generally easterly, northerly and easterly by the last-mentioned boundary and further easterly by the northern boundary of the Parish of Scarsdale to the western boundary of allotment 1, Section 32B, Parish of Carngham; thence northerly by that boundary and the western boundary of allotment 2 and south-easterly by Tanerly Road and Hillcrest Road to the northern boundary of the Parish of Scarsdale; thence north-easterly, south-easterly and southerly by that parish boundary to the south-eastern angle of that parish; thence southerly by a direct line to the north-eastern boundary of allotment 3A, Section B, Parish of Lynchfield; thence south-easterly by the boundaries of that allotment and allotment 2 to the south-eastern angle of the last-mentioned allotment; thence south-easterly by a direct line to the north-eastern angle of allotment 1A, Section C; thence southerly by the eastern boundaries of that allotment and allotment 1B and a line to the western boundary of allotment 13, Section D; thence south-westerly by a road to the southern boundary of the Parish of Lynchfield; thence generally easterly by that boundary and the southern boundary of the Parish of Enfield to the Leigh River; thence south-easterly by that river to the southern boundary of the Parish of Bamganie; thence easterly by that boundary to the most western angle of allotment 7J, Parish of Coolebarghurk; thence further easterly by a line through that allotment to its eastern boundary; thence northerly and easterly by the southern boundary of the last-named parish to the Moorabool River; thence north-westerly by that river to the southern boundary of the Parish of Durdidwarrah; thence easterly by the southern boundaries of the Parishes of Durdidwarrah, Anakie and Lara to the road forming the northern boundary of allotment 66, Parish of Lara; thence south-easterly by that road and easterly by the road forming the northern boundary of allotment 1A, Parish of Lara to Hovell Creek; thence easterly by the northern boundary of allotment 1A, Parish of Wurdie-Youang, the road forming the northern boundary of allot-

ment 3, Section B and a line to the Geelong and Melbourne Railway; thence north-easterly by that railway to the Little River; thence generally north-westerly by that river to its junction with Balliang Creek; thence further north-westerly by Balliang Creek to the Geelong-Bacchus Marsh Road; thence north-easterly by that road to Davis Lane; thence westerly by that lane to the Balliang Creek; thence generally northerly by that creek to the southern boundary of the Parish of Parwan; thence generally easterly by that boundary to the road forming the eastern boundary of the parish; thence northerly by that road, Davis Road, Norton Road and a line to the Werribee River; thence generally easterly by that river to the Djerriwarrah Creek; thence generally northerly by that creek to the northern boundary of the Parish of Djerriwarrah; thence easterly by the northern boundaries of the Parishes of Djerriwarrah and Kororoit, Holden Road and the northern boundary of the City of Keilor to Jacksons Creek; thence generally easterly by that creek to its junction with Deep Creek; thence generally northerly by that creek to Konagadder Creek; thence generally north-westerly by that creek to the northern boundary of the Parish of Bollinda; thence westerly by that boundary to the eastern boundary of the Parish of Havelock; thence northerly by that boundary to the road forming the southern boundary of Murphy's Station Pre-emptive Right; thence westerly and north-westerly by that road to Heath Lane; thence westerly by Heath Lane, a line and Sutherlands Road to Bollinda Creek; thence generally north-westerly by that creek to the Heskett-Kerrie Road; thence north-westerly by that road to the road forming the south-eastern boundary of allotment 112 Parish of Rochford; thence south-westerly by that road to the southern boundary of that parish; thence north-westerly by that boundary to the western boundary of the Shire of Romsey; thence generally northerly by that shire boundary to the south-eastern boundary of the Shire of Kyneton; thence generally easterly by that boundary and generally northerly by the eastern boundary of that shire to the southern boundary of the Shire of McIvor; thence north-easterly by that boundary to the western boundary of the Eastern Riding of the Shire of McIvor; thence generally northerly, easterly, northerly and north-westerly by that riding boundary to Wild Duck Creek; thence generally north-westerly by that creek to the southern boundary of the Parish of Langwornor; thence westerly by that boundary to the eastern boundary of allotment 5M, Section 7, Parish of Langwornor; thence northerly, westerly and south-easterly by the boundaries of the said allotment to the southern boundary of the Parish of Langwornor; thence generally westerly by that boundary to the eastern boundary of the Parish of Redesdale; thence northerly by that boundary and generally westerly by the northern boundaries of the Parishes of Redesdale, Hawkestone and Sutton Grange to the eastern boundary of the Parish of Ravenswood; thence southerly by that boundary to the Coliban Main Channel; thence generally southerly by that channel to the Calder Highway; thence

north-westerly by that highway to the eastern boundary of the Chewton Riding, Shire of Metcalfe; thence southerly by that boundary to the Melbourne to Castlemaine Railway; thence south-easterly by that railway to the eastern boundary of the Parish of Chewton; thence southerly by that boundary and the eastern boundary of the Parish of Fryers to the southern boundary of the latter named parish; thence westerly by that boundary and northerly by the western boundary of that parish to the southern boundary of the Parish of Guildford; thence westerly by the southern boundaries of the Parishes of Guildford and Strangways to the eastern boundary of the Parish of Sandon at the north-eastern angle of allotment 2, Section 6 in that parish; thence southerly by that boundary to the road forming the northern boundary of allotment 29D, Section 3; thence westerly by that road to the north-western angle of that allotment; thence southerly by a road to the northern boundary of the Parish of Campbelltown; thence easterly and southerly by the northern and eastern boundaries of that parish to the McLachlan Creek; thence generally north-westerly and northerly by that creek and the Joyces Creek to the road forming the northern boundary of allotment 16 (Glengower Estate), Parish of Rodborough; thence westerly by that road, northerly and westerly by the road forming the northern boundary of allotment 15 to the north-western angle of the said allotment; thence north-westerly by a road to the north-eastern angle of allotment 2, Section 11, in the last-named parish; thence westerly by a road and the northern boundaries of allotments 2, 2A and 2B, Section 5, to the Tullaroop Creek; thence southerly by that creek to the northern boundary of allotment 11, Section 5, Parish of Craigie; thence westerly by that boundary to the north-western angle of the said allotment; thence northerly by a road to the north-eastern angle of allotment 7, Section 8; thence westerly by a road and the northern boundaries of allotments 13 and 14, Section 2, to the north-western angle of the latter allotment; thence northerly by a road to the most northern angle of allotment 49, Section 1 and further northerly by a line and the western boundary of allotment 47J to the northern boundary of allotment 74; thence westerly by that boundary to the eastern boundary of allotment 74A; thence north-westerly by that boundary and easterly and northerly by the southern and eastern boundaries of allotment 74B to the south-western boundary of the land temporarily reserved for Public Recreation by Order in Council of 20 July 1885; thence south-easterly, north-easterly and north-westerly by the western, southern and eastern boundaries of that reserve and northerly by a road to the southern angle of allotment 16, Section A; thence north-easterly and north-westerly by the southern and eastern boundaries of that allotment to its northern angle and northerly by a line to the northern boundary of the last-named parish; thence easterly by that boundary to the western boundary of the Parish of Carisbrook; thence generally northerly by that boundary and easterly by the northern boundary of the said parish to the Tullaroop Creek; thence northerly by that creek to the Loddon River; thence north-westerly by that river to the Bet Bet Creek; thence south-westerly by that creek to the south-eastern angle of allotment 41, Section 2, Parish of Bet Bet; thence northerly and westerly by the northern boundary of the said parish to the north-western angle of allotment 2, Section 3B; thence south-westerly by the Avoca and Dunolly road to the most southern angle of allotment 11, Section A, Parish of Natteyallock; thence north-westerly, south-westerly and westerly by the southern boundary of the parish to the south-western angle of allotment 14, Section 4; thence southerly by a road to the south-eastern angle of allotment 12; thence westerly by a road to the eastern boundary of allotment 3A, Section 1; thence southerly and westerly by the eastern and southern boundaries of that allotment to the south-western angle thereof; thence northerly by a road to the south-eastern angle of allotment 7A; thence westerly by a road and a line to the

Avoca River; thence generally northerly by that river to the southern boundary of the Shire of Charlton; thence westerly by that boundary to the eastern boundary of the Parish of Donald; thence southerly by that boundary to the southern boundary of the Parish of Donald; thence generally westerly by that boundary to the Richardson River; thence generally south-westerly and south-easterly by that river to a point in line with the western boundary of allotment 191, Parish of Wirchilleba; thence southerly by a line and the western boundary of that allotment to the southern boundary of the said parish; thence westerly by the southern boundaries of the Parishes of Wirchilleba and Marma to the Wimmera River, which forms part of the eastern boundary of the Shire of Wimmera; and thence generally southerly by that shire boundary and further southerly by the Serra Range to the point of commencement.

BORONIA PROVINCE

Commencing at the intersection of Blackburn Road and Canterbury Road; thence generally easterly by Canterbury Road to Heatherdale Road; thence southerly by that road and a line to Dandenong Creek; thence generally easterly by that creek and the northern boundary of the Parish of Scoresby to the eastern boundary of the City of Knox; thence generally south-westerly by that boundary to the Monbulk Creek; thence generally south-westerly by the Monbulk Creek and Corhanwarrabul Creek to its junction with the Dandenong Creek; thence south-easterly by the Dandenong Creek to a point in line with Police Road; thence westerly by a line and Police Road to the Mulgrave Freeway; thence north-westerly by that freeway to Springvale Road; thence northerly by that road to Coleman Parade; thence westerly by that parade to Kingsway; thence northerly by Kingsway to the Darling to Glen Waverley Railway; thence westerly by that railway to Blackburn Road; and thence northerly by that road to the point of commencement.

CENTRAL HIGHLANDS PROVINCE

Commencing on the Yarra River at a point in line with Coldstream West Road; thence easterly by a line and Coldstream West Road to Edward Road; thence southerly by that road to the Maroondah Highway; thence generally easterly by that highway to Mooroolbark Road; thence southerly, south-westerly and south-easterly by that road to Hull Road; thence north-easterly, easterly and again north-easterly by that road to the Olinda Creek; thence generally southerly by that creek to Swansea Road; thence further southerly by that road to Edinburgh Road; thence generally north-westerly by that road to Belfast Road; thence south-westerly by that road to Cardigan Road; thence westerly, northerly and again westerly by that road to Pembroke Road; thence southerly by that road to Lawson Road; thence south-westerly by that road to Cambridge Road; thence generally north-westerly by that road to Hull Road; thence south-westerly by that road to the eastern boundary of the City of Croydon; thence south-westerly and generally south-easterly and southerly by that boundary to the Dandenong Creek; thence generally easterly by that creek and the northern boundary of the Parish of Scoresby to the eastern boundary of the City of Knox; thence generally south-westerly by that boundary to the Monbulk Creek; thence generally south-easterly and north-easterly by that creek to the Belgrave-Gembrook Road; thence generally easterly by that road to Nation Road; thence generally easterly by that road and the road forming the southern boundary of allotment 5B, section A, Parish of Narree Worran to Johns Road; thence northerly and generally south-easterly by that road and easterly by Black Hill Road to School Road; thence northerly by that road and Grantulla Road to Jacksons Hill Road; thence generally north-easterly by that road

to Ridge Road; thence south-easterly and north-easterly by that road to the eastern boundary of allotment 12, section A Parish of Narree Worran; thence north-easterly by that boundary to the northern boundary of the said parish; thence south-easterly and north-easterly by that parish boundary to the Woori Yallock Creek; thence generally north-easterly by that creek to Cockatoo Creek which forms part of the western boundary of the Shire of Upper Yarra; thence generally southerly by that boundary and generally south-easterly and north-easterly by the southern boundary of that shire to the eastern boundary of the County of Evelyn; thence generally northerly by that county boundary to the Great Dividing Range; thence generally north-easterly by that range to the south-eastern angle of the Parish of Koonika; thence northerly and westerly by the eastern and northern boundaries of that parish to the Dandongadale River; thence generally northerly by that river to a point in line with the south-western boundary of allotment 24 Parish of Matong North; thence north-westerly by a line, the south-western boundary of allotment 24, a line, the south-western boundary of allotment 24A and a line to the Rose River; thence generally north-easterly by that river to the eastern boundary of the Parish of Winteriga; thence generally northerly by that boundary and the eastern boundary of the Parish of Bungamero to the southern boundary of the Parish of Whorouly; thence generally westerly and north-westerly by the southern and western boundaries of that parish to the southern boundary of the Parish of Oxley; thence generally westerly by that boundary and the southern boundary of the Parish of Laceby to the eastern boundary of the Parish of Glenrowen; thence generally southerly, westerly and north-westerly by the eastern, southern and western boundaries of that parish to the shore of Lake Mokoan; thence generally south-westerly and north-westerly by the southern and western shores of that lake to the Mokoan Outlet Channel; thence generally westerly by that channel and the Broken River to a point in line with the road forming the eastern boundary of allotment 17 Parish of Caniambo; thence southerly by a line, that road and Keallys Road to Bells Road; thence westerly by that road to Thorns Road; thence southerly by that road to Cemetery Road; thence westerly by that road to the road forming the western boundary of the Parish of Caniambo; thence southerly by that road to the Murchison-Violet Town Road; thence westerly by that road to the road forming the western boundary of allotment 74 Parish of Molka; thence southerly by that road to the road forming the northern boundary of allotment 81C; thence westerly by that road to the road forming the western boundary of allotment 43A Parish of Dargalong; thence southerly by that road to the road forming the northern boundary of allotment 25B; thence westerly by that road and a line in continuation to the Goulburn River; thence generally westerly and southerly by that river to the road forming the south-western boundary of allotment 1240A Parish of Noorilim; thence north-westerly by that road to the northern boundary of that parish; thence south-westerly and westerly by that boundary and generally westerly by the northern boundaries of the Parishes of Bailieston and Wirrate and southerly by the western boundary of the last named parish to the southern boundary of the County of Rodney; thence generally south-westerly by that boundary to the eastern boundary of the Parish of Costerfield; thence generally south-easterly by that boundary to Splitters Creek; thence generally south-easterly by that creek, and generally easterly by Wappentake Creek to Major Creek; thence generally southerly by that creek to the northern boundary of the Parish of Warrowitue; thence generally westerly by that boundary and generally south-westerly by the western boundary of that parish to the northern boundary of the Parish of Tooborac; thence westerly by that boundary to Wild Duck Creek; thence generally south-easterly by that creek to the western boundary of the Eastern Riding of the Shire of McIvor; thence

generally south-easterly, southerly, westerly and southerly by that boundary to the southern boundary of the Shire of McIvor; thence generally southerly by that boundary to the north-eastern corner of the Shire of Kyneton; thence generally southerly and westerly by the eastern boundary of that shire to the north-western angle of the Shire of Romsey; thence generally southerly by the western boundary of that shire to the southern boundary of the Parish of Rochford; thence south-easterly by that boundary to the road forming the north-western boundary of allotment 115; thence north-easterly by that road to the Hesket-Kerrie Road; thence south-easterly by that road to Bollinda Creek; thence generally south-easterly by that creek to Sutherlands Road; thence easterly by that road, a line and Heath Lane to the road forming the southern boundary of allotment 16B Parish of Havelock; thence south-easterly and easterly by that road to the eastern boundary of that parish; thence southerly by that boundary and easterly by the northern boundary of the Parish of Bollinda to Konagaderra Creek; thence generally south-easterly by that creek and southerly by Deep Creek to a point in line with Somerton Road; thence easterly by a line and Somerton Road to the Hume Highway; thence south-easterly by that highway to Cooper Street; thence easterly by that street, Hendersons Road and a line to the Plenty River; thence generally northerly by that river to a point in line with Worms Lane; thence easterly by a line, Worms Lane and a line to Heard Avenue; thence northerly by that avenue and Yan Yean Road to Bannons Lane; thence generally north-easterly by Bannons Lane to Haleys Gully Road; thence generally south-easterly by that road to the Hurstbridge-Arthurs Creek Road; thence generally southerly by that road to Diamond Creek, being part of the eastern boundary of the Shire of Diamond Valley; thence generally southerly by that boundary to Allendale Road, at Reynolds Road; thence southerly by a line to the junction of Main Road and the southern portion of Reynolds Road; thence southerly by Reynolds Road and a line to the Yarra River; and thence generally north-easterly by that river to the point of commencement.

CHELSEA PROVINCE

Commencing on the shore of Port Phillip Bay at a point in line with Canadian Bay Road; thence generally northerly by the shore of Port Phillip Bay to a point in line with Charman Road; thence northerly by a line and Charman Road to Latrobe Street; thence easterly by that street to the Nepean Highway; thence north-westerly by that highway to Wickham Road; thence easterly by that road to Chesterville Road; thence southerly by that road to Keys Road; thence easterly by that road to Warrigal Road; thence southerly by that road to Kingston Road; thence easterly by that road to Boundary Road; thence generally southerly by that road to Lower Dandenong Road; thence easterly by that road, Cheltenham Road and Kirkham Road to the Frankston-Dandenong Road; thence generally southerly and south-westerly by that road to Thompsons Road; thence easterly by that road to McCormicks Road; thence southerly by that road to Ballarto Road; thence westerly by that road 700 metres, more or less, to the former eastern boundary of the City of Frankston; thence southerly by that boundary, McClelland Drive and Fultons Road to the Baxter-Tooradin Road; thence westerly by that road to the Baxter to Mornington Railway; thence south-westerly by that railway to Moorooduc Road; thence northerly by that road to the south-western boundary of the City of Frankston; and thence generally north-westerly by that boundary, Canadian Bay Road and a line to the point of commencement.

DOUTTA GALLA PROVINCE

Commencing at the junction of Ashley Street and the Western Highway; thence westerly by that highway to Ander-

son Road; thence southerly by Anderson Road to the Footscray to Bacchus Marsh Railway; thence westerly by that railway to the 220 kV Keilor to Brooklyn S.E.C. Transmission line; thence southerly by that transmission line to Boundary Road; thence westerly by that road and a line to the Werribee River; thence generally north-westerly by that river to the Djerriwarrh Creek; thence generally northerly by that creek to the northern boundary of the Parish of Djerriwarrh; thence easterly by the northern boundaries of the Parishes of Djerriwarrh and Kororoit, Holden Road and the northern boundary of the City of Keilor to Jacksons Creek; thence generally easterly by that creek to its junction with Deep Creek; thence generally northerly by that creek to a point in line with Somerton Road; thence easterly by a line and Somerton Road to the North Eastern Railway; thence generally southerly by that railway to the Thomas-town-Keilor 220 kV S.E.C. Transmission Line; thence south-westerly by that transmission line to the Moonee Ponds Creek; thence generally south-westerly by that creek to the Albion to Broadmeadows Railway; thence south-westerly by that railway to the eastern boundary of the City of Keilor; thence south-easterly by that boundary to a point in line with Nomad Road; thence southerly by a line, Nomad Road, a line and Treadwell Road to Keilor Road; thence south-easterly by that road to Roberts Street; thence southerly by that street to Buckley Street; thence westerly by that street to Steele Creek; thence generally southerly by that creek to the Maribyrnong River; thence generally south-westerly by that river to a point in line with Ashley Street; and thence southerly by a line and Ashley Street to the point of commencement.

EAST YARRA PROVINCE

Commencing at the junction of Station Street with High-bury Road; thence westerly by Highbury Road to Warrigal Road; thence southerly by that road to Gardiners Creek; thence generally north-westerly by that creek to the Yarra River; thence generally north-westerly and north-easterly by that river to the Koonung Koonung Creek; thence generally south-easterly by that creek to Elgar Road; thence southerly by that road to Canterbury Road; thence easterly by that road to Station Street; thence southerly by that street to Riversdale Road; thence easterly by that road to Station Street; and thence southerly by that street to the point of commencement.

EUMEMMERRING PROVINCE

Commencing on the eastern boundary of the Narre Warren Ward, City of Berwick at the northern boundary of the City of Berwick; thence generally southerly by that ward boundary and the Berwick Town Drain to Greaves Road; thence westerly by that road to Pound Road; thence north-westerly by that road to the Narre Warren-Cranbourne Road; thence southerly by that road to the southern boundary of the City of Berwick; thence westerly by that boundary and the northern boundary of the Parish of Lyndhurst to Evans Road; thence southerly by that road to Thompson Road; thence westerly by that road to the Frankston-Dandenong Road; thence north-easterly and generally northerly by that road to Kirkham Road; thence westerly by that road, Cheltenham Road and Lower Dandenong Road to Boundary Road; thence generally northerly by that road to Kingston Road; thence easterly by that road to Clayton Road; thence northerly by that road to Fairbank Road; thence easterly by that road to Westall Road; thence generally northerly by that road to Centre Road; thence easterly by that road to Springvale Road; thence northerly by that road to the Mulgrave Freeway; thence south-easterly by that freeway to Police Road; thence easterly by that road and a line to the Dandenong Creek; thence north-westerly by that creek to its junction with the Corhanwarrabul Creek; thence north-easterly by that

creek and the Monbulk Creek to the western boundary of the Shire of Sherbrooke; thence south-westerly, south-easterly and southerly by that boundary to the northern boundary of the City of Berwick; and thence generally easterly by that boundary to the point of commencement.

GEELONG PROVINCE

Commencing on the shore of Port Phillip Bay at the mouth of the Little River; thence generally north-westerly by that river to the Geelong-Melbourne Railway; thence south-westerly by that railway to the northern boundary of allotment 10, section B, Parish of Wurdi-Youang; thence westerly by a road, the northern boundary of allotment 1A and a road to the East Branch of the Sutherland Creek; thence southerly by that branch and the Sutherland Creek to the road forming the northern boundary of allotment A, section 3, Parish of Darriwil; thence westerly by that road to the western boundary of allotment A, section 4; thence southerly by that boundary to the Moorabool River, and generally south-westerly by that river to the western boundary of the Parish of Gherineghap; thence southerly by that boundary to the Barwon River which forms part of the northern boundary of the Shire of Barrabool; thence generally westerly by that boundary and generally southerly by the western boundary of that shire to the north-western angle of allotment 7, section 3 Parish of Lorne; thence easterly by the northern boundary of that allotment to Reedy Creek; thence generally south-easterly by that creek to the shore of Bass Strait; and thence generally north-easterly, westerly and again north-easterly by the shores of Bass Strait, Port Phillip Bay, Corio Bay and Port Phillip Bay to the point of commencement.

GIPPSLAND PROVINCE

the City of Sunshine; thence westerly by that city boundary and Mitchell Street to Rosamond Road; thence southerly by that road and Summerhill Road to Barkly Street; thence westerly by that street to Warleigh Road; thence southerly by that road and a line to the Melbourne and Sunshine Railway; thence westerly by that railway to the eastern boundary of the City of Sunshine; thence generally southerly by that city boundary to the West Gate Freeway; thence south-westerly by that freeway to the Kororoit Creek; thence generally north-westerly by that creek to the southern boundary of the City of Sunshine; thence westerly by that city boundary and Boundary Road to the 220 kV Keilor to Brooklyn S.E.C. Transmission Line; thence generally north-westerly and northerly by that transmission line to the Footscray and Bacchus Marsh Railway; thence easterly by that railway to Anderson Road; and thence northerly by that road to the point of commencement.

SWAN HILL DISTRICT
