Regional Water Strategy Plan for the South-Western Region
of Victoria

Stage 1

Augmentation of Geelong's Water Supply to the Year 1995

On 31 July 1984, the Governor in Council requested the Committee to:

- (1) Inquire into and report to Parliament by June 1986 on proposals for the future management of water resources in the "south-western" region of Victoria, covering the Moorabool River, Barwon River, Lake Corangamite, Otway Coast (which includes the Gellibrand River) and Hopkins River basins. The inquiry is to cover all aspects of water resources management, including catchment management, water supply drainage, river management, flood plain management, salinity, groundwater, and wastewater collection, treatment and disposal. The inquiry is to take into account any existing or proposed transfers of water resources into or out of the region, and is to consider the engineering, economic, social and environmental aspects of any proposals; and
- (2) Inquire into and report to Parliament by December 1984 on any proposals for augmenting the water supply system of the Geelong and District Water Board which should be implemented to ensure continuity of supply through to 1995.

The first stage of the Committee's inquiry will be the examination of proposals for augmenting the Geelong and District Water Board's water supply system to ensure continuity of supply to 1995.

The Committee proposes to hold public hearings in relation to these proposals in Geelong and Colac (and other centres as may be necessary) commencing the week beginning 24 September 1984.

The Committee has published a background information paper identifying the available water resources, describing existing water supply systems in the region, setting out forecasts of water requirements and identifying a range of possible schemes to meet the predicted short and medium term water supply needs of Geelong. The Committee invites written submissions relating to the first stage of its inquiry and would appreciate notice from any one who would like to be heard by the Committee during the public hearings in September.

Submissions should reach the Committee by 14 September 1984, and be addressed to the Secretary, Natural Resources and Environment Committee, 7th Floor, 100 Exhibition Street, Melbourne 3000.

The second stage of the Committee's inquiry will commence during 1985 and will deal with the development of a Regional Water Strategy Plan for the South-western Region of Victoria (including Geelong, Ballarat, Colac, Warrnambool and the Otways).

The Regional Water Strategy Plan will consider surface and ground water supplies, effluent disposal, flood plain management, regional drainage, salinity and environment protection.

This second stage of the inquiry will be preceded by the release of a summary paper identifying key management issues and for each issue a series of options.
