PUBLIC HIGHWAY—SHIRE OF WERRIBEE

PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

Whereas by the Local Government Act 1958, section 519 it is amongst other things enacted that it shall be lawful for the Governor in Council at any time and from time to time upon the request of the council of any municipality by notice in the Government Gazette to proclaim any land reserved used or by purchase or exchange acquired for a street road highway thoroughfare bridge square court alley or right-of-way or any street road lane or passage made or laid out or proposed to be made or laid out on any land of which a plan of subdivision delineating that street road lane or passage has been sealed with the seal of the municipality under subdivision (3) of division 9 of Part XIX of the Local Government Act 1958 or a corresponding previous enactment to be a public highway and that such land shall thereupon and thenceforth from the date of such proclamation become and be absolutely dedicated to the public as a public highway within the meaning of any law then or thereafter in force.

And whereas the Council of the Shire of Werribee has requested that the land hereinafter mentioned, used for a road, be so declared to be a public highway.

Now therefore I, the Governor of the State of Victoria in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State, do by this proclamation declare that a road off Synnot Street, Werribee as shown by hatching on the plan hereunder shall be a public highway within the meaning of the said Act.



FIFTEEN MILE CREEK IMPROVEMENT TRUST Rating By-Law No. 20

3746

The Fifteen Mile Creek Improvement Trust, in pursuance and exercise of the powers conferred by the River Improvement Act 1958, doth make the By-Law following:

1. The following rates are to be called the Fifteen Mile Creek Improvement District Improvement Rate, are hereby made, and shall be levied upon the occupiers or owners of all properties within the Fifteen Mile Creek Improvement District which are rateable to the Shire of Benalla:

A rate of one half of a cent in the dollar on the net annual value of all properties in the "A"

- 2. In respect of all those properties within "B" Division, no rate is made or levied for the period beginning with 1 January 1985, and ending with 31 December 1985.
- 3. Provided that in no case shall the amount of rate payable per annum in respect of any property be less than two dollars (\$2.00).
- 4. Such rates are made and shall be levied for the period beginning with 1 January 1985, and ending with 31 December 1985, and shall be payable on 1 January 1985, at the office of the Fifteen Creek Improvement Trust at Moyhu.
- 5. Interest will be charged on all rates remaining unpaid after 30 April 1985, at the prescribed rate.
- 6. Such person or persons as the Fifteen Mile Creek Improvement Trust may from time to time appoint for the purpose shall be authorised to demand, receive, collect and recover the said rate.

- (d) All loans made or the balance of such loans available as at 1 October 1985, to the aforesaid Authority shall be taken over by the Board on

the terms and conditions applying to such loans immediately prior to that date;

- (e) All monies due and payable to the aforesaid Authority as at 1 October 1985, in respect of the provision of sewerage services, shall by this Order, as on and from that date, be due and payable to the Board;
- (f) The officers and employees of the said Authority as at 1 October 1985, shall cease to be officers and employees of the Authority and shall become officers and employees of the Board;
- (g) The districts of the Authority as set forth hereunder, with such boundaries, as apply at 1 October 1985, shall be added to the districts over which the Board has jurisdiction:


