- (iii) offer to the public for subscription or purchase or invite the public to subscribe for or purchase the Prescribed Interests or issue, place or make or cause to be issued, placed or made any advertisement or public announcement in respect of the Prescribed Interests in any communication, document, publication, circular or in the press or other media other than—
 - (a) by means of the Offer Document; or
 - (b) in any notice within the meaning of sub-section 99 (1) of the Code on condition that—
 - 1. the advertising material contains nothing that is not also contained in the registered prospectus or offer document;
 - 2. the advertising is not materially misleading or deceptive or likely to mislead or deceive in the form or context in which it occurs; and

3. any advertising material which the Commissioner for Corporate Affairs for the State of Victoria considers does not meet the above requirements will be withdrawn.

3. The Company and the Representative shall comply with the terms and conditions of the Deed and (unless inconsistent with the terms of the Deed) with provisions of the Code as if the Deed were an approved Deed within the meaning of Division 6 of Part IV of the Code.

4. The total amount to be raised from the public by way of subscription or purchase of the Prescribed Interests shall not exceed the sum of three million dollars (\$3 000 000).

- (1) Building Materials Sales
- (2) Carpet Sales
- (3) Furniture Sales
- (4) Industrial Sales
- (5) Motor Accessory and Tyre Sales

Provisions Applicable to Applications for Use of Development.

- (a) Each application for the use or development of the land for any of the specified uses shall be accompanied by a plan showing—
 - (i) the location, layout, type and design of buildings and works;
 - (ii) the location and extent of vehicle parking area;
 - (iii) the position and width of entrance to and exits from the site;
 - (iv) the number, location, size and form of all advertisements proposed to be erected on the site; and
 - (v) the preservation, planting and maintenance of trees and other landscaping materials.

Conditions of Use/ and/or Development therefore—

- (b) No land or building shall be used or developed or adapted for any of the uses specified above unless accommodation for stationary vehicles is provided on site in conformity with the provisions of Clause 30 of this Ordinance;
