

#### MEDICAL BOARD OF VICTORIA

#### Record of Temporary Medical Registrations as at 31 December 1984

Printed and published under the direction of the Medical Board of Victoria pursuant to the provisions of section 27 of the Medical Practitioners Act 1970.

Section 27 of the Medical Practitioners Act 1970 states, inter alia:

Section 27 (2) enables the Board to apply conditions and limitations when issuing a certificate of temporary registration.

Temporary registrants will in general be required to work either-

- (a) under the general supervision of and within the applicant institution or an officially related institution, or with the approval of the applicant institution within separate institutions of the same standard as the applicant institution.
  - When these conditions are to apply, Class 1 temporary registration may be granted; or
- (b) under the direct supervision of qualified members of the staff of the applicant institution and only within the applicant institution or an officially related institution. If specifically sought by the applicant institution, the Board may grant permission for the registrant to work outside the applicant institution or an officially related institution provided that such work is solely within the practice of the designated qualified member of the staff of the sponsoring institution and under his constant direct supervision. Under these conditions the temporary registrant may not—
  - (i) act as the principal treating doctor in the clinical management of patients;
  - (ii) render accounts except as an assistant to the designated qualified member of the staff of the applicant institution.

When these conditions are to apply to Class II, temporary registration may be granted.

#### Section 27 (3) states:

Every such certificate shall in the first place be issued for a period of not more that two years, but upon application in writing by the governing body of a teaching or research institution during the currency of the certificate the Board may, from time to time, renew the certificate for a further period or periods of not more than one year in respect of each such application, but so that the maximum period for which a certificate may be in force under this section in respect of any person shall not in the aggregate exceed four years.

Section 27 (4) states:

The Board may at any time cancel any certificate issued or renewed under this section and thereupon the certificate shall cease to have any force or effect.

#### REGULATIONS FOR CERTAIN CROWN RESERVES IN THE MUNICIPAL DISTRICT OF THE CITY OF ALTONA

I, Roderick Alexander Mackenzie, Her Majesty's Minister for Conservation, Forests and Lands in and for the State of Victoria in pursuance of the powers conferred on me by section 13 of the Crown Land (Reserves) Act 1978 do hereby make the following Regulations for and with respect to the Crown lands (hereinafter referred to as the "Reserves") stipulated in the schedule hereunder in lieu of all previous Regulations relating thereto, except for the Regulation made on 2 August 1978, which are hereby rescinded.

The Reserves have been placed under the control of the Corporation of the City of Altona as Committee of Management (hereinafter referred to as the "Committee") with full power and authority to enforce these Regulations.

#### **SCHEDULE**

- 1. The land in the Parish of Truganina temporarily reserved for Public Park and Public Recreation purposes by Order in Council of 16 October 1979 (vide Government Gazette dated 24 October 1979) (Rs 10684).
  - (a) The land in the Parish of Truganina permanently reserved for Public Purposes by Order in Council of 28 July 1970 (vide Government Gazette dated 5 August 1970.)
  - (b) The land in the Parish of Truganina temporarily reserved for Public Purposes by Orders in Council of 29 October 1957 and 9 August 1983 (vide Government Gazettes dated 6 November 1957 and 17 August 1983 respectively) (Rs 10264).
- 3. The remaining portion of the land in the Parish of Truganina permanently reserved for Public Recreation purposes by Orders in Council of 6 October 1964 and 13 May 1970 (vide Government Gazettes dated 14 October 1964 and 20 May 1970, respectively) (Rs 7827).
- 4. The remaining portion of the land in the Parish of Truganina temporarily reserved for Public Recreation purposes by Order in Council of 20 March 1973 (vide Government Gazette dated 27 March 1973) (Rs 9726).
- 5. The land in the Parish of Cut-Paw-Paw being Crown allotments B1 and B2 section 3, deemed to be temporarily reserved for Recreation and Public Park purposes—(Rs 12037).

### REGULATIONS Part 1—Definitions

- (a) In these Regulations, unless inconsistent with the context or subject matter:
  - "Authorized Persons" means-
  - (i) A Bailiff of Crown Lands;
  - (ii) An officer or employee of the Committee on duty;
  - (iii) Any member of such Committee;

- (iv) Any person authorized generally or specially by the Committee; or
- (v) A member of the Victoria Police Force. "Secretary" means the Secretary for the time being of the Committee.
- (b) In these Regulations, unless the contrary intention appears, where a word or phrase is given a particular meaning, other parts of speech and grammatical forms of that word or phrase have corresponding meanings.

#### Part 2-Control of Reserves

- 2. The Reserves (other than such portions thereof as are licensed by the Committee to any person, club or association pursuant to the Crown Land (Reserves) Act 1978) shall be open to the public free of charge from sunrise to sunset except upon such days and at such hours as the Committee may by resolution set aside as occasions upon which charges or entrance fees may be collected and received for clubs, associations or persons using or entering into or upon such Reserves.
  - 3. No person shall-
  - (a) enter or remain in the Reserves who may offend against decency as regards dress, language or conduct, or who may behave in a disorderly, unseemly or offensive manner, or create or take part in any disturbance;
  - (b) enter or remain in the Reserves whilst in a state of intoxication;
  - (c) use indecent or offensive language in the Reserves;
  - (d) offer any article of food or drink or any other commodity whatsoever for sale in the Reserves or bring intoxicating liquor thereon without the consent of the Committee first obtained;
  - (e) obstruct, hinder or interfere with any person employed on the Reserves;
  - (f) climb, jump on or get over any of the gates or fences in or around the Reserves, or stick bills or advertisements or cut names thereon, or in any way damage or injure any of the buildings, furniture or fittings, gates, stiles, fences, seats or other structures in the Reserves;
  - (g) interfere with, break or damage in any way any of the trees, shrubs or plants in the Reserves or pluck flowers or destroy or cut grasses therein;
  - (h) leave or deposit any unwanted material or any rubbish whatsoever in the Reserves except in any receptacle provided for the purpose by the Committee;
  - (i) light any fire in the Reserves except at such places as are set apart for the purpose by the Committee;
  - (j) carry or discharge any firearm or air gun in the Reserves or shoot, snare or destroy any game or birds thereon:
  - (k) bet publicly in the Reserves without the consent of the Committee;
  - (l) spit or expectorate on the paths or on any structure in the Reserves;

- (m) erect or place any building, caravan, van, tent, or any other structure on the Reserves, or camp on any portion thereon without the permission, in writing, of the Committee first obtained and then only subject to such conditions and the payment of such fees as may be determined by the Committee from time to time:
- (n) bring into the Reserves any dog unless controlled by chain or cord without the permission, in writing, of the Committee first obtained;
- (o) ride any horse within the Reserves in a manner which is dangerous to the public therein;
- (p) bring into or allow to remain in the Reserves any dog, horse, cattle, sheep or any other animal without the prior approval in writing of the Committee:
- (q) do anything on the Reserves for the purpose of making money without the prior approval, in writing, of the Committee;
- (r) play or perform in any band of music, or deliver or read any public speech, literature, prayer, sermon, or address of any kind or sing publicly any sacred or secular song, or enter into any public assemblage on the Reserves without the prior approval in writing of the Committee;
- (s) except the officers or employees of the Committee on duty, enter the Reserves or any part thereof when a charge for admission is made without first paying the fee chargeable for admission;
- (t) park any vehicle in the Reserves except in any place set aside for the purpose by the Committee or any Reserve attendant:
- (u) drive any motor vehicle, motor cycle or any other vehicle on the Reserves in excess of the specified speed limits or in contravention of any authorized signs therein or direction by the Reserve attendant;
- (v) play, practise or engage in any organized game in the Reserves except in accordance with such conditions and restrictions as may be determined by the Committee from time to time;
- (w) remove or in any way damage or deface any fence, gate, seat, structure, receptacle, vegetation or any other physical feature in the Reserves;
- (x) fail to comply with any lawful direction given by any Reserve attendant in accordance with the provisions of these Regulations.
- 4. For the purposes of good order, any person authorized by the Committee may refuse admission to any person to the Reserves.
- 5. No person shall remain in the Reserves at any time when lawfully directed by any member or employee of the Committee, any member of the police force or by a bailiff of Crown Lands or any person authorized by the Committee, to leave the same.
- 6. No club, association or person shall hold or take part in any game of any description, entertainment, performance, show or ceremony in any part of the Reserves without the written authority of the Committee first obtained and then only subject to the

payment of such fees and on such terms, and conditions as the Committee deems to be reasonable and consistent with these Regulations.

- 7. No person shall remove any earth, sand, stone, marble or gravel from the Reserves nor remove, dig for, or disturb any crustacean or other edible marine life.
- 8. No person, club or other body, shall, without the consent of the Committee first obtained, grade or scrape the ground or cut or burn any grass growing on any part of the Reserves.
- 9. The Committee shall have power to let any portion of the Reserves to any club, association, person or society for the purpose of holding entertainments, performances, shows or sports, subject to the payment of such fees and on such terms as it may deem to be reasonable and consistent with these Regulations, and to authorize any club, association, society or person to make a charge for admission thereto as hereinbefore provided in these Regulations.
- 10. Persons renting or hiring any stand, building, erection or enclosure for any sport, fete or holiday amusement may be required to deposit any sum which the Committee may at any time determine by way of guarantee that due care shall be taken of any stand, building, erection or enclosure and such Committee, in its absolute discretion, may make good any damage or injuries sustained by any stand, building, erection, or enclosure or anything contained therein during such occupancy or hiring and deduct the cost of making good such damage, injury or loss from the sum of money deposited by way of guarantee and all persons so renting or hiring shall abide by these Regulations and by any order given by the Committee.
- 11. The Committee shall have the power to hold entertainments, shows or performances on the Reserves, and to make a charge for admission thereto as hereinbefore provided.
- 12. No person shall enter any building in the Reserves or enter upon any arena therein without the permission of the Committee and any person having done so shall leave the same on having been requested to do so by any member of the Committee, any member of the police force or by any bailiff of Crown Lands.
- 13. No person shall remove or displace or damage or deface any board, plate fitting or written notice for the exhibition of any Regulations, or any notice fixed or set by the Committee of the Reserves.
- 14. Any person, club or society having obtained permission of the Committee to use any dressing shed, pavilion or other structure or enclosure on the Reserves shall maintain and leave the same in clean and tidy condition. No room fitted with lock and key shall be left unlocked after use.
- 15. No person shall throw or cause to be thrown, any stone or other substance or play football, cricket, hockey or any other game with a hard or semi-hard ball on the Reserves, except in portions set aside for the purpose.
- 16. No person, except workmen employed on the Reserves, shall enter any plots therein which may be closed for plantation of young trees, shrubs or grass.

17. Every person holding or purporting to hold any receipt of permission, in writing, issued by the Committee shall, on demand by any member of the Committee or any officer thereof or any member of the police force produce such receipt or permission.

#### Part 3-Enforcement

18. No person shall in the Reserves-

- (a) Cross or trespass on any playing ground, during any sport or during practise by any person or member of any sports club, for the time being occupying the Reserves, or any portion thereof;
- (b) behave improperly or riotously;
- (c) improperly interfere with or interrupt any sports or holiday amusement or any practise thereat;
- (d) obtain admission to any part of the Reserves when not entitled to such admission under these Regulations.
- 19. The Committee may require any person who in the opinion of the Committee has offended against any of these Regulations to forthwith leave the Reserve.
- 20. Any person committing any breach of these Regulations who refuses to state his name and place of abode to any member of the Committee or to an employee of such Committee or who, in the opinion of such member or employee, states a false name or place of abode shall be guilty of an offence under these Regulations.


