MELBOURNE AND METROPOLITAN BOARD OF WORKS

General Notice

The Melbourne and Metropolitan Board of Works having made provision for carrying off the sewage of each and every property which or any part of which is situate in the Sewerage Areas hereinafter described doth hereby declare that on and after 17 April 1985 each and every property so situate shall be deemed to be a sewered property within the meaning of the Melbourne and Metropolitan Board of Works Act 1958.

The Sewerage Areas hereinbefore referred to are:

Sewerage Area No. 5008

City of Waverley—This area comprises lots 192 to 202, 205 to 207, 225 to 227, 175 and 174 Crosby Drive, lots 240, 168 to 173, 176 to 191 and 228 to 232 Bunker Crescent, lots 218 to 224 and 208 to 217 Greenways Road.

Sewerage Area No. 5087
