



Vegetation and Vine Diseases Act 1958
VINE DISEASE DISTRICTS

PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

Whereas by section 33 of the Vegetation and Vine Diseases Act 1958 it is provided that the Governor in

Council may by order proclaim any portion of Victoria the boundaries whereof shall be defined in such order to be a "vine disease district" and may from time to time revoke or annul such order either as to the whole of such district or as to any part thereof—

Now therefore, I, the Governor of the State of Victoria in the Commonwealth of Australia by and with the advice of the Executive Council of the said State do by this my Proclamation hereby proclaim those portions of Victoria the boundaries of which are defined below to be Vine Disease Districts for the purposes of the said Act, that is:

 The Mooroopna Vine Disease District the boundary of which is defined as follows:

Commencing at the point where the northern boundary of the Parish of Mooroopna joins with the western boundary of that parish; thence easterly along the northern boundary of that parish to the junction with the Goulburn River; thence generally southerly along the western bank of the Goulburn River to the junction of the river with the southern boundary of the Parish of Toolamba; thence westerly along the southern boundary of that parish to the western boundary of that parish; thence northerly along the western boundary of that parish and the western boundary of the Parish of Mooroopna to the point of commencement.

2. The Nagambie Vine Disease District the boundary of which is defined as follows:

Commencing at the point where the northern boundary of the Parish of Bailieston joins the western boundary of that parish; thence easterly along the northern boundary of that parish and easterly north easterly and generally south westerly along the northern boundary of the Parish of Noorilim to the intersection with the northern boundary of the Parish of Wahring; thence easterly along the northern boundary of that parish to the eastern boundary of that parish; thence southerly along the eastern boundary of that parish and the eastern boundary of the Parish of Wormangal to the southern boundary of that parish; thence westerly along the southern boundary of that parish and part of the southern boundary of the Parish of Tabilk to the intersection with the Seymour to Shepparton railway line; thence southerly along that railway line to the intersection with the southern boundary of the Parish of Avenel; thence westerly along the boundary to the western boundary of that parish; thence northerly along that boundary to the southern boundary of the Parish of Mitchell; thence westerly along that boundary to the western boundary of that parish; thence northerly along that boundary and the western boundary of the Parish of Bailieston to the point of commencement.

3. The North-East Vine Disease District the boundary of which is defined as follows:

Commencing at the point where the western boundary of the Parish of Bundalong joins with the Murray River; thence generally easterly along the south bank of the Murray River to the intersection with the eastern boundary of the Parish of Wodonga; thence southerly along the eastern boundary of that

parish and the eastern boundaries of the Parishes of Baranduda, Yackandandah, Bruarong and Mudgeegonga; thence generally westerly along the southern boundary of the Parish of Mudgeegonga to the intersection of the eastern boundary of the Parish of Myrtleford; thence generally southerly along the eastern boundary of the Parish of Myrtleford to the southern boundary of that parish; thence generally westerly along the southern boundary of that parish and the southern boundaries of the Parishes of Whorouly, Moyhu, Greta and Lurg; thence northwesterly along the south western boundaries of the Parishes of Lurg and Winton; thence north-easterly along that part of the north-western boundary of the Parish of Winton to the intersection of the western boundary of the Parish of Mokoan; thence northerly along the western boundaries of the Parishes of Mokoan, Boweya, Boomahnoomoonah and Bundalong to the point of commencement.

REVOCATION OF VINE DISEASE DISTRICTS

Whereas by section 33 of the Vegetation and Vine Diseases Act 1958 it is provided that the Governor in Council may by order proclaim any portion of Victoria the boundaries whereof shall be defined in such order to be a "vine disease district" and may from time to time revoke or annul such order either as to the whole of such district or as to any part thereof.

Now therefore, I, the Governor of the State of Victoria, in the Commonwealth of Australia, being of the opinion that the insect *Daktulosphaira vitifolii*, commonly known as grape phylloxera, is no longer known to occur within a significant part of the North Central Vine Disease District of Victoria (being the area described in the proclamations made on 29 May 1923 and 5 August 1935) and by and with the advice of the Executive Council of the said State, do by this my Proclamation hereby:

Revoke the proclamation made on 29 May 1923 and published in the *Government Gazette* of 6 June 1923 declaring the Counties of Bendigo and Rodney and portions of the Counties of Gladstone, Talbot, Gunbower, Dalhousie, Anglesey, Moira, Delatite, Bogong and Benambra to be a Vine Disease District; and

Revoke the proclamation made on 5 August 1935 and published in the *Government Gazette* of 7 August 1935 declaring portion of the County of Moira to be a Vine Disease District.

Now therefore, I, the Governor of the State of Victoria in the Commonwealth of Australia, by and with the advice of the Executive Council of the said

State, do by this proclamation declare that Danny Street coloured brown on Plan of Subdivision No. 52558 shall be a public highway within the meaning of the said Act.
