No. 10181. "An Act to amend the *State Disasters Act 1983* and for other purposes." (*State Disasters (Amendment) Act 1985*.)

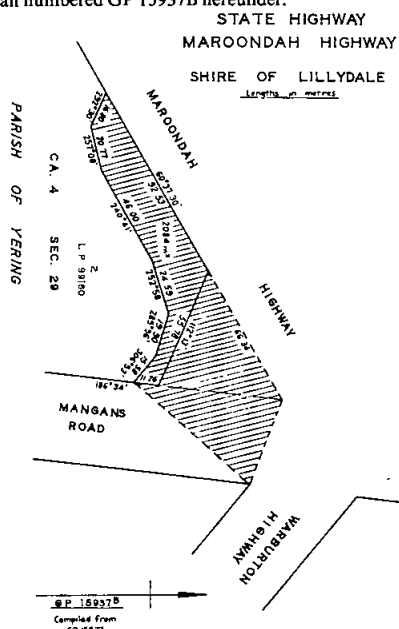

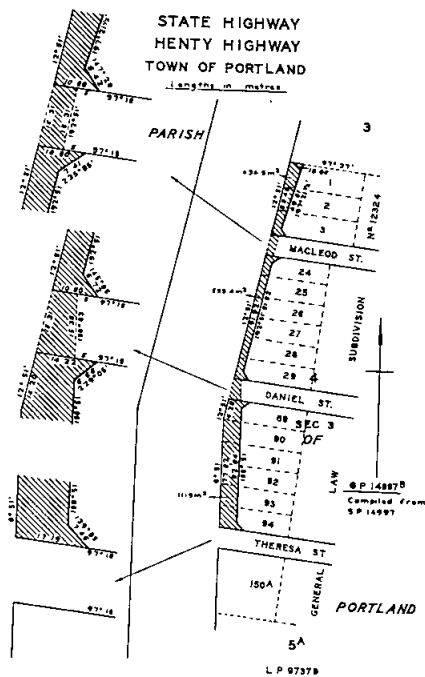




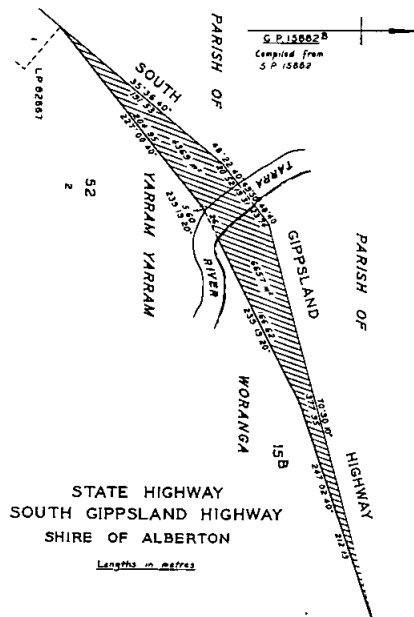

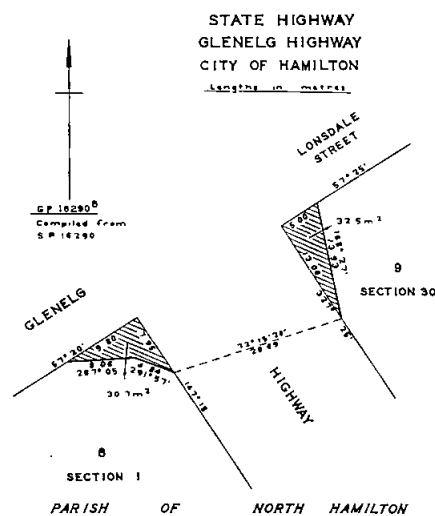

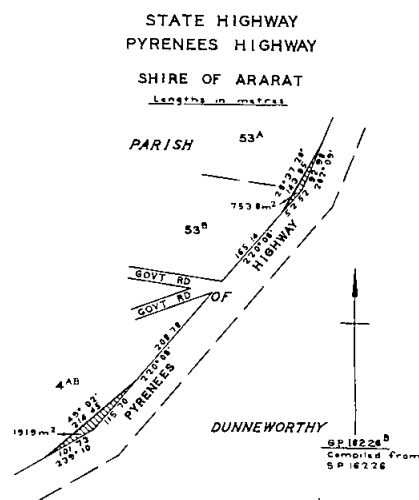
20/85 Declaration of the widening of the South Gippsland Highway in the Shire of Alberton as shown hatched on plan numbered GP 15882B hereunder.



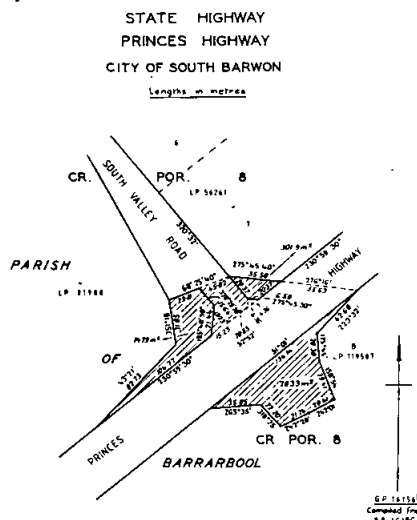
22/85 Declaration of the widening of the Glenelg Highway in the City of Hamilton as shown hatched on plan numbered GP 16290B hereunder.

Now therefore His Excellency the Governor of the State of Victoria, with the advice of the Executive Council of the said State on the recommendation of the Minister for Water Resources and in pursuance of the hereinbefore recited powers, doth hereby declare order and direct that the provisions of Schedule Three A of the Water Act shall be varied as on and from 1 July 1985, as described hereunder, to the intent that the Kerang Irrigation Area, Koondrook Irrigation Area and Third Lake Irrigation Area be united as on and from that date to form one Irrigation Area to be known as Kerang Irrigation Area which new area is defined by blue colour on Plan No. WA68 signed by the Minister of Conservation, Forests and Lands and lodged in the Central Plan Office.

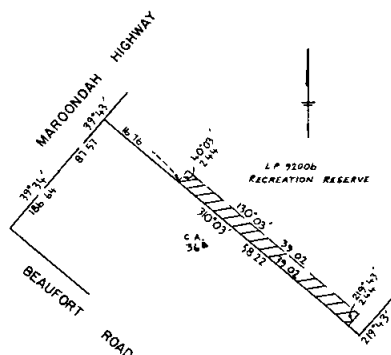

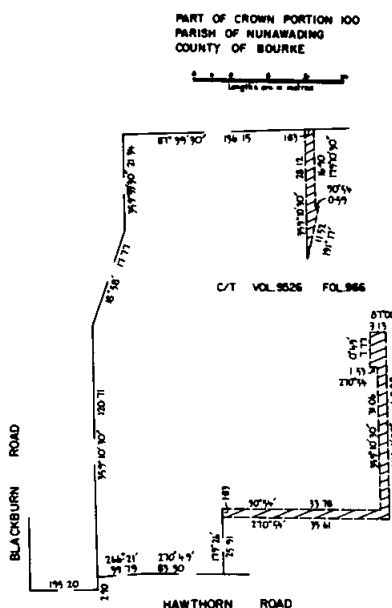

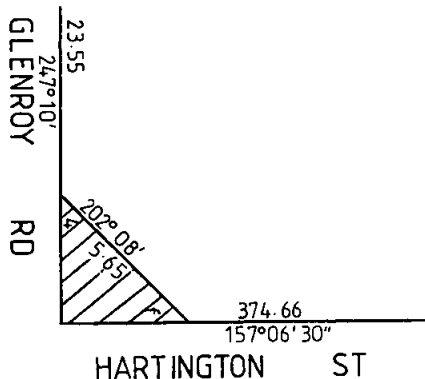

By-Law No. 141

Recreation Vehicle Control By-Law

A By-Law of the City of Castlemaine made under the provisions of the *Local Government Act* and numbered 141 for prohibiting and/or regulating the use of motorized vehicles for recreational purposes on any land or any specified part or parts of land not being a highway or private street or road or public land within the meaning of the *Land Conservation Act 1970*.

In pursuance of the powers conferred by section 197xxvii of the *Local Government Act* and of any and every other power it thereunto enabling the Mayor, Councillors and Citizens of the City of Castlemaine orders as follows:

1. In this By-Law—

"motorized vehicles for recreational purposes" means and includes all mini-bikes, trucks, tractors, trail bikes, motor bikes, motor cars, motor scooters, go-carts and any other vehicles which may be propelled by a motor or by mechanical means.

"public place" means—

- (a) any bridge footway footpath court alley passage or thoroughfare open to or used by the public;
- (b) any park garden reserve or other place of public recreation or resort;
- (c) any open place to which the public, whether upon or without payment for admittance, have or are permitted to have access;
- (d) any school or the land or premises in connection therewith—
but does not include a highway.

2. No person shall use any motorized vehicle for recreational purposes on any land including any public place within the municipality of the City of Castlemaine not being a highway or private street or road or public land within the meaning of the *Land Conservation Act 1970* without the written consent of the Council first obtained.

3. Any person applying for such written consent from the Council under Clause 1 hereof shall—

- (a) make application in writing to the Council;
- (b) state the place at which such vehicle or vehicles is or are to be used;
- (c) the date and/or dates and the times during which such vehicle or vehicles will be used;
- (d) the names, addresses and age or ages of any person or persons who will be using such vehicle or vehicles at such time and in respect of who such consent is applied for;
- (e) describe such vehicle or vehicles stating its make, engine size and whether or not it is registered under the *Transport Act* or the corresponding enactments then in force;
- (f) whether or not the vehicle or vehicles have been properly fitted with silencers;
- (g) submit written consent of the owner of the land whereon the vehicle or vehicles are to be ridden on the date or dates and times referred to in the application;

(h) supply such other information that the Council may require.

4. The Council in giving its consent under Clause 2 hereof may impose any condition which it considers appropriate to the use of such vehicles and any person who has been given such a consent by the Council subject to any condition or conditions shall comply with the said condition or conditions.

5. This By-Law shall apply to and have operation throughout the whole of the municipal district.

6. By-Law No. 38

A By-Law of the Shire of Avon made under the provisions of section 93 of the *Health Act 1958* and numbered 38 for the purpose of—

- (a) regulating the collection and removal of house and trades wastes and other rubbish;
- (b) the provision use and control of receptacles for the deposit and collection of refuse and rubbish (whether temporary or otherwise) and prescribing the size and shape of and the materials to be used in the construction of such receptacles;
- (c) preventing or regulating the deposit of refuse and rubbish upon streets and other lands and places under the control of the Council;
- (d) the removal replacement cleansing and disinfecting of receptacles for refuse and rubbish; and the use of deodorants or disinfectants in such receptacles;
- (e) prescribing the times for the removal or carriage through the streets of any garbage or offensive or noxious matter of liquid whether into or out of or through the municipal district; providing that the utensils receptacles and vehicles used therefor shall be properly constructed and covered so as to prevent any leakage therefrom or the escape of any such matter or of any offensive effluvia; and compelling the cleansing of any place whereon such garbage matter or liquid has been dropped or spilt in such removal or carriage.

In pursuance of the powers conferred by the *Health Act 1958* and every other power enabling it in that behalf the President and Councillors and Citizens of the Shire of Avon order as follows:

1. By-Law numbered 28 is hereby repealed.

2. This By-Law shall come into full force and operation on the day after the date of its publication in the *Victoria Government Gazette*.

3. This By-Law shall apply to and have operation throughout the municipal district of the Shire of Avon.

4. In this By-Law, unless inconsistent with the context or subject matter—

- (a) "Animal" includes any horse mare gelding colt filly or foal and any bull cow ox steer heifer or calf and any ram ewe sheep or lamb and any ass mule camel goat or pig and any dog or cat;
- (b) "Council" means the Council of the Municipality of the Shire of Avon;
- (c) "Dangerous Wastes" includes acids, poisons and volatile or explosive matter;
- (d) "Depot" means any land, place or premises used for and in relation to the disposal of refuse and rubbish and approved and reserved by the Council or other proper authority for such purpose;
- (e) "Premises" includes messuages buildings lands and hereditaments of every tenure;
- (f) "Proprietor" means the proprietor of any premises and includes the owner, the occupier, or any person having the management or control thereof;
- (g) "Receptacle" includes any bin or sack used for the collection of rubbish and refuse;

- (h) "Refuse and Rubbish" includes all wastes (except Nightsoil, sewage and manure) produced or accumulated in or about any house, building or premises and includes ashes and dust.

5. The proprietor of every house, building or premises shall provide, keep and maintain at all times upon his premises a properly constructed receptacle in the form of a bin, weather resistant sack or garage bag as specified in this By-Law, in which he shall, from time to time, cause to be deposited therein all refuse produced or accumulated in or about such house, building or premises.

6. Each bin shall be constructed of metal or plastic and be designed in such a manner as to prevent any absorption by any part of such bin of any offensive matter which may be deposited therein or any escape by leakage or otherwise of any part of the contents of such bin. When a bin is constructed of metal it shall be constructed of galvanized iron of not less than 24 gauge securely riveted and soldered. When a bin is constructed of plastic it shall conform with the specifications of the Standards Association of Australia Number A.S. 1535, "Moulded Plastics Household Garbage Cans".

7. Each bin shall have a capacity of not more than 85 litres, shall be strongly constructed and provided with properly attached side-lifting handles and be capable of being easily and conveniently carried by one man.

8. Every such bin shall be provided with a suitable close fitting lid with a flange overlapping the top of the bin and shall be kept constantly covered (except when refuse is being deposited therein or discharged therefrom) and a sufficient quantity of some efficient deodorant shall be from time to time, introduced therein when necessary to keep the contents in an inoffensive condition.

9. When a weather resistant sack is used, it shall have a capacity of not more than 85 litres and shall be constructed with a minimum of two plied walls and shall be suspended in a frame fitted with a fly-proof hinged lid so as to be clear of the ground or floor level.

When an approved plastic garbage bag is used, it shall conform with the specifications of the Australian Standards Association No. 1251 "Polyethylene (Polythene) Garbage Bags".

10. (a) A person shall not place or cause or permit to be placed any slops or liquid waste in such bin or approved sack or garbage bag, nor shall deposit any moist refuse in such bin or approved sack or garbage bag unless such refuse has been previously strained and effectively wrapped in waste paper.

(b) A person shall not place or cause to be placed any disposable nappies in any such bin or approved sack or garbage bag unless such disposable nappies have been effectively wrapped with waste paper.

(c) A person shall not place or permit to be placed any briquette dust or ashes in any receptacle unless the briquette dust or ashes have been effectively quenched with water in such quantity as to form the consistency of a stiff paste and thereafter effectively wrapped in paper.

(d) A person shall not place or cause to be placed any dangerous wastes in any receptacle.

11. The Proprietor shall cause each bin to be kept in good order and condition at all times and shall coat the inside of each bin with tar or other suitable substance and any receptacle shall not be used if it becomes unsuitable for the retention of rubbish or if it does not comply with the provisions of this By-Law.

12. On such days and at such hours as may be appointed by the Council, the proprietor shall for the purpose of having each bin emptied or each approved sack or garbage bag removed, cause such bin or approved sack or garbage bag to be placed adjacent to the entrance of such house, building or premises, on any street, lane or right-of-way on which such house, building, or premises abuts, as follows:

- (a) When there is an unpaved portion of footway then on such unpaved portion near to the street channel; or
- (b) Where the footway is paved to its full extent than on such footway near to the street channel; or
- (c) In such other location as may be approved by the Council.

13. The contractor or person or persons employed or authorized by the Council for the removal of such refuse shall be responsible for the removal of any weather resistant sack or plastic garbage bag and for the complete emptying (without spilling any of the contents) of such bin or bins directly into a vehicle provided for this purpose at such hours and on such days as may be appointed by the Council.

14. The contractor or person or persons employed or authorized by the Council for the removal of such refuse shall at least once a week, or at such greater frequency as directed by Council, collect and remove such refuse and sacks in a suitable vehicle in such a manner as not to cause spillage, nuisance, danger to health.

15. Any vehicle, provided by a contractor or person or persons authorized by Council or any vehicle provided by Council for the purpose of garbage collection, shall be constructed of impervious material so as to prevent any liquid or garbage matter leakage or spillage therefrom and be watertight and provided with a cover capable of preventing any such spillage of such refuse.

16. Any such vehicle when full, shall be taken to the tip without any spillage where as soon as practicable the refuse and sacks shall be rendered innocuous by means of such method as may be required by Council's Health Surveyor or Engineer, and in such a manner as not to create a nuisance.

17. The contractor or person or persons employed or authorized by the Council shall cause all vehicles used for the reception and removal of such refuse and sacks to be kept clean, thoroughly disinfected and maintained in a proper state of repair.

18. A person shall not convey or permit to be conveyed in any vehicle upon any street or road—

any manure, dead animal, offal, bones, hides, skins, offensive matter, refuse, rubbish or other waste matter whatsoever, unless such vehicle is so constructed loaded and covered as to:

- (i) effectively prevent the dropping on any street or road from the said vehicle of any part of its contents;
- (ii) reduce as far as possible the escape of offensive odours.

19. Any person who drops or spills any garbage matter or liquids during removal or carriage shall effectively clean such place of such matter.

20. A person shall not deposit or leave or permit or suffer to be deposited or left on any land not being a depot set aside for such purpose any refuse rubbish offensive liquids or litter whatsoever.

21. Trade Waste—

- (a) the proprietor of any premises where trade waste may be derived shall ensure such trade waste is stored in an approved manner and is contained in a receptacle;
- (b) all such receptacles shall be constructed so as to be impervious, robust and vermin proof and be capable of being easily handled and emptied;
- (c) all receptacles used for the storage of trade wastes shall be kept on the property generating such trade waste, provided all such receptacles are easily accessible for the purposes of removal. No such receptacle shall be located so as to be a nuisance nor cause obstruction;
- (d) where trade wastes are removed by any contractor not contracted by Council such removal shall be carried out in conformity with any statutory requirements in force in the municipality at the time of such removal;
- (e) all persons contracting for the removal of trade refuse from any premises shall obtain Council's approval in writing before commencing such removal and shall arrange for the provision of equipment and facilities for the conduct of such removal to the satisfaction of Council's Health Surveyor or Engineer.

22. Any person who shall by any wilful act or default commit a breach of any of the provisions of this By-Law shall for any offence be liable to a penalty not exceeding four hundred dollars and should such offence be a continuing offence the offender shall be liable to a further penalty of not more than ten dollars per day for each day on which such offence is continued after a conviction or order by any court.

The resolution for passing this By-Law was agreed to by Council on 1 July 1984 and was confirmed on 6 August 1984.

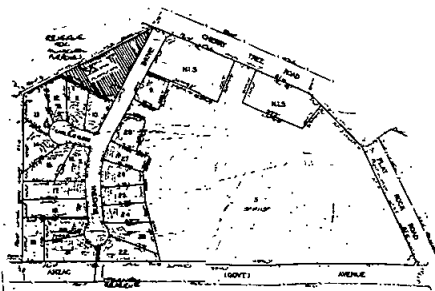

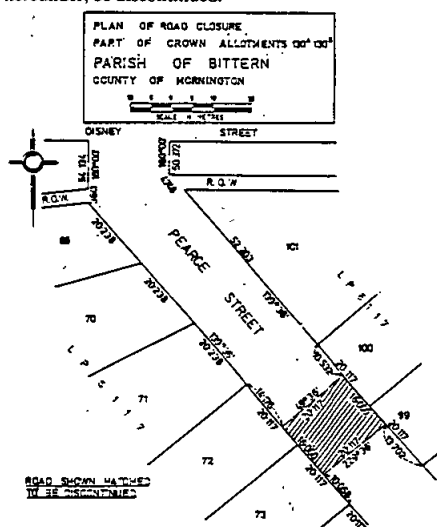

SHIRE OF WHITTLESEA
 By-Law No. 82

A By-Law of the Shire of Whittlesea made under the provisions of the *Health Act 1958* and numbered 82 for the purposes of regulating the use and control of receptacles for the deposit and collection of refuse and rubbish and prescribing the size and shape of the material to be used in the construction of such receptacles.

In pursuance of the powers conferred by the *Health Act 1958*, the President, Councillors and Ratepayers of the Shire of Whittlesea (hereinafter called "the Council") order as follows:

Part I—Name and Area of Application of By-Law

(a) This By-Law shall be known as the Refuse and Household Garbage Receptacles By-Law.

(b) By-Laws Numbered 25, 35, and 41 are hereby repealed.

(c) This By-Law shall apply to and have operation throughout the district of the Shire of Whittlesea and shall apply to every house, building and premises located in areas which Council may from time to time declare to be areas which are to be served by Council's refuse collection service.

Part II—Definitions

(a) In this By-Law, unless inconsistent with the context or subject matter—

"Council" means the Council of the Shire of Whittlesea.

"Premises" includes messuages buildings land and hereditaments of every tenure.

"Proprietor" means the proprietor of any premises and includes the owner, the occupier, or any person having the management or control thereof.

"Refuse" includes all wastes (except sewage and manure) produced or accumulated in or about any house, building or premises but shall not include trade waste.

"Trade Waste" means any waste material produced or accumulated on any premises as a result of any commercial or industrial process or occupation carried on in such premises.

Part III—Receptacles

(a) The proprietor of every house, building, or premises shall provide, keep and maintain at all times upon his premises a properly constructed receptacle in which he shall from time to time cause to be deposited all refuse produced or accumulated in or about such house, building or premises.

(b) Such receptacle shall be a bin constructed of galvanized iron of not less than 24 gauge, or polyethylene bin in such a manner as to prevent any absorption by any part of such receptacle of any offensive matter which may be deposited therein, or in any escape by leakage or otherwise of any part of the contents of such receptacle.

(c) Each such receptacle shall have a capacity of not more than 80 litres and shall be so constructed as to be capable of being easily and conveniently carried by one man and shall not exceed 16 kilograms in weight when fully laden with refuse.

(d) (i) Where the receptacle is constructed from 24 gauge galvanized iron it shall be provided with properly attached side lifting handles and with a suitable close fitting lid with a flange overlapping the top of such receptacle and shall be kept constantly closed (except when such refuse is being deposited therein or discharged therefrom).

(ii) Where the receptacle is constructed from polyethylene it shall be constructed to the specifications as set out in Australian Standard No. 1535—1975 as may be amended or revised by the Standards Association of Australia and fitted with properly attached side lifting handles and with a suitable close fitting lid with a flange overlapping the top of such receptacle and shall be kept constantly closed (except when such refuse is being deposited therein or discharged therefrom).

(e) All such receptacles shall be periodically cleaned, disinfected and deodorized as may become necessary so as to render them in a clean and sanitary condition.

(f) The proprietor shall cause such receptacle to be kept at all times in good order and inoffensive.

Part IV—Placement of Material for Collection

(a) (i) A person shall not place or cause or permit to be placed any slops or liquid waste in such receptacle, nor shall deposit any moist refuse in such receptacle unless such moist refuse has been previously strained and effectively wrapped in paper.

(ii) A person shall not place or cause or permit to be placed any household garbage or any dust from a vacuum cleaner or any ashes unless such dust or ashes are effectively wrapped in paper so as to remain confined in such paper whilst within such receptacle and so as not to become loose or spread in such receptacle.

(iii) A person shall not place or cause or permit to be placed any animal carcass or parts thereof or offal or skins of any animal in such receptacle except that which are the remains of a carcass or meal intended for human consumption.

(b) The proprietor (at such hours and on such days as may be appointed by the Council for the removal of such refuse) shall cause such receptacle to be deposited close to the entrance of his premises so that it may conveniently be removed by the contractor or person authorized by Council or employed in that behalf by the Council.

Part V—Removal of Refuse

(a) The contractor or person authorized or employed by Council for the removal of such refuse shall be responsible for the complete emptying (without spilling any of the contents) of such receptacle or receptacles directly into a vehicle provided for its reception.

(b) The contractor or person authorized or employed by the Council for the removal of such refuse shall at least once in each week, or at such greater frequency as the Council directs, collect and remove such refuse in a suitable covered vehicle in such a manner as not to cause nuisance, danger to health, or offensiveness.

(c) Such vehicle shall be provided with a cover and kept covered except when refuse is being put into or discharged from such vehicle.

(d) Such vehicle shall as far as practicable be rendered watertight by means of an impervious lining or by painting the inside thereof with tar or by other suitable and effective means.

(e) The person in charge of such vehicle shall cause it to be taken when full by the shortest practicable route to the tip, incinerator, or destructor.

(f) The contractor or person authorized or employed by the Council for the removal of such refuse shall cause all vehicles used for the reception and removal of such refuse to be properly constructed, kept clean, and thoroughly disinfected with approved disinfectant, and maintained in a proper state of repair.

(g) If any person or persons commit a breach of this By-Law, he or they shall for every such breach be liable to a penalty of not more than \$400 and in the case of a continuing offence a further daily penalty of not more than \$10.

The resolution adopting this By-Law No. 82 was agreed to at the Meeting of the Council held on 13 December 1982 and confirmed on 7 February 1983.

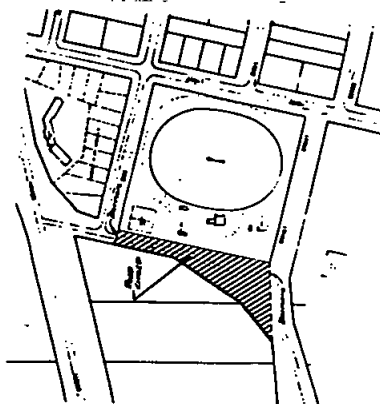
