## DISPOSAL OF PUBLIC RECORDS

Public Record Office Standard: PROS 85/1

## Statement of the Standard

## 1.0 Introduction

1.1 The Public Record Office was established under the *Public Records Act 1973* (as amended) for the better preservation, management and utilization of the public records of Victoria.

1.2 Public records include any records made or received by a person employed in a public office in the course of his/her duties, or by a court or person acting judicially in Victoria. Record is defined to mean any document within the meaning of the *Evidence Act 1958*, and includes information whether on paper, film, magnetic tape or disc, or any other media.

1.3 The term "Public Office" is defined in sub-section 2 (1) of the Act to mean:

- (a) any department, branch or office of the Government of Victoria;
- (b) any public statutory body corporate or unincorporate;
- (c) any municipality or other body constituted by or under the *Local Government Act 1958*; and
- (d) any other local governing body corporate or unincorporate.

1.4 Under section 12 of the *Public Records Act 1973*, the Keeper of Public Records is responsible for the establishment of standards for the efficient management of public records and for assisting public offices to apply those Standards to records under their control. Officers in charge of public offices are responsible under section 13 of the Act to carry out a programme of records management in accordance with the Standards established by the Keeper.

## 2.0 General Standards Covering Disposal and Storage

2.1 Standards applying to the disposal and storage of public records have been issued as follows:

- (a) applying to public offices referred to in paragraphs (a) and (b) of the definition of "Public Office" in sub-section 2 (1) of the *Public Records Act 1973*:
  - PROS 82/4: Guidelines for the Storage of Public Records (having effect for a period of 10 years from 30 June 1982);
  - PROS 82/5: Procedures for the disposition of Public Records (having effect for a period of 10 years from 1 June 1982);
  - PROS 84/32: Transfer of Public Records to Custody of Public Record Office (having effect for a period of 10 years from 14 September 1984);
- (b) applying to public offices referred to in paragraphs (c) and (d) of the definition of "Public Office" in sub-section 2 (1) of the *Public Records Act 1973*:
  - PROS 82/3: Records Management Manual for Local Government (having effect for a period of 10 years from 31 October 1983);

- PROS 84/32: Transfer of Public Records to Custody of Public Record Office (having effect for a period of 10 years from 14 September 1984).

2.2 These Standards include provision for the disposal of public records by destruction or transfer to the Public Record Office as well as guidelines on the development of disposal arrangements and records storage.

2.3 In paragraphs 6.1-6.4, 9.1-9.4, 9.9 and 10.5 of PROS 82/5, Appendices C, D, I and Q of the Supplement to PROS 82/5, and paragraphs 6.1-6.3, 9.1-9.4, 10.5 and Appendices C, I and N of Volume 2 of PROS 82/3, procedures and forms for the disposal of public records are provided.

## 3.0 Variation to General Standards

3.1 In pursuance of section 12 of the *Public Records Act 1973*, I hereby vary and amend Public Record Office Standard PROS 82/5 by suspending the operation of paragraphs 6.1-6.4, 9.1-9.4, 9.9 and 10.5 and the use of the forms and procedures in Appendices C, D, I and Q of the Supplement to the Standard insofar as they relate to the destruction of public records.

3.2 In pursuance of section 12 of the *Public Records Act 1973*, I hereby vary and amend Public Record Office Standard PROS 82/3 by suspending the operation of paragraphs 6.1-6.3, 9.1-9.4 and 10.5 in Volume 2, and insofar as they relate to the destruction of public records, the use of the forms and procedures in Appendices C, I and N of Volume 2.

## 4.0 Authorization of Records Disposal

4.1 No public records may be destroyed or otherwise disposed of except in accordance with Standards issued under section 12 of the *Public Records Act 1973*. Disposal of records includes permanent retention, destruction and transfer of custody.

4.2 Destruction or disposal of public records is permitted:

- under disposal procedures issued as Public Record Office Standards;
- under normal administrative practice as set out in para. 4.5 of this Standard.

4.3 The destruction or disposal of records may be authorized by:

- a disposal schedule;
- a destruction or retention authority.

Such authorities are issued by the Keeper of Public Records with the agreement of relevant public offices.

4.4 Disposal schedules may take the form of a General Disposal Schedule covering the disposal of records that are common to a number of public offices, or Specific Disposal Schedules drawn up to cover records that are specific to a particular public office. Disposal schedules are issued as Standards under section 12 of the *Public Records Act 1973*.

4.5 The destruction of some public records is permitted without authorization under normal administrative practice by means of:

- the dispatch of outgoing correspondence;
- the destruction of ephemeral material of a facilitative nature created, acquired or collected by public offices during the course of their duties being:



- working papers consisting of rough notes and calculations used solely to assist in the preparation of other records such as correspondence, reports and statistical tabulations;
- drafts not intended for retention as part of the office's records the content of which has been reproduced and incorporated in the public office's record-keeping systems;
- extra copies of documents and published material preserved solely for reference.

#### 5.0 *Destruction of Financially Accountable Records*

5.1 Financially accountable records may not be destroyed unless the audit requirements of a public office have been satisfied.

5.2 Public offices, which fall within the definition of a Department contained in Regulations under the *Audit Act 1958*, are required to obtain the approval of the Auditor-General prior to destruction of financially accountable records. Approval should be sought through the Public Record Office as outlined in 9.0.

#### 6.0 *The Records Disposal Plan*

6.1 Effective records disposal action should be planned and integrated into a public office's information management programme.

6.2 Each public office should develop a Records Disposal Plan which:

- identifies objectives and priorities;
- provides for disposal action based on the development and implementation of disposal schedules, the implementation of other Public Record Office Standards relevant to disposal, and the programmed use of destruction and retention authorities; and
- provides for the development of appropriate records storage and transfer strategies.

#### 7.0 *Destruction of Records under a Disposal Schedule*

7.1 Public records may be destroyed in accordance with the provisions of an approved disposal schedule.

7.2 In most cases, once a disposal schedule has been issued as a Standard, further authorization for disposal action undertaken in accordance with the schedule's provisions is not required. In these cases, notification of destruction is required by the schedule. It should be made by the public office to the Public Record Office using the Notification of Destruction Form and following the related procedures as prescribed by this Standard.

7.3 In some cases a disposal schedule may require further authorization by the Keeper of Public Records for each individual destruction of records undertaken in accordance with the schedule's provisions. In such cases, authorization should be sought by the public office using the Destruction Authority Form and following the related procedures as prescribed by this Standard.

7.4 Where a disposal schedule includes financially accountable records of public offices which fall within the definition of a Department contained in regulations under the *Audit Act 1958*, the Auditor-General's prior approval may not be required for each individual destruction of such records provided the period of

retention specified in the schedule has expired and notification of destruction is made to the Public Record Office. However, disposal schedules may specify that the Auditor-General's prior approval is required. In such cases it should be sought by the public office using the Destruction Authority Form and following the related procedures as prescribed by this Standard.

#### 8.0 *Notification of Destruction*

8.1 Where notification of destruction is required under provisions of a disposal schedule, a public office should notify the Public Record Office by completing in duplicate form PRO 29, Notification of Destruction of Public Records in Public Offices, prior to destruction. A copy of the form should be forwarded to the Public Record Office prior to destruction, or at the time specified in the disposal schedule. One copy of the form should be kept for the public office's own record of disposal action.

8.2 Form PRO 29, Notification of Destruction of Public Records in Public Offices, should be signed prior to dispatch to the Public Record Office by the head of the public office or an officer appointed for that purpose.

#### 9.0 *Authorization of Destruction under a Destruction Authority*

9.1 Prior authorization for each individual destruction is required (except in cases of destruction under normal administrative practice):

- for the destruction of records not covered by a disposal schedule;
- for the destruction of records covered by a disposal schedule which includes a requirement to seek prior authorization for each individual destruction from the Keeper of Public Records;
- for the destruction of financially accountable records covered by a disposal schedule which includes a requirement to seek the Auditor-General's prior approval for each individual destruction.

9.2 Where prior authorization by the Keeper of Public Records or prior approval of the Auditor-General is required, a public office should seek authorization by completing and forwarding to the Public Record Office two copies of form PRO 11a, Destruction Authority for Public Records in Public Offices. If approval by the Auditor-General is required, the Public Record Office liaises with the Auditor-General to seek his approval. Following authorization by the Keeper of Public Records and, where appropriate, approval by the Auditor-General, one copy of the form is returned to the public office. Destructions may not proceed until the authorized copy of the form is received. This copy should be retained by the public office as a record of disposal action.

9.3 Form 11a, Destruction Authority for Public Records in Public Offices, should be signed prior to its dispatch to the Public Record Office by the head of the Public office or an officer appointed for that purpose.

9.4 Form 11a, Destruction Authority for Public Records in Public Offices, should be accompanied by a completed form PRO 11 b, Records Appraisal Check List, for each class of records included in a Destruction Authority that is not covered by a disposal schedule.

#### 10.0 *Retention of Permanent Value Records under a Disposal Schedule*

10.1 All records designated as permanent in a disposal schedule must be retained and transferred to the Public Record Office at the time specified in the schedule, unless provision is made in a Disposal Standard for their transfer to an in-house Archives or Place of Deposit (see 15.4).

#### 11.0 *Retention of Permanent Value Records under a Retention Authority*

11.1 Authorization for the permanent retention of permanent-value records not covered by a disposal schedule may be given in a Retention Authority. Such an arrangement is undertaken by the Public Record Office. Records covered by a Retention Authority must be transferred to the Public Record Office.

#### 12.0 *Disposal of Microfilm and Related Records*

12.1 The process of microfilming public records does not mean that those records can then be destroyed or otherwise disposed of without an approved disposal authority. Micrographic system design should include provision for the development of appropriate disposal arrangements for both the microfilm (roll or cartridge film, microfiche or jackets, aperture cards) and related paper records. Disposal authorization should be arranged through the Public Record Office.

12.2 As a general rule authorization is not given to destroy original paper records with a permanent status following microfilming. After temporary records have been microfilmed, approval may be given to shorten the retention period of the original paper records. In regard to temporary paper records with legal value, approval to destroy original paper records prior to the minimum retention period is granted subject to the condition that, before destruction takes place, a reproduction or negative of the records (as the case requires) is made under section 53 *b* or 53 *c* of the *Evidence Act* 1958. These sections include requirements relating to the microfilm copy being made in good faith, the taking of affidavits and, in the case of section 53 *c*, the use of a camera approved by the Attorney-General. Compliance with section 53 *b* or 53 *c* of the *Evidence Act* 1958 ensures that the copy is a complete copy of the original record, and is an adequate substitute for that record for evidentiary purposes.

12.3 More detailed provisions relating to the disposal of microfilm and related records will be contained in a forthcoming Standard.

#### 13.0 *Disposal of ADP Records*

13.1 As public records include information on any media, disposal of automated records should be in accordance with Standards issued under section 12 of the *Public Records Act* 1973. A forthcoming Standard will make more detailed provisions for the disposal of automated records (magnetic tapes, discs, magnetic drums, punch cards, paper tapes) and related documentation. Related documentation refers to system and file specifications (including record layouts and codebooks for magnetic tapes), test documentation, manuals and user guides. Computer input and output microform and related paper records are not included in the definition of ADP records.

13.2 In the case of automated records, disposal includes any routine treatment, e.g. wiping, updating or rerecording, which results in information contained on the records being lost. Such treatment may result in the loss of permanently valuable data.

13.3 Until more detailed provision is made for the disposal of automated records and related documentation, in accordance with this Standard modification and updating of data as part of the running of established programmes and routines is hereby authorized.

13.4 Public offices should consult with the Public Record Office before terminating any programme that would result in the destruction or loss of potentially permanent-value data files.

13.5 Public offices should consult with the Public Record Office during the development of computerized systems to identify and make provision for any potentially permanent-value data files.

#### 14.0 *Destruction of Records Subject to Outstanding Freedom of Information Requests*

14.1 Destruction is not permitted of any public record in respect of which a request for access has been received under the *Freedom of Information Act* 1982, or similar legislation applicable to other public offices, until such time as access has been granted to the applicant or, in the case where access is denied, an appeal against the refusal to grant access has been determined or, in the case where no appeal is made, the period during which an appeal can be made has lapsed.

#### 15.0 *Transfer of Records*

15.1 Records should be transferred to the Public Record Office in accordance with the provisions of a disposal schedule or PROS 84/32, Transfer of Public Records to Custody of Public Record Office, and following the procedures in PROS 82/5, Procedures for the Disposition of Public Records, or PROS 82/3, Records Management Manual for Local Government.

15.2 Temporary sentenced records may, with the approval of the Keeper of Public Records, be transferred to a commercial storage establishment that has been appointed a Place of Deposit by the Minister of Property and Services under section 14 (1) of the *Public Records Act*. Permanent records or records the disposal status of which has not yet been determined may not be transferred to commercial storage.

15.3 Records may be transferred to in-house secondary storage for a period prior to destruction or transfer to the Public Record Office. The design and planning of an in-house secondary storage area should be in accordance with PROS 82/4, Guidelines for the Storage of Public Records, or PROS 82/3.

15.4 Records may be transferred to an in-house Archives or to a Place of Deposit in accordance with the provisions of a Disposal Standard.

#### 16.0 *Methods of Destruction*

16.1 Records should be destroyed by approved methods of destruction. Approved methods of destruction are:

- shredding,
- pulping,
- burning.

Burying records is not an approved method of destruction.

16.2 Destruction of records should be supervised by a public officer.

17.0 *Establishment of Standard*

17.1 In pursuance of section 12 of the *Public Records Act 1973*, I hereby establish these provisions as a Standard applying to the records of all public offices. This Standard and Forms PRO 11 a, 11 b and 29, as varied or amended from time to time, shall have effect for a period of 10 years from the Standard's date of issue and may be renewed at the expiry of that period. 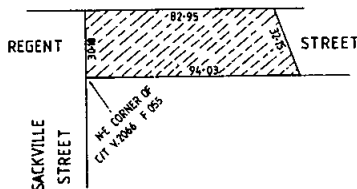
