I, the Governor of the State of Victoria, in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State, in pursuance of the powers conferred by section 15 of the *Country Fire Authority Act 1958* and all other powers me thereunto enabling and after consideration of a report by the Country Fire Authority, do by this my Proclamation vary the area of the Bairnsdale Urban Fire District by proclaiming the part of the Eleventh Fire Control region described hereunder to be an urban fire district for the purposes of the said Act:

In the Eleventh Fire Control Region:

1. Bairnsdale Urban Fire District
