General Notice

The Melbourne and Metropolitan Board of Works having made provision for carrying off the sewage of each and every property which or any part of which is situate in the Sewerage Areas hereinafter described doth hereby declare that on and after 28 April 1986 each and every property so situate shall be deemed to be a sewered property within the meaning of the *Melbourne and Metropolitan Board of Works Act 1958*—
