Historic Shipwrecks Act 1981

PROTECTION OF HISTORIC SHIPWRECKS AND RELICS

I, Jim Kennan, Minister for Planning and Environment for the purposes of the *Historic Shipwrecks Act 1981*—

(1) Declare the remains of the shipwreck *Clarence* to be a historic shipwreck as specified under section 10 (1) of the *Historic Shipwrecks Act 1981*, and the articles associated with it to be of such historic significance as to warrant their declaration as historic relics as provided for by section 10 (2) of the said Act; and

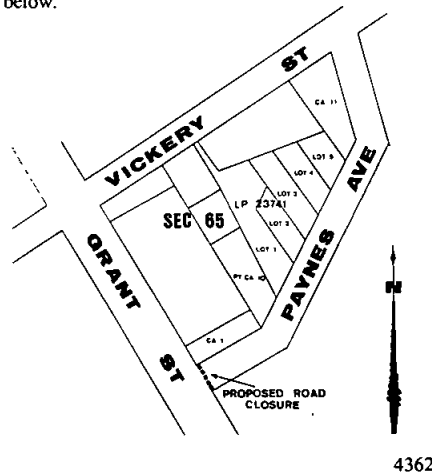
