AMALGAMATION OF THE ALFRED  
HOSPITAL, CAULFIELD HOSPITAL AND  
THE ROYAL SOUTHERN MEMORIAL  
HOSPITAL

The Governor in Council makes this order under sections 29, 30 and 42 of the *Hospitals and Charities Act 1958*:

1. Under section 25 of the *Hospitals and Charities Act 1958*, the Chief General Manager of the Department of Health has recommended to the Minister for Health that the Alfred Hospital, Caulfield Hospital and the Royal Southern Memorial Hospital ('the institutions') be amalgamated.

2. The Governor in Council—

- (a) determines that the institutions shall be amalgamated;
- (b) specifies 17 November 1987 as the date on and from which the consequences of amalgamation shall follow;
- (c) specifies the Amalgamated Alfred, Caulfield and Royal Southern Memorial Hospital as the name of the new corporation;
- (d) approves cancellation of registration of the institutions.
