(GIANT PANDA DISPLAY) REGULATIONS
1988

Notice is given of the proposal to make regulations to be known as the Zoological Parks and Gardens (Giant Panda Display) Regulations 1988.

The reason for the proposed regulations is to recover the extra costs which will be incurred as a result of staging the Giant Panda exhibition.

The objective of the proposed regulations is to establish charges for persons entering the viewing area for the Giant Panda Display at the Royal Melbourne Zoological Gardens for the period 26 March 1988 to 23 June 1988 inclusive.

A regulatory impact statement has been prepared in accordance with the provisions of the *Subordinate Legislation Act 1962*.

The results of the regulatory impact statement are

- (a) viewers of the display should contribute to the recouping of costs of the display; and
- (b) regulations are necessary to establish the charges to those viewers.
