Country Fire Authority Act 1958

VARIATION OF FIRE DANGER PERIOD

In pursuance of the powers conferred by section 4 of the *Country Fire Authority Act 1958*, I, Charles Race Thorson Mathews, Minister for Police and Emergency Services, after consultation with the Minister for Conservation, Forests and Lands hereby vary the declaration of fire danger periods previously published in the *Government Gazette* by declaring that such fire danger periods shall end in respect of the undermentioned municipalities or parts of municipalities specified.
