





Regulations RESERVE FOR CONSERVATION OF AN AREA OF NATURAL INTEREST

I, Joan Elizabeth Kirner, Her Majesty's Minister for Conservation, Forests and Lands in and for the State of Victoria under the powers conferred on me by section 13 of the Crown Land (Reserves) Act 1978 do make the following regulations for or with respect to Crown allotment 58, section B, Parish of Bumbang temporarily reserved by order in council of 25 November 1986 for conservation of an area of natural interest (hereinafter referred to as "the reserve").



- (a) As provided in clauses 26 and 27 hereof;

- (c) When the motion in the form to which the Councillor last spoke has been amended and the motion as amended is the motion then under discussion before the meeting."



The Attorney-General has made available a regulatory impact statement about a proposed statutory rule exempting the following offices from the provisions of the Freedom of Information Act.

Auditor-General

Reasons for the Proposed Rule

The objectives to be achieved by the Rule are to exempt the eight offices mentioned from the requirements of the Freedom of Information Act so that each can function without the constraint of having to respond to requests to access to documents.

The Auditor-General, Ombudsman Public Advocate and Police Complaints Authority have a primary responsibility to report to Parliament on their investigations and it is considered that the release of documents prior to making their reports could significantly prejudice their ability to conduct confidential investigations, obtain further information in the future and compromise their reporting to Parliament. A similar reason exists in respect of the Lay Observer who reports to the Law Institute and the Attorney-General.

The Victorian Government Solicitor, Director Public Prosecutions and Solicitor-General generate documents in the course of their role as legal advisers to Ministers, Government departments and agencies. Those documents are considered to be protected by legal professional priviledge and as such it is the Client Minister, Department or Agency which has the sole right to determine any question of access.

Summary of Impact Statement

The statement concludes that in the case of the Victorian Government Solicitor, Director of Public Prosecutions and Solicitor-General, the public's ability to obtain documents will be largely unaltered if the Rule is passed because access to documents can still be sought from the Client Minister, Department or Agency.

In respect of the other offices proposed for exemption, the statement assess the relative merits of exempting the offices to allow them an unfettered ability to investigate with complete confidentiality, to provide reports on their findings and to retain public confidence, against any social cost arising from the denial of access to documents held by those offices.

A By-Law of the City of St. Kilda under the provisions of the *Local Government Act* 1958 and numbered 214 for the purposes of—

- (a) Suppressing nuisances.
- (b) Regulating traffic and processions.
- (c) Generally for maintaining the good rule and government of the municipality.

In pursuance of the powers conferred by section 197 of the *Local Government Act* 1958 and of any and every other power it thereunto enabling the Mayor Councillors and Citizens of the City of St Kilda order as follows:

- 1. This By-Law may be known as the Unsolicited Material By-Law.
- 2. In this By-Law unless inconsistent with the context or subject matter:

"Authorized Officer" means the Municipal Clerk or a By-Laws Officer or a Health Surveyor of the City of St Kilda.

"Council" means the Council of the City of St Kilda.

"Land" includes property.

"Municipal District" means the municipal district of the City of St Kilda.

"Occupier" includes the person in actual occupation, his agent or the person for the time being in charge of any property.

"Owner" bears the same meaning as is ascribed to it in the Local Government Act 1958.

"Permit" means a written permit issued pursuant to the authority of the Council under the hand of an Authorized Officer.

"Person" includes the owner or occupier or the person in charge of any property, and includes an incorporated or unincorporated body or society.

"Prescribed Item" means an item package or article which does not contain on it the address of the premises it is to be or has been delivered to.

"Property" means any land dwelling or flat in separate 'ownership or separtate occupation within any area set forth in this By-Law.

"Public Place" has the same meaning as ascribed to it in the Summary Offences Act 1966.

"Restricted Letterbox" means a letterbox serving residential premises which has attached on it or placed nearby thereto in such a way as to be visible to any person placing an item package or article therein a sign inscribed with the words "No Unsolicited Material" or words to that or a similar effect.

"Vehicle" includes motor cars, trucks, motor cycles, pedal cycles, motor scooters whether registered or not.

3. Any land, dwelling or flat shall, until the contrary is proved be deemed to be in separate ownership or separate occupation for the purposes of this By-Law if it is rated separately and distinctly as one piece of land in the Rate Book of the Council.

Distribution of Notices, Advertisements, Pamphlets, Goods or Gifts

- 4. No person upon any street, footway or other public place shall without first obtaining a permit nor otherwise in accordance with the conditions of any such permit give out or distribute to bystanders or passers-by or place in or upon any vehicle standing or parked in on or upon such street, footway or public place any handbills, placards,
- notices, advertisements, books, pamphlets or papers.

 5. No person shall litter or cause or permit or suffer to be littered any streets, footway or public place by scattering, throwing down, placing or otherwise depositing or permitting or suffering to be scattered thrown down, placed or otherwise deposited upon such street, footway or public place any handbill, placard, notice advertisement, book, pamphlet or paper.
- 6. Any person giving out distributing or placing or causing, permitting or allowing to be given out or distributed to any passers-by or bystanders or vehicles or placed on any vehicles any handbills, placards, notices, advertisements, books, pamphlets or papers shall ensure at all times that the street, footway, or public place within fifty metres from the place where such items are given out distributed or placed is at all times kept clean and free from such items.
- 7. No person upon any street footway or other public place shall without first obtaining a permit nor otherwise than in accordance with the conditions of any such permit give out distribute place upon offer or make available to by-standers, passers-by or vehicles any goods, gifts, or things whatsoever whether by way of gift, sample or otherwise or offer or agree to make such goods, gifts or things available or to deliver the same to such by-stander or passer-by at his place of residence or work.

Permit Applications

- 8. Any person applying for a written permit from the Council pursuant to Clause 4 of this By-Law shall:
 - (a) Make application in writing therefore to the Council stating his name, address and age, and the name and address of the organization or association by which he is employed or which he represents.
 - (b) State precisely to which footways, streets or other public places within the municipality the applicant desires the permit to relate.
 - (c) Specify the nature and content of the bills, placards, notices, advertisements, books, pamphlets or papers to be given out, distributed or placed.

- (d) State precisely between what hours and on what day or days the applicant desires permission pursuant to this Clause.
- (e) Furnish such further and other information as the Council may require.
- Any person applying for a written permit from the Council pursuant to Clause 7 of this By-Law shall:
 - (a) Make application in writing therefor to the Council, stating his name, address and age, and the name and address of the organization or association by which he is employed or which he represents.
 - (b) States precisely to which foot-ways streets or other public places within the municipality the applicant desires the permit to relate.
 - (c) Specify precisely the goods gifts or other things to which the applicant requests the permit relate.
 - (d) State precisely between what hours and on what day or days the applicant desires permission pursuant to this Clause.
 - (e) State whether the goods, gifts or things are to be given out distributed offered or made available (stating which) to by-standers or passers-by.
- (f) State whether the goods gifts or things will be made available by way of gift sample or otherwise (stating which).
- (g) State whether any offer will be made to whether agreement will be sought (stating which) to make such goods gifts or things available to or to deliver the same to such by-stander or passer-by at his place of residence or work.
- (h) Furnish such further and other information as the Council may require.
- 10. The Council may from time to time, prescribe the form or manner in which applications under Clauses 4 and 7 of this By-Law shall be made.

Council Permits

- 11. (1) The Council may in its discretion grant any such application pursuant to this By-Law with or without conditions or may refuse to grant the same
- (2) Where a form of permit is prescribed by this By-Law or by Council Resolution substantial compliance therewith or the issue of a permit to the like effect shall be sufficient for the purposes of this By-Law.
- (3) Any such permit shall continue in force for a period of twelve (12) months from its issue or renewal or until the Council in its absolute discretion shall revoke the same and shall thereafter become null and void and of no effect unless renewed by the Council on the application in writing of the holder made prior to its expiry.
- (4) No permit shall be transferrable by the holder to any other person.

Revocation of Permits

12. If at any time the holder of any permit shall in the opinion of the Council fail to comply with all the terms and conditions of this By-Law and of such permit and the conditions thereof or if at any time in the opinion of the Council any obstruction shall be caused or the orderly flow of traffic shall be interfered with by the exercise of any rights granted by such permit or by any assemblage of persons caused thereby or in the absolute discretion of the Council, the Council considers it otherwise appropriate the Council may revoke such permit and the same shall thereafter become null and void and of no effect.

General Clauses

- 13. No person shall give out distribute or place or cause, permit, or allow or suffer to be given out or distributed to by-standers or passers-by or placed upon any vehicles any hand bills, placards, advertisements, notices, books, pamphlets or papers:
 - So as to unduly obstruct the street, road, footway or public place.
 - (2) So as to cause, permit or suffer any nuisance or other condition liable to be dangerous to health or offensive to exist at or contiguous thereto.
 - (3) So as to cause, permit or suffer any littering s, of such street, road, footway or public place.
 - (4) Any person who gives out or distributes to by-standers or passers-by or places upon any vehicles any handbills, placards, notices, advertisements, books, pamphlets or papers as aforesaid shall at all times—
 - state his name and place of abode when asked to do so by an Authorised Officer or a By-Laws Officer of the Council.
 - (ii) produce any permit granted by the Council pursuant to this By-Law to any Officer of the Council or any member of the Police Force on demand.
 - (iii) comply with and observe all other Statutes, Regulations, By-Laws or Laws applicable and in particular relating to the sale of such goods.
 - (iv) shall not exhibit erect or display any advertisement thereat or in the vicinity thereof without first obtaining the necessary consents and authorities from the Council or any other Responsible Authority.
 - (v) shall not without first obtaining a permit nor otherwise than in accordance with the conditions of any such permit shout or cry out or otherwise advertise (whether by using a public address system or otherwise) the contents of such hand bills, placards, notices, advertisements, books, pamphlets or papers.

Letterbox Distributions

- 14. (1) In this Clause 14 unless inconsistent with the context or subject matter—
 - "Council" means the Council of the Mayor Councillors and Citizens of the City of St. Kilda
 - "Person" includes an incorporated or unincorporated body or society.
 - "Prescribed item" means an item package or article which does not contain on it the address of the premises it is to be or has been delivered
 - "Restricted letter box" means a letterbox serving residential premises which has attached on it or placed nearby thereto in such a way as to be visible to any person placing an item package or article therein a sign inscribed with the words "No Unsolicited Material" or words to that or a similar effect.
- (2) No person shall deposit place or insert or cause permit or suffer to be deposited placed or inserted into any restricted letterbox an unsolicited prescribed item.
- (3) No person shall engage direct or authorise a person to deposit place or insert into any restricted letterbox an unsolicited prescribed item.
- (4) This By-Law does not apply to any statutory body or any services or deliveries provided or made by that body.
- (5) An item package or article shall not be deemed to be a prescribed item within the meaning of that phrase in this By-Law if it contains any electoral or political material advertising a candidate in an approaching federal state or municipal election.
- 15. All persons suspected of or contravening the terms of this By-Law or any permit issued thereunder or the conditions thereof shall give their names and places of abode when asked to do so by an Authorised Officer or By-Laws Officer of the Council.

Penalty

- 16. Any person guilty of any wilful act or default contrary to this By-Law or any permit issued thereunder or any condition thereof shall be liable to a penalty of not less than 1 penalty unit nor more than 10 penalty units and in addition a further penalty of not more than one penalty unit for each day on which an offence against this By-Law is continued after notice has been given to the offence or after a conviction or order of any Court, as the case may be.
- 17. In addition to any penalties any expense incurred by the Council in consequence of a breach of its By-Law shall be paid by the person committing such breach

18. This By-Law shall apply to and have operation throughout the whole of the municipal district
