#### VETERINARY SURGEONS ACT 1958 (as amended)

The Veterinary Board of Victoria on Thursday, 2 April 1987 conducted an inquiry into the conduct of Dr Mark Andrew Collier, a registered veterinary surgeon, of 30 Tourello Avenue, East Hawthorn, Victoria to ascertain whether—

- (1) on 17 February 1987 he permitted to be published in the *Lilydale and Yarra Valley Express* newspaper of 17 February 1987 an advertisement in a form calculated to place undue emphasis on parts of the advertisement in contravention of Regulation 34 of the Veterinary Surgeons Regulations 1969 (as amended);
- (2) on 17 February 1987 he permitted to be published in the *Lilydale and Yarra Valley Express* newspaper of 17 February 1987 an advertisement containing the words "Horse Owners Take Note" and his business telephone number which was calculated unfairly to attract business in contravention of Regulation 49 of the Veterinary Surgeons Regulations 1969 (as amended);
- (3) on 18 February 1987 he permitted to be published in the *Whittlesea Post* newspaper of 18 February 1987 an advertisement in a form calculated to place undue emphasis on parts of the advertisement in contravention of Regulation 34 of the Veterinary Surgeons Regulations 1969 (as amended);
- (4) on 18 February 1987 he permitted to be published in the *Whittlesea Post* newspaper of 18 February 1987 an advertisement containing the words "Horse Owners Take Note" and his business telephone number which was calculated unfairly to attract business in contravention of Regulation 49 of the Veterinary Surgeons Regulations 1969 (as amended).

The Board dismissed charges (1) and (3) and found Dr Collier guilty of charges (2) and (4). Dr Collier was fined \$100 on each charge of which he was found guilty and ordered to pay \$200 towards the cost of the injury.

*Police Regulation Act 1958*

POLICE RECRUITS

Determination No. 4 of the Police Service Board

The Police Service Board, in pursuance of the powers in that behalf conferred on it under Section 69 (2) (c) of the *Police Regulation Act 1958*, hereby makes the following Determination (that is to say):

1. The Determination No. 1 of the Police Service Board of 7 April 1986, and published in the *Government Gazette* of 23 April 1986, as amended, is hereby further amended as follows:

- 1.1 By renumbering paragraphs 11, 12 and 13 to read 12, 13 and 14.
- 1.2 By inserting the following new paragraph 11:

*Personal Injury*

"11 (1) If any recruit sustains personal injury arising out of or in the course of the discharge of duty in circumstances which under the *Accident Compensation Act 1985* or regulations pursuant to that Act make it obligatory upon the Chief Commissioner to notify the Accident Compensation Commission or the State Insurance Commissioner or other approved Claims Administration Agent of that Commission of such injury and the liability to make weekly payments for compensation is admitted by the Accident Compensation Commission or the State Insurance Commissioner or other approved Claims Administration Agent of that Commission or the Accident Compensation Tribunal determines that such payments shall be made in respect of the incapacitation of the injured recruit from all duty, such recruit shall apart from any sick leave which may be standing to the recruit's credit, be granted leave on full pay less the amount paid by way of weekly compensation by the Accident Compensation Commission or the State Insurance Commissioner or other approved Claims Administration Agent of that Commission during the incapacity.

(2) No leave shall be granted under this paragraph in respect of any particular injury or incapacity which is—

- (a) in excess of a continuous period of fifty-two weeks inclusive of any other leave which may be granted with pay; or
- (b) in excess of any aggregate period of fifty-two weeks in respect of any particular injury or incapacity.

(3) A recruit whose employment is terminated during a period for which leave had been granted under this paragraph shall continue to be paid in accordance with the provisions of sub-paragraph (1) until the cessation of the period of leave which would have been granted had the employment not been terminated. Provided that such period of payment after termination shall not count for the purposes of accrual of any other leave entitlements nor shall it count as a period of service for any purpose.

(4) A recruit who has been granted leave under this paragraph shall immediately notify the Chief Commissioner in writing of any civil claim for damages instituted by the recruit in connection with the injury to which such leave relates.

(5) If a recruit who has received leave under sub-paragraph (1) obtains a judgment or settlement of a claim for civil damages in connection with the injury for which such leave is granted the recruit shall repay any payments made under this paragraph to the extent that the judgment or settlement is not reduced by the amount of such payments."

##### CREDIT ORDER No. 15—TERM LOANS

1. This Order may be cited as the "Credit Order No. 15—Term Loans".

2. This Order shall take effect on and from 1 May 1987.

##### Interpretation

  - (d) the amount of the credit charge is variable; or
  - (e) the method by which the credit charge is determined is variable—
- but does not include the provision of credit by way of overdraft.

**Term Loan—Exemption**

4. Parts III–VIII of the *Credit Act* 1984 do not have effect in relation to—

- (a) the provision of credit under a term loan entered into by a bank, not being a term loan that is subject to a predetermined credit charge and no other credit charge; and
- (b) related matters preliminary to, and consequential upon, the provision of that credit.

should by reason of their being dangerous, be prohibited.

And whereas I, Peter Cornelis Spyker, Minister for Consumer Affairs believe that the supply of goods of that class or description ought, in the interests of the safety of the public, be prohibited immediately.

Now therefore I, Peter Cornelis Spyker, Minister for Consumer Affairs pursuant to the powers conferred on me by section 57C of the *Consumer Affairs Act 1972* hereby make an interim order prohibiting the supply in Victoria of goods, namely—

#### DETERMINATION

This Determination is made by the Victorian Dairy Industry Authority under the powers conferred by section 44 of the *Dairy Industry Act 1984* after consultation with the Prices Commissioner and shall come into operation on 1 May 1987.

The Determinations of milk prices made by the Victorian Dairy Industry Authority and published in the *Government Gazettes* dated 6 November 1986 and 11 March 1987 are hereby revoked.

#### DETERMINATION

##### Part 1

##### PRICES PAYABLE FOR SALES OF MILK

The prices payable for sales of daily pasteurised milk in all Milk Districts other than the Border Milk District shall be in accordance with Schedule 1.

The prices payable for sales of packaged milk in the Border Milk District shall be in accordance with Schedule 2.

The retail price for sales of packaged Ultra Heat Treated Milk in all Milk Districts shall not be less than the prices shown in Schedule 3.

The prices payable for milk and milk products in the package types as shown in column 1 of the attached schedules shall be as indicated in the appropriate columns according to the category of sale.

The categories of sale are defined as:

1. Wholesale sales are those from a processor to a delivery dairyman.
2. Semi-wholesale sales are those from a dairyman to a milk shop, or other approved person.
3. Retail sales are sales by a dairyman or a milk vendor of not more than 16 litres to a person on any one day, or any sale made by a licensed milk shop.
4. Vending machine sales are retail sales from an automatic vending machine. The maximum retail price for vending machine sales of unflavoured milk shall be at the nearest five (5) cent multiple above the maximum gazetted retail price. Refer section 24 (2) and (3) of the *Dairy Industry Act 1984* for licensing requirements.
5. For Border Milk District, Vendor sales are those by dairymen to milk vendors in the Border Milk District who do not operate licensed dairy premises. The price of plain milk to vendors in the Border Milk District shall be set at the rate of 75 per cent of the gazetted retail prices for the Border Milk District.

6. An institutional sale is a sale by a dairyman or vendor to:

(a) A charitable institution or benevolent society which is either exempt and/or registered under the Hospital and Charities Act and subsidised by the Health Department of Victoria for maintenance purposes; or

(b) An institution which is operated under the Community Welfare Services Act.

7. Sales to institutions by dairymen shall be at the rate of 95 per cent gazetted maximum semi-wholesale delivered price.

8. Delivered sales are those where milk is delivered to the premises of the purchaser by the seller or his agent.

All persons conducting business as a dairy, factory, store, milk processor, milk vendor, milk carrier, milk shop or any combination of the foregoing are required to hold a current and valid dairy industry licence pursuant to section 24 of the *Dairy Industry Act 1984*.

#### Part 2

#### PRICES PAYABLE FOR MILK SUPPLIED BY DAIRYFARMERS

The Authority has determined that the price to be paid to dairyfarmers for milk supplied by dairyfarmers and accepted by the Authority for sale or distribution in Victorian Milk Districts shall be 32.45 cents per litre.

#### Part 3

#### PRICES PAYABLE FOR MILK SUPPLIED TO PROCESSORS BY THE AUTHORITY

The Authority has determined that the following prices must be paid for milk sold by the Authority to milk processors.

(a) Standardised raw milk for processing as daily pasteurised milk available for sale in Victoria will be 40.91 cents per litre.

(b) Standardised raw milk for processing into unflavoured Ultra Heat Treated milk for sale in Victoria will be 38.99 cents per litre.

(c) Standardised raw milk for processing into flavoured Ultra Heat Treated milk for sale in Victoria will be 37.99 cents per litre.

#### Part 4

#### MINIMUM AND MAXIMUM DETERMINED PRICES

In accordance with section 44 of the *Dairy Industry Act 1984*, the minimum prices set out in this Determination to be paid for market milk (other than flavoured milk and UHT milk) sold by wholesale and semi-wholesale or retail, are not more than 3 per cent lower than the related maximum prices fixed in a previous Determination.

#### Part 5

#### FEDERAL SALES TAX ON FLAVOURED MILK

Federal sales tax, levied under Assessment Act No. 1 section 70A is included in minimum retail prices shown in Schedules 1 and 3 and in retail prices shown in Schedule 2.

Wholesale delivered prices and semi-wholesale delivered prices as gazetted in Schedule 2 do not include Sales Tax. Federal Sales Tax must be charged separately where applicable by addition to these prices unless a Sales Tax Exemption is quoted by the purchaser.

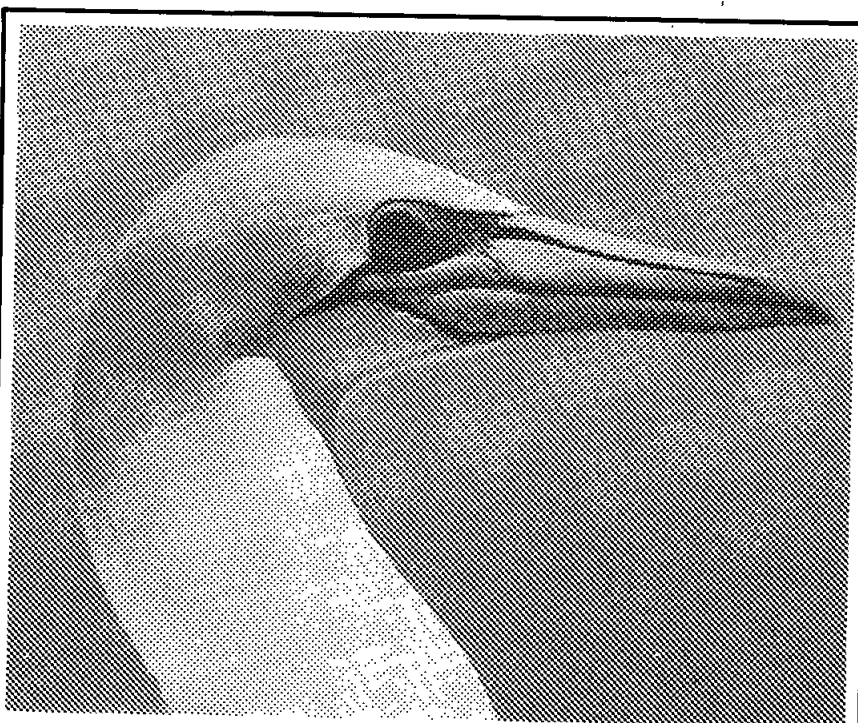

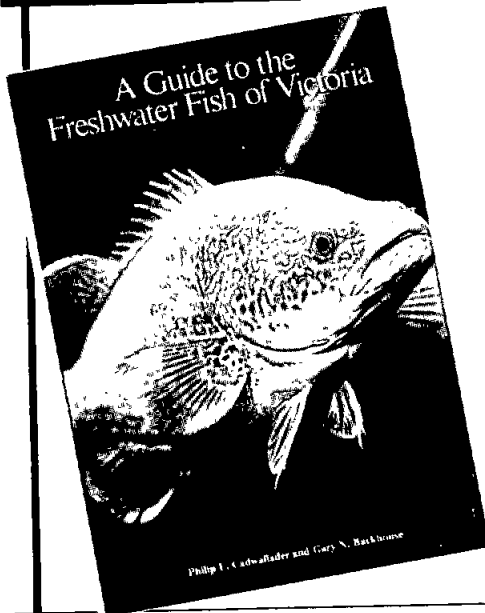

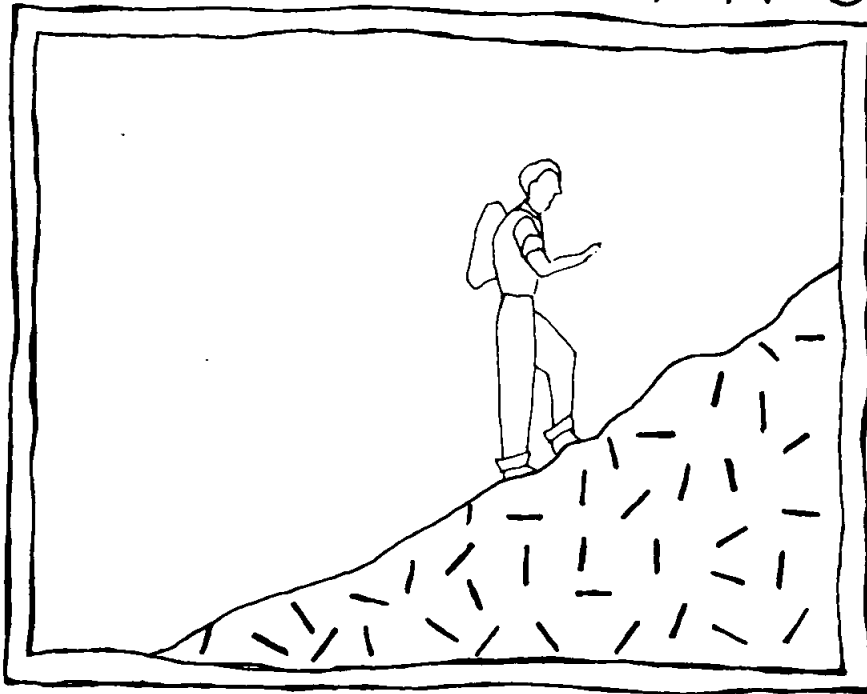
