Films Act 1971

EXEMPTION UNDER SECTION 11 (2)

Under the powers found in section 11 (2) of the *Films Act 1971*, the Governor in Council exempts the films set out in the schedule below from the provisions of Part II of the *Films Act 1971*, subject to the following conditions:

1. That the films be exhibited only by the Australian Film Institute at the "New Cinema Poland Festival" in Melbourne from 2 July 1987 to 13 July 1987, inclusive, an event approved by

the Attorney-General of the Commonwealth for the purposes of Part III of the Customs (Cinematograph Films) Regulations of the Commonwealth of Australia;

2. That the films are screened not more than three times during the course of the event;
3. That the films be exported or delivered to the holder of a permission in respect of the films within 6 weeks of the conclusion of the event;
4. That the films are not screened other than before a subscription audience; and
5. That no person under the age of 18 years is admitted to the screening of the films.

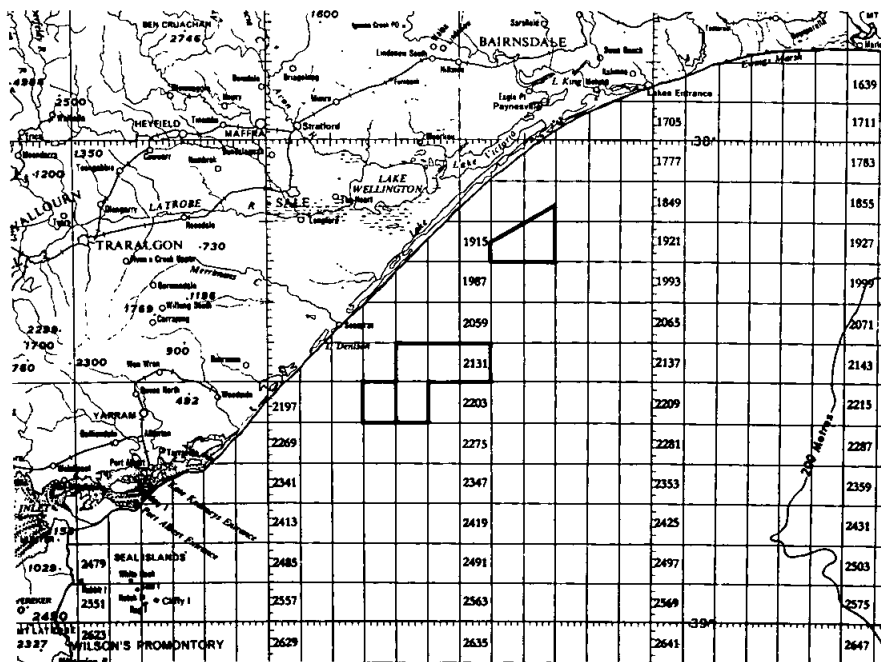

Poultry

- (i) The keeping of animals, birds and poultry in specified areas and conditions as summarised hereunder.
- (ii) Part I states the By-law shall have effect—
 - (a) within the areas defined by the Rural Water Commission as the urban water supply district boundaries of the Townships of Manangatang, Piangil, Chinkapook, Chillingollah, Woorinen South, Ultima, Lake Boga, Nyah and Nyah West;
 - (b) within the residential, commercial and industrial zones of the Shire of Swan Hill Robinvale Planning Scheme;
 - (c) within the residential zone of the Shire of Swan Hill Castle Donnington Planning Scheme—

and also details when the By-law shall come into operation and prescribes a number of specific definitions for words and terms included in the By-law.

- (iii) Part II prescribes the provisions relating to the keeping of animals and the need to obtain a permit from council for keeping same on normal size allotments. It also states that no nuisance dangerous, injurious or offensive to health conditions are caused by the keeping of any animal, cat or dog, and details the minimal distances from property boundaries on which stables may be constructed.
- (iv) Part III prescribes the provisions relating to keeping dogs and cats and the need to obtain a permit from council for keeping a dog on a minimal size allotment. It also prescribes the distances from property boundaries where kennels or catteries may be sited.
- (v) Part IV prescribes the provisions relating to keeping poultry and birds and details the respective maximum number of poultry that may be kept. It also details that poultry houses must be located on well drained ground and prescribes the minimum areas and distances from boundaries under which they may be constructed.
- (vi) Part V prescribes the provisions relating to keeping horses, asses and mules and the need to obtain a permit from council for the keeping of same in prescribed areas of the shire. It also prescribes that—
 - (a) persons seeking such permit must provide a description of the animal and written agreement of the owners

- of other land within a twenty-five (25) metre distance of the property boundary;
- (b) the property on which the animal is kept to be well drained and securely fenced;
- (c) Council may revoke previously issued permits;
- (d) stables shall be constructed to an approved standard;
- (e) manure refuse and rubbish from properties on which stables are erected shall be placed in properly constructed impervious containers which are constantly covered, maintained in a good state of repair and effectively deodorised;
- (f) the contents of the receptacles shall be removed at least weekly or more frequently if required.
- (vii) Part VI general provisions prescribe—
 - (a) council may impose such conditions as considered necessary when granting consents and may also revoke such consent at any time;
 - (b) council may approve of stables and structures in use prior to the introduction of the By-law;
 - (c) the responsibilities of owners and occupiers of properties on which any dog, cat, animal, bird or poultry is kept to ensure no offensive, dangerous or injurious to health are caused;
 - (d) a requirement for the appropriate treatment or proper disposal of any dog, cat, animal, bird, or poultry which develops any infectious disease;
 - (e) a requirement for the control of objectionable noises at unreasonable times for any dog, cat, animal, bird or poultry;
 - (f) a requirement for the proper storage on properties of foodstuff for any dog, cat, animal, bird or poultry;
 - (g) a requirement to prevent the harbourage of rats and other vermin around poultry houses, pigeon lofts, bird cages and animal enclosures and the regular removal of bird droppings, litter and refuse from such premises;
 - (h) a requirement for the proper construction, maintenance and drainage of every kennel, cattery, stable, pen, poultry house, pigeon loft or bird cage;

- (i) a requirement for owners or occupiers to comply within the prescribed time with orders issued under the By-law;
- (j) council's powers concerning orders issued under the By-law;
- (k) that persons giving false or misleading information in applications for approval under the By-law, are guilty of an offence against the By-law;
- (l) the penalties for offences against the provisions of the By-law shall be a maximum of ten (10) penalty units and one (1) penalty unit per day for a continuing offence.

By-Law No. 64

Keeping of Fowls

A By-Law of the City of Croydon made under the provisions of the *Local Government Act 1958* and the *Health Act 1958* for the purpose of:

- (a) providing for the health of the residents in the municipal district and against the spread of contagious or infectious diseases.
- (b) suppressing nuisances.
- (c) regulating the keeping of fowls with power to limit the number of fowls kept on any property.
- (d) regulating or prohibiting the keeping of any place, or storage of any things which in the opinion of the council may be offensive injurious to health or dangerous.
- (e) fixing, subject to Part IV of the *Health Act 1958* the distance from any dwelling within which it shall be unlawful to keep any animal.

In pursuance of the powers conferred by the *Local Government Act 1958* the *Health Act 1958* and every other power it thereunto enabling the Mayor Councillors and Citizens of the City of Croydon hereby order as follows:

Part I—General

1. This By-Law shall be known as the Keeping of Fowls By-Law and shall come into operation on the day after the date upon which notice of its making is published in the *Victoria Government Gazette*.

2. In this By-Law unless inconsistent with the context or subject matter:

- (a) 'Approved materials' includes masonry concrete reinforced concrete iron or other hard and incombustible materials approved by the council.
- (b) 'authorised officer' means a Health Surveyor or a By-Laws Officer of the Council.
- (c) 'Council' means the council of the municipality of the City of Croydon.
- (d) 'dwelling' includes any building or structure, intended, used, adapted, or designed for use by people for the purpose of living therein and includes a portion of a building used intended adapted or designed for use as a dwelling and further includes a living room, sleepout, tent, caravan and all rooms for sleeping living or cooking.
- (e) 'Fowl' includes any fowl poultry, duck, turkey, goose, gander, rooster or the like.

(f) 'litter' includes wood shavings . . . straw or dry grass clippings or other similar suitable clean material satisfactory to an authorised officer.

(g) 'Municipal district' means the municipal district of the City of Croydon.

(h) 'permit' means a permit in writing issued pursuant to the provisions of this By-Law.

(i) 'property' means any land dwelling or flat or unit in separate ownership or separate occupation within the municipal district.

3. (1) Any land or dwelling shall, until the contrary is proved, be deemed to be in separate ownership or separate occupation for the purposes of this By-Law if it is rated separately and distinctly as one piece of land in the Rate Book of the Council.

(2) This By-Law shall apply to and have operation throughout those parts of the municipal district which at the date of commencement of this By-Law are zoned for residential purposes under the provisions of the City of Croydon Planning Scheme 1961 which are declared for the purposes of this By-Law to be populous or residential areas.

(3) By-Law No. 126 of the Shire of Lillydale in so far as it relates to the municipal district is hereby repealed.

Part II—Fowl

4. A person shall not keep cause or permit to be kept or suffer to remain more than six (6) fowl on any property having an area of less than 0.25 hectares.

5. A person shall not keep cause or permit to be kept or suffer to remain more than six (6) fowl on any property without a written permit.

6. A person shall not keep cause or permit to be kept or suffer to remain any fowl on any property otherwise than in a fowl house which complies with the requirements of this By-Law.

7. Every fowl house shall:

(a) have an area in square metres of not less than the product of the number of fowl multiplied by 2/5ths.

(b) be roofed with galvanised iron or other approved material.

(c) be paved with concrete at least 75 millimetres thick and with the surface of such paving being at least 75 millimetres above the surrounding ground level at all points and coved to a height of 75 mm internally with adequate vermin proof drains.

(d) have the external walls including the door thereof constructed of approved material to a height of one metre minimum above

the floor area. Wire netting may be used above such height to the roof level.

(e) be rendered rat proof by placing galvanised iron, jointed brick work or concrete around the foundations to a depth of 0.5 metres below ground level.

(f) be constructed and maintained to prevent the escape of any fowl.

8. A fowl house may have attached thereto a fowl run which is enclosed by wire netting provided that it is maintained in such a manner as to prevent the escape of fowl therefrom.

9. Every fowl house or fowl run shall be sited:

(a) at least 8 metres from the nearest point of any dwelling.

(b) at least 2 metres from the boundary of any adjoining allotment of land.

(c) at least 12 metres from the boundary of any street or road to which the land has frontage.

Part III—Cleanliness

10. The owner and occupier of any property on which a fowl house is erected or fowl are kept shall—

(a) ensure that the ground surrounding any fowl house or fowl run is well drained to the satisfaction of an authorised officer.

(b) keep the area of land within 3 metres of any fowl house or fowl run upon the property free from all dry grass, weeds, refuse, rubbish or other materials capable of harbouring rats or vermin.

(c) ensure that all food for consumption by any fowl is kept or stored in rat proof receptacles or rat proof buildings.

(d) cause any fowl house or fowl run thereon and the area of the property within two metres thereof to be thoroughly cleansed from time to time as often as may be necessary and shall keep the same at all times in a clean and sanitary condition to the satisfaction of an authorised officer.

(e) cause any fowl kept thereon which suffers from any infectious disease communicable to man to be forthwith destroyed and disposed of to the satisfaction of an authorised officer.

(f) every fowl house shall be regularly cleaned and all manure and other matter be removed and dispersed to the satisfaction of an authorised officer.

(g) ensure that no feathers, carcass or part of any carcass or litter is burnt in such a manner as to cause a nuisance or to be offensive, injurious to health or dangerous.

(h) ensure that the floor of the fowl house are at all times covered to a depth of 20 millimetres with litter.

11. Any person applying for a permit pursuant to the provisions of this By-law shall—

(a) lodge with the council—

(i) an application in writing in the form of the Second Schedule hereto.

(ii) a block plan of the property referred to in such application with the measurements and showing delineated thereon the portion of the property on which it is intended to keep fowl.

(iii) such other further or additional information as the council may require.

(b) at least fourteen (14) days before such application is lodged notify the owner and occupier of all properties adjoining or abutting the property in respect of which the application is made of his intention to apply for such a permit by means of a notice in the form of the First Schedule and when required by the council advertise his intention to so apply in a newspaper circulating generally within the municipal district in the prescribed form.

(c) lodge a copy of such notification together with proof to the satisfaction of an authorised officer of compliance with the notification requirements of this By-Law at the time that he makes the application as aforesaid.

12. Any person interested in or affected by such application may object to the council in writing within 14 days of the publication of the Notice of Intention to Apply for a Permit stating the grounds of his objection.

13. Every such application shall be considered by the council together with any objections to the granting of the permit received by it up to the time of making its determination and the council may in its discretion grant or refuse the permit applied for with or without conditions.

14. Any permit given under this By-Law shall be given in the form of the Third Schedule hereto under the hand of the Municipal Clerk or his deputy and such permit shall remain in force until the same is revoked or cancelled by the council under this By-Law.

Part V—Permit Revocation

15. The Council may at any time revoke or cancel any permit by dispatching by pre-paid post to the person to whom such permit was granted to his address stated in his application or last

known to the council or serving personally upon him notice in writing of such revocation or cancellation if in the opinion of the council:

- (a) any fowl is kept so as to cause a nuisance or other condition liable to be dangerous to health or offensive.
- (b) by reasons of any alteration to the property the permit should be revoked or cancelled.
- (c) there has been a breach of any of the provisions of this By-Law or of any of the conditions of the permit (whether or not any legal proceedings should be taken in respect of such breach), or
- (d) there is any justifiable complaint by any resident of the municipal district to the keeping of any fowl.

16. Any revocation of permit or notice shall be valid if given under the hand of the Municipal Clerk or his deputy.

Part VI—General

17. The owner or occupier of any property shall not allow or cause or suffer to remain on such property any fowl or any building structure or enclosure which does not comply with provisions of this By-Law.

18. All persons suspected of or contravening the terms of this By-Law shall give their names and places of abode when asked to do so by a By-Laws Officer or an authorised officer at the Council.

19. Any person who wilfully gives false or misleading information in a Notice of Intention to Apply for a permit or in any application for a permit shall be guilty of an offence against this By-Law.

20. Any person guilty of any wilful act or default contrary to any of the provisions of this By-Law or contrary to the conditions of any permit granted pursuant to this By-Law shall be liable to a penalty of not less than two penalty units nor more than ten penalty units and in addition a further penalty of not more than one penalty unit for each day on which an offence against this By-Law is continued after notice has been given to the offender by the Council of the Department of the offence or after a conviction or order by any Court, as the case may be.

21. In addition to any penalty imposed under Clause 20 hereof, any expense incurred by the council in consequence of a breach of this By-Law shall be paid by the person committing such breach.
