ABATTOIR AND MEAT INSPECTION (AMENDMENT NO. 2) REGULATIONS 1987

It is proposed to amend Regulations made under the *Abattoir and Meat Inspection Act 1973*. The object of this amendment is to provide a more equitable means for recouping meat inspection services in abattoirs.

A Regulatory Impact Statement has been prepared, as required by the *Subordinate Legislation Act 1962*. As a result of preparing that Statement, it is concluded that the regulations are necessary to achieve greater equity by revising the formula for charging fees on a 'per-carass' basis for the various species of animals slaughtered in abattoirs.

Credit (Amendment No. 2) Regulations 1987

A Regulatory Impact Statement has been prepared relating to proposed amendments to Regulations under the *Credit Act 1984*.

certain fees and charges may be included in the amount financed in relation to credit sale contracts, loan contracts, and continuing credit contracts secured by mortgages over property. statements of rates of interest expressed otherwise than as an annual percentage rate are prohibited.

two further print types in common usage may be used in documents under the Credit Act.

These changes have already been implemented in New South Wales and Western Australia.

The Regulatory Impact Statement has been prepared in accordance with the *Subordinate Legislation Act 1962* and concludes that the Regulations should be made. **Futures Industry (Application of Laws)
Regulations 1987**

Citation

1. These Regulations may be cited as the Futures Industry (Application of Laws) Regulations 1987.

Objective

2. The objective of these Regulations is to make the necessary modifications for the application in Victoria of amendments to the Futures Industry Regulations of the Commonwealth made under the *Futures Industry Act 1986* of the Commonwealth.

Authorising Provision

3. These Regulations are made under section 14 of the *Futures Industry (Application of Laws) Act 1986*.

Definition

4. In these Regulations 'the Act' means the *Futures Industry (Application of Laws) Act 1986*.

Amendment of Schedule 2 to the Act

5. (1) In Schedule 2 to the Act, after clause 6A insert—

6AB. In Regulation 37—

- (a) in paragraph (a) after "1974" there were inserted "of the Commonwealth"; and
- (b) in paragraph (b) after "1973" there were inserted "of the Commonwealth"; and
- (c) in paragraph (c) after "1945" there were inserted "of the Commonwealth".

6AC. In Regulation 38 (1)—

- (a) for "Companies Regulations" there were substituted "Companies (Victoria) Regulations"; and
 - (b) for "that Act" there were substituted "that Code".

Title

1. These Regulations may be cited as the National Companies and Securities Commission (State Provisions) (Amendment) Regulations 1987.

Objective

Authorising Provision

3. These Regulations are made under sections 6, 15, 16, 17 and 21 of the *National Companies and Securities Commission (State Provisions) Act 1981*.

Principal Regulations

4. In these Regulations, the *National Companies and Securities Commission (State Provisions) Regulations 1981 are called the Principal Regulations.

Amendment of Principal Regulations

5. (1) At the end of Regulation 5 of the Principal Regulations insert '*Futures Industry (Application of Laws) Act 1986*'.

(2) At the end of Regulation 6 of the Principal Regulations insert '*Futures Industry (Application of Laws) Act 1986*'.

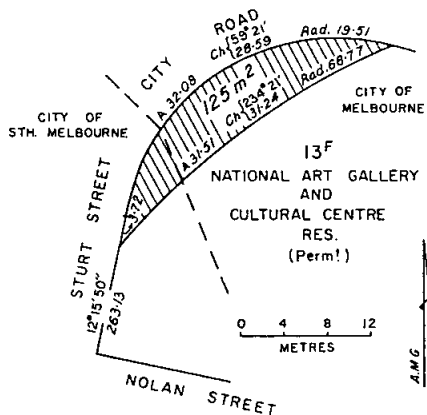

- (iii) the Foundation aims to establish trust and maintain confidentiality with new clients to overcome their paranoia, anxiety and fear;
- (iv) it has been the experience of the Foundation that some clients, particularly prostitutes, lesbians and male homosexuals, have definite preferences as to whom they can confide in initially;
- (v) the Foundation aims to eventually work through preferences by sharing cases but initially the importance of "matched" client/counsellor has resulted in speedier resolution of past traumas—

and determined that the exemption requested was desirable.

The Board hereby grants an exemption from the operation of section 21 (1) (a) and (c) and section 59 of the *Equal Opportunity Act 1984* to permit the Buoyancy Foundation of Victoria to advertise for and appoint male or female social workers as the circumstances require in order to maintain a balance of the sexes in its staff of social workers.

This exemption shall remain in force until 5 June 1990.

By-Law No. 215

Dog Litter By-Law

A By-Law of the City of St. Kilda under the provisions of the *Local Government Act* 1958 and numbered 215 for the purposes of:

- (a) Providing for the health of the residents in the municipal district and against the spreading of contagious or infectious diseases;
- (b) Suppressing nuisances;
- (c) Generally for maintaining the good rule and government of the municipality.

In pursuance of the powers conferred by section 197 of the *Local Government Act* 1958 and of any and every other power it thereunto enabling the Mayor Councillors and Citizens of the City of St. Kilda order as follows:

Title

1. This By-Law may be known as the "Dog Litter By-Law".
2. In this By-Law unless inconsistent with the context or subject matter—

"Authorised Officer" means the Municipal Clerk, By-Laws Officer or an Officer authorised by the City of St. Kilda.

"Council" means the Council of the City of St. Kilda.

"Dog" shall include any dog whatsoever of any one or more breeds or of no discernable breed, whether of registrable age pursuant to the provisions of the *Dog Act* 1970 as amended or not.

"Dog Litter" means dog excrement of whatsoever nature including dog faeces and dog urine.

"Land" includes property.

"Municipal District" means the municipal district of the City of St. Kilda.

"Occupier" includes the person in actual occupation, his agent or the person for the time being in charge of any property.

"Person" includes the owner or occupier or the person in charge of any property, and includes an incorporated or unincorporated body or society, and references to the singular or plural number shall include the plural and singular number respectively.

"Property" means any land dwelling or flat in separate ownership or separate occupation within any area set forth in this By-Law.

"Public Places" has the same meaning as ascribed to it in the *Summary Offences Act* 1966.

"Street" or "Road" respectively means a street or road whether or not a public highway, and includes every public highway.

3. Any land, dwelling or flat shall, until the contrary is proved be deemed to be in separate ownership or separate occupation for the purposes of this By-Law if it is rated separately and distinctly as one piece of land in the Rate Book of the Council.

Liability for Removal of Dog Litter

4. The owner, or any person apparently in charge or control, of any dog at the time at which such dog deposits excretes or in any other manner whatsoever creates any dog litter in on or upon any street road or public place, shall be liable for the removal of such dog litter from such street road or public place, whether or not at the time of such deposit excretion or creation such dog was under or apparently under human control.

5. The person liable pursuant to Clause 4 herein for the removal of dog litter from any street road or public place shall remove or cause to be removed such dog litter forthwith once he becomes or should reasonably become aware of the existence of such dog litter; and shall remove or cause to be removed the dog litter and in so doing shall take all reasonable steps to ensure no

nuisance or condition which is offensive or liable to be dangerous to health is caused thereby.

6. Any person guilty of any act or default contrary to the provisions of clauses 4 and 5 of this By-Law shall be guilty of an offence against this By-Law and shall be liable to a penalty of not less than one penalty unit nor more than 10 penalty units and in addition a further penalty of not more than one penalty unit for each day on which the offence against this By-Law is continued after notice has been given to the offender by the Council of the commission of the offence or after a conviction or order of any Court, as the case may be.

7. For the purposes of any proceedings pursuant to the provisions of this By-Law, where a dog is registered with the Council pursuant to the provisions of the *Dog Act* 1970 as amended, such registration shall be proof of ownership of the dog by the person registered as owner; and evidence that immediately before depositing excreting or creating any dog litter the said dog was following, or had issued from the property occupied by, such person shall be prima facie proof that he is the owner of the dog.

8. The owner of any dog in respect of which a complaint has been made, whether or not such dog be registered or of registrable age pursuant to the provisions of the *Dog Act* 1970 as amended, shall bear the onus of proof that some other person was in charge or control of the dog at the time the dog litter in respect of which the complaint is made was deposited excreted or created.

General

9. All persons suspected of or contravening the terms of this By-Law shall give their names and places of abode when asked to do so by an Authorised Officer or By-Laws Officer of the Council.

10. In addition to any penalties, any expense incurred by the Council in consequence of a breach of this By-Law shall be paid by the person committing such breach.

11. This By-Law shall apply to and have operation throughout the whole of the Municipal district.

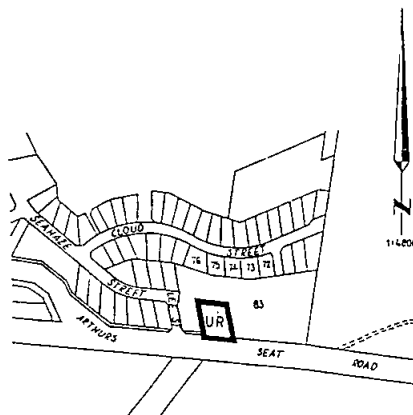

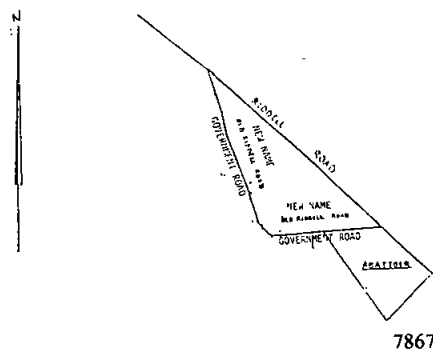

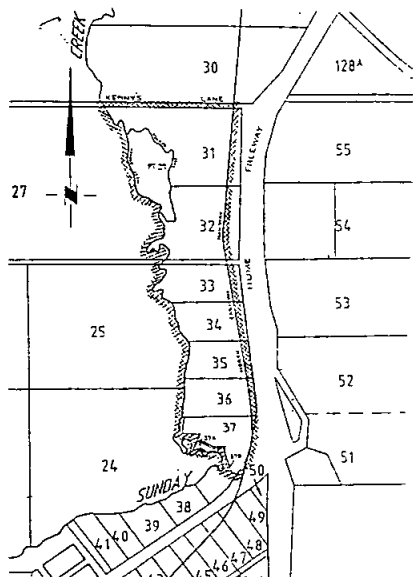
