hereby declares that the existing drains (or  
portions thereof) within the Metropolis described  
in Parts I to V inclusive of the Schedule hereto  
shall be main drains under and for the purposes  
of the said Act.

## The Schedule

The following is a description of the courses of and a specification of the points of commencement and termination of the existing drains. The co-ordinates are based on Australian Map Grid Zone 55.

## Part I

Commencing at a point north of Thompsons Road with co-ordinates of N 5816 779 and E 330 953 and bearing 129° 36' for a distance of 116 m, thence on a 400 m radius curve for a distance of 292 m to a point with co-ordinates of N 5816 614 and E 331 312. From this point on a bearing of 87° 48' for a distance of 578 m and thence on a 600 m radius curve for a distance of 729 m to a point with co-ordinates of N 5816 267 and E 332 467. From this point on a bearing of 157° 24' for a distance of 231 m and thence on a 400 m radius for distance of 325 m to a point with co-ordinates of N 5815 833 and E 332 783 and thence on another 400 m curve of a distance of 174 m terminating at a point south of Doncaster Road with co-ordinates of N 5815 739 and E 332 927.

## Part II

Commencing at a point near Kosciusko Road with co-ordinates of N 5816 499 and E 331 342 and thence north for distance of approximately 115 m and terminating at the Koonung Creek underground drain.

## Part III

Commencing at a point near the corner of Outhwaite Avenue and Park Avenue with co-ordinates of N 5816 411 and E 332 568 and thence south west for a distance of approximately 153 m and terminating at the Koonung Creek underground drain.

## Part IV

Commencing at a point at the rear of the properties in Gardenia Road with co-ordinates of N 581 6055 and E 332 517 and thence easterly for a distance of approximately 36 m and terminating at a point on the Koonung Creek underground drain with co-ordinates of N 5816 065 and E 332 548.

## Part V

Commencing at a point near the corner of High Street and Doncaster Road with co-ordinates of N 5815 827 and E 332 932 and thence south west for a distance of approximately 90 m and terminating at the Koonung Creek underground drain at a point with co-ordinates of N 581 5808 and E 332 843.

**DETERMINATION**

This Determination is made by the Victorian Dairy Industry Authority under the powers conferred by section 44 of the *Dairy Industry Act 1984* after consultation with the Prices Commissioner and shall come into operation on 14 September 1987.

The Determinations of milk prices made by the Victorian Dairy Industry Authority and published in the *Government Gazette* dated 29 April 1987 and 1 July 1987 are hereby revoked.

**Part I**

**PRICES PAYABLE FOR SALES OF MILK**

The prices payable for sales of daily pasteurised milk in all Milk Districts other than the Border Milk District shall be in accordance with Schedule 1.

The prices payable for sales of packaged milk in the Border Milk District shall be in accordance with Schedule 2.

The retail price for sales of packaged Ultra Heat Treated Milk in all Milk Districts shall not be less than the prices shown in Schedule 3.

The prices payable for milk and milk products in the package types as shown in column 1 of the attached schedules shall be as indicated in the appropriate columns according to the category of sale.

The categories of sale are defined as:

1. Wholesale sales are those from a processor to a delivery dairyman.
2. Semi-wholesale sales are those from a dairyman to a milk shop, or other approved person.
3. Retail sales are sales by a dairyman or a milk vendor of not more than 16 litres to a person on any one day, or any sale made by a licensed milk shop.
4. Vending machine sales are retail sales from an automatic vending machine. The maximum retail price for vending machine sales of unflavoured milk shall be at the nearest five (5) cent multiple above the maximum gazetted retail price. Refer section 24 (2) and (3) of the *Dairy Industry Act 1984* for licensing requirements.
5. For Border Milk District, Vendor sales are those by dairymen to milk vendors in the Border Milk District who do not operate licensed dairy premises. The price of plain milk to vendors in the Border Milk District shall be set at the rate of 75% of the gazetted retail prices for the Border Milk District.
6. An institutional sale is a sale by a dairyman or vendor to:
  - (a) A charitable institution or benevolent society which is either exempt and/or registered under the Hospitals and Charities Act and subsidised by the Health Department of Victoria for maintenance purposes; or
  - (b) An institution which is operated under the Community Welfare Services Act.
7. Sales to institutions by dairymen shall be at the rate of 95% gazetted maximum semi-wholesale delivered price.
8. Delivered sales are those where milk is delivered to the premises of the purchaser by the seller or his agent.

All persons conducting business as a dairy, factory, store, milk processor, milk vendor, milk carrier, milk shop or any combination of the foregoing are required to hold a current and valid dairy industry licence pursuant to section 24 of the *Dairy Industry Act 1984*.

## Part 2

## PRICES PAYABLE FOR MILK SUPPLIED BY DAIRYFARMERS

The Authority has determined that the price to be paid to dairyfarmers for milk supplied by dairyfarmers and accepted by the Authority for sale or distribution in Victorian Milk Districts shall be 32.45 cents per litre.

## Part 3

## PRICES PAYABLE FOR MILK SUPPLIED TO PROCESSORS BY THE AUTHORITY

The Authority has determined that the following prices must be paid for milk sold by the Authority to milk processors.

- (a) Standardised raw milk for processing as daily pasteurised milk available for sale in Victoria will be 40.91 cents per litre.
- (b) Standardised raw milk for processing into unflavoured Ultra Heat Treated milk for sale in Victoria will be 38.99 cents per litre.
- (c) Standardised raw milk for processing into flavoured Ultra Heat Treated Milk for sale in Victoria will be 37.99 cents per litre.

## Part 4

## MINIMUM AND MAXIMUM DETERMINED PRICES

In accordance with section 44 of the *Dairy Industry Act 1984*, the minimum prices set out in this Determination to be paid for market milk (other than flavoured milk and UHT milk) sold by wholesale and semi-wholesale or retail, are not more than 3% lower than the related maximum prices fixed in a previous Determination.

#### REGULATORY IMPACT STATEMENT

##### Land Acquisition and Compensation Regulations

It is proposed to make regulations under the *Land Acquisition and Compensation Act* 1986. The broad objective of the regulation is to prescribe the minimum matters necessary to give full force and effect to the Act. The specific objectives of the regulations are:

- (a) to prescribe classes of land for which reservation under a planning scheme for a public purpose is not required prior to commencement of acquisition;
- (b) to ensure that exemptions from the requirement of reservation under a planning scheme enable efficient acquisition procedures by governmental agencies, whilst also providing an adequate level of protection for landowners;
- (c) to prescribe forms and statements and fees for lodging documents under section 10 (1) of the Act; and
- (d) to ensure that the fee levels prescribed reflect the costs of processing documents and complying with the legislation.

A Regulatory Impact Statement on the proposed regulations has been prepared in accordance with the requirements of the *Subordinate Legislation Act 1962*.

The statement concludes that the regulations provide the only way of achieving (a) and (c), that (b) should be achieved by arriving at an appropriate balance between administrative efficiency and the protection of landowners, and that (d) should be achieved by setting fees at an appropriate level.

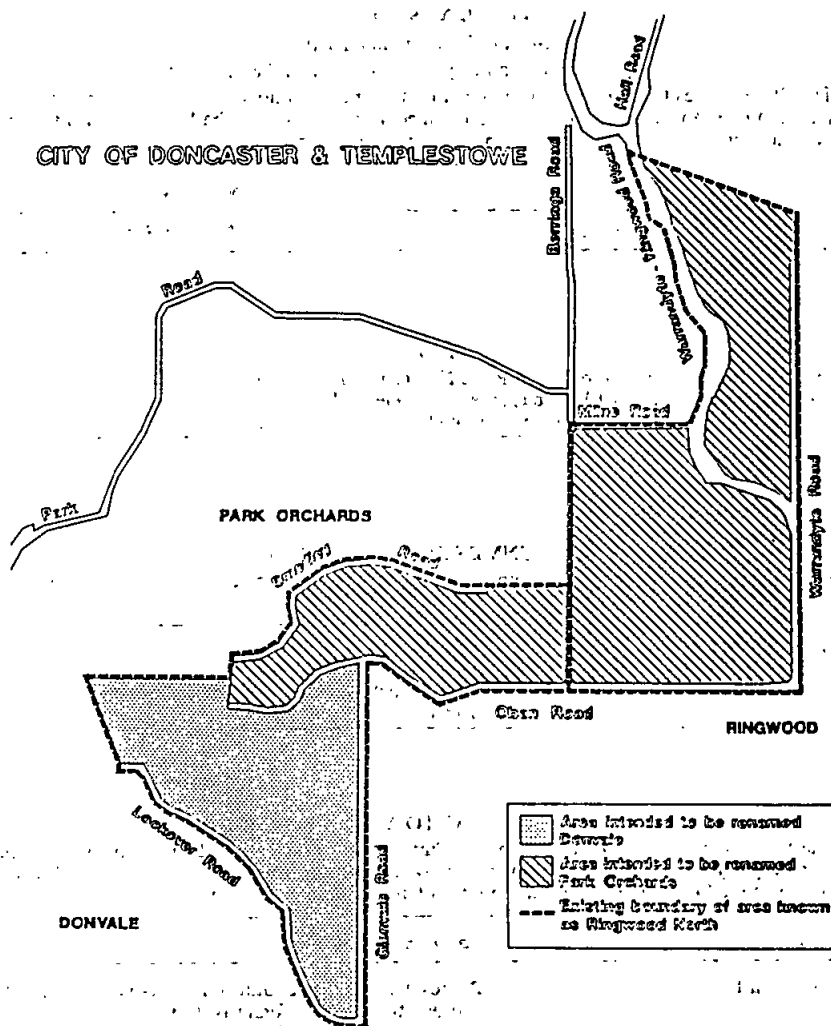

## RACING ACT 1958

The Governor of Victoria, acting with the advice of the Executive Council and pursuant to the powers conferred by section 116HA of the *Racing Act 1958* does by this Order:

(a) acknowledge an Agreement between the Totalizator Agency Board of Victoria and the Australian Capital Territory Gaming and Liquor Authority made on 31 August 1987.

(b) determines that the provisions of the *Racing Act 1958* be subject to such alterations and modifications as are detailed in the schedule, which are necessary and expedient to give effect to the Agreement.

## Schedule

1. Section 104 of the Act is Modified to the Extent that:

Fractions of dividends which the club conducting the totalizator is informed by the Board are derived from bets through the Board under the Agreement is not to be paid into the Dividends Adjustment Fund provided for in section 105 but is to be paid by the club to the Board within 14 days of the race meeting and be remitted by the Board to the Authority.

2. Section 116C of the Act is Modified to the Extent that:

(1) Commission deducted under section 102 (1) of the Act which the club conducting the totalizator is informed by the Board is derived from bets made through the Board under the Agreement is to be paid by the club to the Board within 14 days of the race meeting and the commission so received is to be distributed as follows:

- (a) an amount equal to .25% of the total of bets made through the Board under the Agreement is to be paid to the Treasurer of Victoria to be carried to and form part of the Consolidated Fund.
- (b) an amount equal to .25% of the total of bets made through the Board under the Agreement is to be retained by the Board and applied towards meeting the costs and expenses incurred by the Board in carrying out its functions under the Agreement.
- (c) the balance of the commission is to be paid to the Authority.

(2) Unclaimed dividends and refunds accruing in respect of investments made through the Board under the Agreement is to be paid by the Board to the Authority.

3. Section 116BK is Modified to the Extent That:

(1) Fractions of dividends accruing from investments received by the Board under the Agreement are not to be paid into the Dividends

Adjustment Fund provided for in section 116BL but are to be paid by the Board to the Authority.

(2) Unclaimed dividends and refunds accruing in respect of investments made through the Board under the Agreement are to be paid by the Board to the Authority.

3. Section 116BM is Modified to the Extent That:

Commission deducted in respect of bets received by the Board under the terms of the Agreement is to be distributed as follows:

- (a) an amount equal to .25% of the total of bets made through the Board under the Agreement is to be paid to the Treasurer of Victoria to be carried to and form part of the Consolidated Fund.
- (b) an amount to .25% of the total bets made through the Board under the Agreement is to be retained by the Board to be applied towards the costs and expenses incurred by the Board in carrying out its functions under the Agreement.
- (c) the balance of the commission is to be paid to the Authority.

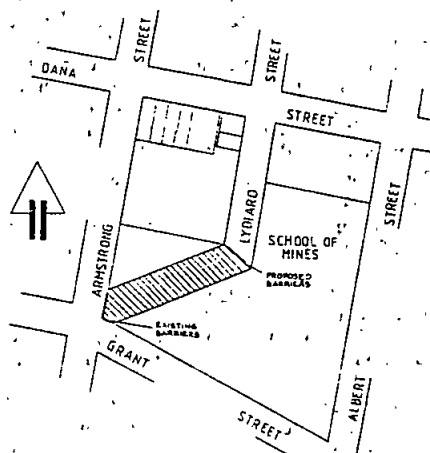
