POLICE RECRUITS

Determination No. 6 of the Police Service Board

The Police Service Board in pursuance of the powers in that behalf conferred on it under section 69 (2) (c) of the *Police Regulation Act 1958*, hereby makes the following Determination with respect to Police Recruits (that is to say):

1. The Determination No. 1 of the Police Service Board of 7 April 1986, and published in the *Government Gazette* of 23 April 1986, is hereby further amended as follows:

1.1 By deleting paragraph 14 and substituting therefor the following new paragraph:

"Dependants

14. A recruit who maintains his substantially dependent spouse and/or substantially dependent children and is required to live at the Police Academy shall be entitled to reimbursement of the actual cost of his meals and accommodation up to \$135.90 per week."

2. This determination shall come into operation on and from 13 September 1987.

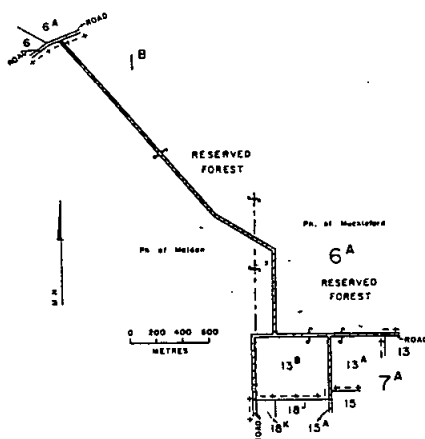

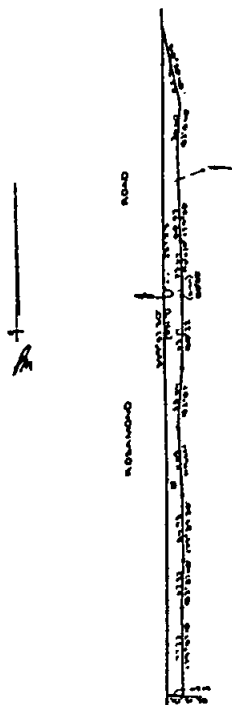

- (vi) holding a licence from the Banking Commission of Switzerland; or
- (vii) holding a licence issued by the Governor in Council pursuant to the Banking Ordinance 1964 contained in Chapter 155 of the Laws of Hong Kong; or
- (viii) federally chartered by the Comptroller of Currency under the *National Banking Act* 1863 of the United States of America and a member of the Federal Reserve System; or
- (ix) holding a banking licence (full banking licence) issued by the Monetary Authority of Singapore under the Banking Act of Singapore,
- (iii) is incorporated and carries on business in Australia,
- (b) a corporation which is incorporated in and carries on business in Australia and has a Commercial Paper Rating of not less than A.1 taken from Australian Ratings Pty. Ltd.,
- (c) a corporation which is incorporated in and carries on business in Australia and has a Medium Term Corporate Rating of not less than AA taken from Australian Ratings Pty. Ltd.,
- (d) a corporation which does not otherwise comply with paragraphs (a), (b) and (c) but the liabilities of which are unconditionally guaranteed by a corporation which does conform which the criteria set out in those paragraphs, and is itself an eligible corporation.

which is carrying on a bona fide banking business and having at that time a short term US rating of not less than P-1 if taken from Moody's Investor Service or A-1 if taken from Standard and Poor's Corporation or long term US rating not less than Aa if taken from Moody's Investor Service or AA if taken from Standard and Poor's Corporation.

3. "buy-back transaction" means a transaction whereby, in pursuance of an agreement between any person and the Manager, the Manager (for and on behalf of the Crown) purchases public securities and/or negotiable instruments at an agreed price, and subsequently sells those public securities or negotiable instruments (including, where the agreement so provides, public securities or negotiable instruments substituted for any of these public securities or negotiable instruments) to that person at the end of an agreed period, at an agreed price and at an agreed rate of interest.

4. "Commonwealth" means Commonwealth of Australia.

5. "Commonwealth securities" means bonds, debentures, stock or other securities issued by the Crown in right of the Commonwealth of Australia.

6. "corporation" means a body corporate.

7. "eligible corporation" means:

- (a) a corporation which:
 - (i) has shareholders' funds (including paid up share capital and reserves) of more than one hundred million dollars, and
 - (ii) has paid a dividend in each of the five years immediately preceding the current year, and

8. 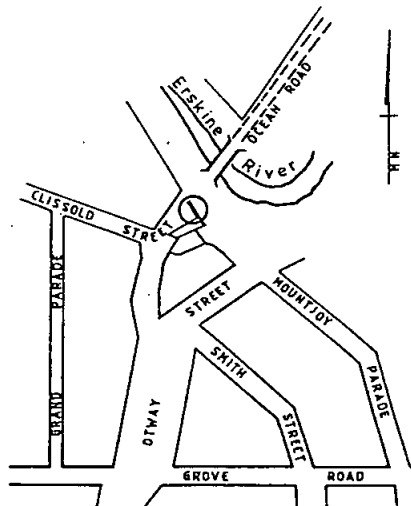
