STATE ELECTRICITY COMMISSION WIRING REGULATIONS 1988

It is proposed that new Regulations be made to revoke the existing Wiring Regulations and to adopt updated technical requirements for the quality and safety of electrical installations and to provide generally for electrical trade and industry needs.
