

BLF (DE-RECOGNITION) ACT 1985

The Governor in Council makes the following Order:

This Order is made pursuant to the powers conferred by section 7 of the *BLF (De-Recognition) Act 1985*.

The Governor in Council orders that:

1. Each of the Orders dated 13 October 1987, the Supplemental Order dated 10 November 1987 and the further Supplemental Order dated 22 December 1987 made pursuant to the powers conferred by section 7 of the *BLF (De-Recognition) Act 1985* is extended in duration until 30 June 1988.

2. Clause 4 of the Order dated 22 December 1987 is amended as follows:

(a) For paragraph (b) substitute—

(b) wherever the word "officer" appears substitute the words "prescribed person";

(ba) wherever the word "person" appears (except where secondly occurring in section 296 (9)), substitute the words "prescribed person";

(b) Omit paragraph (e);

(c) After paragraph (n) insert—

(na) in sub-section 296 (11)—

(i) for the words "Commission may, in its discretion," substitute "investigator may, in his or her discretion"; and

(ii) for the words "as it thinks reasonable" substitute the words "as the investigator thinks reasonable";

(d) In clause 5 for paragraph (a) substitute—

(a) "Prescribed person" means an officer, employee, former officer, or former employee of a trading or financial corporation whether in Victoria or elsewhere.; and

(e) For the expression '6. "prescribed document"' substitute the expression '(b) "prescribed document"'.
