PROPOSED PIPELINE REGULATIONS 1988

It is proposed that Regulations be made to—

update and consolidate Regulations made
under the *Pipelines Act 1967*;

prescribe various forms, fees and procedures,
as required by the Act;

set out requirements relating to the design,
construction, operation and testing of
pipelines; and

set out requirements to ensure safe diving
operations undertaken in association with
pipelines.

A Regulatory Impact Statement has been
prepared and this concludes that the proposed
Regulations will facilitate the establishment of
pipelines and ensure that pipelines are
constructed and operated in a safe manner.

Comments and submissions are invited from
the public and will be received up to 21 days
from the publication of this notice.
