Regulatory Impact Statement

Notice is given of a proposal to make the above regulations.

The reason for the proposed regulations is to revise the River Improvement and Drainage Trusts (Long Service Leave) Regulations 1970 which will be revoked on 30 June 1988.

The objectives of the proposed regulations are:

- 1. to provide for the nature of service and the computation of the period of service which entitles employees of river management boards to be granted long service leave;
- 2. to provide for the recognition of an employees prior service with certain authorities or offices in computing the period of service which entitles an employee to be granted long service leave.
- A Regulatory Impact Statement has been prepared in accordance with the Subordinate Legislation Act 1962.

The results of the statement are as follows:

- 1. There is no feasible alternative to making the regulations.
- 2. No significant financial impact on the public or on river management boards is envisaged as a result of the regulations.
- 3. The benefit to the community of making the proposed regulations outweighs any disadvantages.
