Subordinate Legislation Act 1962 Metropolitan Fire Brigades Act 1958 PROPOSED METROPOLITAN FIRE BRIGADES (CONTRIBUTIONS) REGULATIONS 1988

It is proposed that new Regulations be made:

- (a) To revoke the Metropolitan Fire Brigades (Contributions) Regulations 1970 and their antecedents in anticipation of their "sunset" date of 30 June 1988;
- (b) To identify the various classes of insurance policy which are regarded as having a fire component, and to specify the proportions of the premiums arising from those policies which are attributable to their fire component;
- (c) To establish the mechanisms by which the Metropolitan Fire Brigades Board can determine the amount to be contributed by each eligible insurance company under section 40 of the Act;
- (d) To provide a basis for the calculation of the contributions to the Board under section 44x of the Act. These are made by the owners of property within the M.F.D. who either self-insure or insure outside Victoria, and by insurance brokers, where insurance outside Victoria is arranged through them.

A Regulatory Impact Statement has been prepared as required by the Subordinate Legislation Act 1962. As a result of preparing that statement it is concluded that the potential benefits to the community of adopting the proposed Regulations outweigh any disadvantages.

DANDENONG VALLEY AUTHORITY (PATTERSON RIVER RECREATIONAL AREA) REGULATIONS 1988

It is proposed that the Dandenong Valley Authority (Patterson River Recreational Area) Regulations 1988 be made to revoke the existing Dandenong Valley Authority (Patterson River Recreational Area) Regulations 1968 to replace these regulations with updated regulatory provisions.

These regulations provide for the control management use and care of the recreational area at Patterson River so that the area is managed for the benefit of the community in a manner: compatible with flood mitigation, the need for the protection of water quality, health standards and the environment.

A Regulatory Impact Statement has been prepared and this concludes that the preferred method of achieving the objective is to make regulations.
