NOTICE OF REGULATORY IMPACT
STATEMENT

Stock Diseases Regulations 1988

It is proposed to make new Regulations with the objectives of:

- (i) protecting the producers of animals from the spread of infectious diseases; and
- (ii) protecting the supply of wholesome livestock products to the domestic and export markets; and
- (iii) preventing the spread of livestock diseases which are transmitted from animals to man; and
- (iv) recovering the costs of administering the licensing of chicken hatcheries.

A Regulatory Impact Statement has been prepared in accordance with the *Subordinate Legislation Act 1962* and concludes that an infrastructure for the provision of livestock disease diagnosis, control and eradication contributes to Victoria's competitive advantage in the world market for livestock and livestock products.

MURRAY-DARLING BASIN (RIVER
TRAFFIC) REGULATIONS 1988

It is proposed that the Murray-Darling Basin (River Traffic) Regulations 1988 be made to revoke the existing River Murray Waters Regulations 1965 to replace these regulations with updated regulatory provisions.

These Regulations control the activity of people and vessels in and around the locks to ensure the safety of all users of the locks.

A Regulatory Impact Statement has been prepared and this concludes that the preferred method of achieving the objective is to make regulations.
