PROPOSED LIQUOR CONTROL
(LICENCES AND PERMIT FEES)
REGULATIONS 1988

It is proposed that Regulations be made to prescribe fees for making applications and fees for certain licences and permits under the *Liquor Control Act 1987*.

A Regulatory Impact Statement has been prepared as required by the *Subordinate Legislation Act 1962*.

The Statement concludes that the proposed Regulations should have a substantially neutral financial impact on the liquor industry and recommends that they be made.

PROPOSED FISHERIES (ABALONE)
REGULATIONS 1988

Regulatory Impact Statement

Notice is hereby given that a Regulatory Impact Statement (RIS) has been prepared in relation to the proposed *Fisheries (Abalone) Regulations 1988*.

The purpose of the Regulations is to provide the regulatory framework necessary to implement the *Fisheries (Abalone) Act 1987*. The objectives are to control the level of exploitation by commercial and amateur harvesters of the resource, and to reduce illegal taking of abalone for sale.

The RIS concludes that the proposed Regulations are necessary to achieve these objectives, and that the benefits to the fishing industry outweigh the costs.
