ABATTOIR AND MEAT INSPECTION ACT
1973

The Governor in Council, acting under section 17A of the *Abattoir and Meat Inspection Act 1973*, declares that kangaroo flesh may, subject to the following qualifications, be sold for human consumption:

1. Such sales may, for the purpose of an international conference dinner sponsored by the Anti-Cancer Council, Victoria, at the Kiss At Ten Restaurant in Pelham Street, Carlton on Tuesday, 15 November, be made to Dr Graham Giles of the Anti-Cancer Council, Rathdowne Street, Carlton.

2. The maximum quantity of kangaroo flesh that may be sold to Dr Graham Giles for the purpose of the conference dinner shall be 25 kilograms.
